As further discussed in Note 1 to the financial statements, the Plan's governing body decided to terminate the Plan on June 20, 2024. As a result, the Plan changed its basis of accounting from the ongoing basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Reasonable assurance is a high level of assurance, but it is not absolute assurance; therefore, it is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Supplemental Information Required by ERISA

The supplemental information listed in the index as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplemental information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental information that is agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Predecessor auditors performed an audit of the Plan's 2023 (ongoing) financial statements. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report dated October 11, 2024, indicated that (a) the amounts and disclosures in the 2023 (ongoing) financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 (ongoing) financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that is agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 – Plan Description

The following description of the Dril-Quip, Inc. Employee 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description and the Plan Document for a more complete description of the Plan’s provisions.

Plan Termination

On June 20, 2024, the Plan’s governing body decided to terminate the Plan effective August 5, 2024 (the “Termination Date”), and to distribute Plan assets as soon as administratively feasible. Effective September 5, 2024, the Plan ceased all contributions and new participant loans. The nonvested portion of all participant accounts were fully vested upon the Termination Date. All participants received an account closing distribution of their account balances based on their distribution election. Distributions were requested in lump sum cash distributions or as a direct rollover to an Individual Retirement Account (“IRA”) or other qualified retirement plan. As of December 31, 2024, the distribution of Plan assets was not complete, and the trust was not fully liquidated and terminated.

General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of the Dril-Quip, Inc. and participating employer TIW Corporation and Honing, Inc. (collectively, the “Employer” or “Company”). The Plan commenced effective August 22, 1988, and was amended and restated effective June 1, 2022. The Plan was subsequently amended and restated effective March 1, 2023, to comply with the latest rules and regulations. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodian and Trustee

Effective August 1, 2022, Empower Companies changed the legal name of Great-West Companies to Empower. Empower Trust Company, LLC (“Empower,” the “Trustee,” or “Custodian”) is the Plan Trustee and Custodian. Empower maintains custody of all investments held by the Plan. Empower Retirement, LLC (the “Recordkeeper”) maintains the Plan’s participant account balances and provides recordkeeping services to the Plan. Among other duties, the Recordkeeper receives contributions, holds and invests the fund assets in accordance with the direction of participants, and makes distributions as directed by the Plan Administrator.

Eligibility and Plan Entrance Date

All employees, except residents from Puerto Rico and part-time, temporary, or seasonal employees, are eligible to participate in the Plan upon reaching the age of 18 and completing three months of service. Part-time, temporary and seasonal employees are allowed to participate in the Plan after having completed 1,000 hours of service. Eligible employees are permitted to enter the Plan on the day that all eligibility requirements are met.

Contributions

Prior to the Termination Date, participants were permitted to contribute, on a before-tax or Roth basis, up to 100% of their eligible compensation, up to the maximum amount permitted for deferral annually under the IRC, which was \$23,000 for 2024. Participants who reach the age of 50 on or before the end of a Plan year are allowed to make additional before-tax catch-up contributions of up to the maximum amount permitted annually under the IRC, which was \$7,500 for 2024.

Note 1 – Plan Description (continued)

Contributions (continued)

Participants may contribute amounts representing distributions from other qualified benefit or defined contribution plans (“rollovers”).

The Company may make discretionary matching contributions, as determined by the Employer. Effective April 1, 2022, the Company contributes 100% of the first four percent of eligible compensation that a participant contributes to the Plan. Contributions are subject to certain limitations.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation. The Plan also includes an auto-escalation feature whereby a participant’s deferral rate automatically increases by 1% annually until the participant reaches a deferral rate of 10%, and their contributions are invested in a designated balanced fund until changed by the participant.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions, allocations of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions and rollover contributions, plus actual earnings thereon. Prior to the Termination Date, vesting in the Company’s contribution portion of their accounts was based on years of continuous service, as defined below:

Participant-Directed Investments

All assets of the Plan are participant-directed investments. Participants have the option of directing their account balances to one or more investment options offered by the Plan. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. The funds vary in types of investment, rates of return, and investment risk.

Notes Receivable from Participants

Prior to the Termination Date, participants were permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined quarterly, was set at 1% above Prime, as defined. Principal and interest were paid ratably through payroll deductions and were due in equal installments not less frequently than monthly.

Payment of Benefits

Upon separation of service due to death, disability, retirement, or termination of employment, a participant may elect to receive either a lump sum payment equal to the value of the participant's vested balance or a partial withdrawal. Distributions to a terminated employee with an account balance not exceeding \$5,000 are made as a lump sum distribution as soon as administratively possible following the participant's termination of employment. The participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan.

If a terminated employee has an account balance exceeding \$5,000, the participant may elect to maintain their balances within the Plan. If the vested account balance is \$5,000 or less, the Plan permits involuntary lump sum cash distributions. A participant may withdraw all or a portion of their vested account balance in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$88,875 and \$57,460, respectively. These accounts will be used to reduce future Company contributions and to pay Plan expenses. Also, in 2024, Employer contributions were reduced by \$28,608 from forfeited nonvested accounts.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

On June 20, 2024, the Plan's governing body decided to terminate the Plan. As a result, the 2023 financial statements have been prepared on the ongoing basis of accounting, and the 2024 financial statements have been prepared on the liquidation basis of accounting in conformity with the accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as those held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

Payment of Benefits

Benefits payments are recorded when paid.

Administrative Expenses

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Certain expenses specifically incurred by, or attributable to, a participant will be paid from that participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Note 3 – Fair Value Measurements (continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within level 1 of the fair value hierarchy.
- **Stable Value Collective Trust Funds** – The stable value funds are composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) occur daily, and there are no significant restrictions on participant redemptions or any unfunded commitments.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

The Plan’s independent auditor did not perform auditing procedures with respect to this information except for comparing such information with the related information included in the financial statements and supplemental schedule.

Note 5 – Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and units of the collective trust funds managed by the Custodian. These transactions qualify as party-in-interest transactions as defined by ERISA but are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

The Plan had notes receivable from participants at December 31, 2023. These receivables and all transactions relating to these receivables qualify as party-in-interest transactions that are exempt from the prohibition of party-in-interest transactions under ERISA.

Note 6 – Tax Status

The Plan operates under a non-standardized, preapproved profit-sharing plan sponsored by Empower Retirement, LLC. The Internal Revenue Service (“IRS”) has determined and informed the Recordkeeper, by letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS regarding the Plan’s qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
