**1. Description of Plan**

The following brief description of the Triangle Credit Union Cash Balance Defined Benefit Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a cash balance pension plan covering substantially all employees of Triangle Credit Union (Credit Union) who meet certain eligibility requirements. It is subject to the *Employee Retirement Income Security Act of 1974* (ERISA). The original effective date of the Plan is April 1, 1982.

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE 2.0 Act) was signed into law. It includes mandatory and optional provisions impacting retirement plans. Applicable provisions outlined in the SECURE 2.0 Act will be adopted if elected and/or required. Plan amendments for these changes are not yet required.

Eligibility

Employees are eligible for participation under the Plan on the first day of the Plan year coinciding with or next following attainment of age 20 and completing six months of service.

Normal Retirement Date

A participant's normal retirement date is age 65.

Retirement Benefit Formula

If an employee's original employment began prior to January 1, 2013, and they were not rehired on or after January 1, 2017, they are considered a "Grandfathered Participant" and the normal retirement benefit will be determined based on a retirement benefit formula equal to 30% of the employee's average monthly compensation (determined using a sixty-month highest consecutive average), computed to the nearest 5 dollars. When the Plan year is a short year, the number of the hours of service required will be proportionately reduced based on the number of full months in the short Plan year.

In addition to the calculations set forth above, the accrued benefit will be subject to the following rules and limitations:

- (a) If still employed after reaching normal retirement age, participants will continue to accrue benefits based upon service and average monthly compensation determined at the close of any Plan year coinciding with or following normal retirement age.
- (b) The accrued benefit will be adjusted by an accrual fraction which is calculated as the actual years of service completed divided by the years of service an employee would have if remaining employed to normal retirement age.
- (c) If the years of service as of the end of the Plan year in which normal retirement age is attained are less than fifteen (15), the percentage of average monthly compensation will be reduced by one fifteenth (1/15th) for each year of service less than fifteen (15).

If not a “Grandfathered Participant,” the normal retirement benefit will be equal to the actuarial equivalent of the hypothetical account.

The “Hypothetical Account” is the sum of the following amounts under (a) and (b) below as of the date of determination:

- (a) Hypothetical Allocation. For each Plan year in which employees are a participant, their hypothetical account will be credited for that Plan year with a hypothetical allocation equal to 3% of Plan year compensation. The monthly accrued benefit shall not be less than \$10 for any cash balance participant who works at least 1,000 hours.

Eligible participants must complete at least one (1) year of service during the Plan year to be eligible to receive the hypothetical allocation described above. For purposes of determining eligibility to receive a hypothetical allocation, a year of service means a Plan year during which 1,000 hours of service are completed.

- (b) Interest Credit. For each month until the accrued benefit is paid, the participant’s hypothetical account will be credited with interest determined by multiplying the balance of their account at the beginning of the Plan year, plus any credited hypothetical allocation for the Plan year, by 1/12th of the applicable interest rate. The applicable annual interest rate will be the average 30-year Treasury rate, as reported by the Internal Revenue Service, for the second calendar month preceding the first day of the Plan year. No interest will be credited for any period after payment of a participant’s accrued benefit commences. Interest will be credited as of the last day of each month.

*Early Retirement Benefit*

Any participant who has reached age 55 and has at least 10 years of credited service is eligible to elect early retirement. The participant’s accrued benefit will be reduced by the greater of 1) 5/9<sup>ths</sup> of 1% for each of the first 60 months and 5/18<sup>ths</sup> of 1% for each month thereafter or 2) the actuarial equivalent of the accrued benefit if that benefit is distributed in a form other than nondecreasing life annuity payable over the participant’s lifetime.

*Pre-Retirement Death Benefit*

If a participant dies prior to commencing to receive retirement benefits, their spouse will receive a death benefit equal to the actuarial equivalent of the minimum spouse’s death benefit. If unmarried, death benefits will be provided to a designated beneficiary. The minimum spouse’s death benefit is equal to the amount that would have been paid to the spouse if the participant had begun receiving distributions under a joint and 50% survivor annuity.

*Lump Sum*

Available to any participant with a vested accrued benefit.

For cash balance participants, the vested percent is zero for less than three years of service and 100% vested after three years of service.

*Funding Policy*

The sponsor of the Plan, the Credit Union, makes contributions to the Plan from time to time in amounts based on actuarial valuations, to be at least sufficient to meet the minimum funding standards of ERISA. The Plan has met the ERISA minimum funding standards for 2024 and 2023.

*Termination of the Plan*

Although it has not expressed any intent to do so, the Credit Union has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations. Whether a particular participant's accumulated Plan benefits will be paid depends on both the priority of those benefits and the level of benefits guaranteed by the Pension Benefits Guaranty Corporation (PBGC) at that time. Some benefits may be fully or partially provided for by the then existing assets and the PBGC guaranty, while other benefits may not be provided for at all. Participants should refer to the Plan document for more complete information.

**2. Summary of Significant Accounting Policies**

*Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the period, and the actuarial present value of accumulated Plan benefits at the date of the financial statements. Actual results could differ from those estimates.

*Risk and Uncertainties*

The Plan provides for various investment options, including pooled separate accounts and a guaranteed investment contract with a life insurance company. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Valuation of Investments and Income Recognition*

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value because contract value is the amount the participants would receive if they were to initiate permitted transactions with the Plan. The Plan's investments in the pooled separate accounts are stated at fair value, which has been determined based on the net asset value of the underlying funds as a practical expedient. The pooled separate accounts have no unfunded commitments, can be redeemed daily and require no redemption notice. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

*Contributions*

Contributions are accrued based upon amounts required to be adequately funded under the provisions of the ERISA or, if greater, amounts actually contributed for the year which are subject to certain limitations. Contributions are recorded in the period for which the contribution is declared.

*Payment of Benefits*

Benefits are recorded when paid.

*Administrative Expenses*

Administrative expenses are paid by the Plan participants to the extent they are not paid by the Plan sponsor. Fees for recordkeeping services and investment management are paid by the Plan participants indirectly through the Plan's investment returns.

*Subsequent Events*

Events occurring after the statement of net assets available for benefits date are evaluated by the Plan Administrator to determine whether such events should be recognized or disclosed in the financial statements. The Plan Administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

**3. Actuarial Present Value of Accumulated Plan Benefits**

Accumulated Plan benefits are those periodic payments, including lump-sum distributions, which are attributable under the Plan's provisions to the service employees have rendered. Accumulated Plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. The actuarial present value of accumulated Plan benefits is determined by an actuary from TruStage, formerly known as CUNA Mutual Group, and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

**4. Fair Value Measurements**

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of the unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs to the valuation methodology are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available. The Plan does not hold any investments subject to the leveling tables.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* The Plan's interests in the accounts are valued based on net asset values reported by the trustee of the funds based upon the quoted fair values of the underlying investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Contracts With Insurance Company**

The Plan has a fully benefit-responsive group annuity contract issued by CMFG Life Insurance Company (CMFG). Interest under this contract will accrue on a daily basis. An initial guaranteed interest rate was credited from the contract effective date until the initial guaranteed interest rate expiration date. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There is no guaranteed level of future interest rates after the initial guaranteed interest rate expiration date, and interest is credited at the then-current effective annual interest rate declared by CMFG. The contract is included in the financial statements at contract value as the contract is supported by the general account of CMFG. Contract value, as reported to the Plan by CMFG, represents contributions made under the contract, plus earnings, less participant withdrawals or transfers and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan Administrator does not believe that a contract termination is probable of occurring. The contract is subject to a market value adjustment if the Plan terminates the contract and elects a lump sum distribution, if the Plan requests to transfer contract value on or after the date the termination request is issued by CMFG, or if a partial termination, as defined in the contract, has occurred, which may result in a payout of less than 100% of principal and interest credited. **6. Income Tax Status**

The Credit Union has restated the Plan as of January 1, 2020 to a volume submitter defined benefit plan sponsored by CMFG, which received an opinion letter dated February 28, 2023. In this letter, the Internal Revenue Service (IRS) informed the Credit Union that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has since been amended; however, Plan management believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has evaluated the Plan's tax positions and concluded there are no uncertain tax positions that require adjustment to the financial statements.

**7. Information Certified by the Custodian**

The Plan's investments, related investment income (loss) and investment transactions, including net appreciation, were certified as complete and accurate by Matrix Trust Company, the custodian, as of December 31, 2024 and 2023 and for the years then ended. Plan management has determined that Matrix Trust Company meets the requirements of a qualified institution as defined by the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, in accordance with the request of the Plan Administrator, and as allowed under 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure, this information was not subjected to auditing procedures by the Plan's independent auditors, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedules.

**8. Party-in-Interest Transactions**

TruStage provides administrative services to the Plan and is an affiliate of CMFG. Therefore, investments, and the related transactions, in the CMFG pooled separate accounts, the Group Annuity Contract and administrative fees, if any, paid to TruStage are considered to be party-in-interest transactions. Certain direct administrative expenses charged to the Plan and paid to the custodian during 2024 and 2023 totaled \$33,751 and \$34,442, respectively.
