Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Maxco Supply, Inc. 401(k) Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Maxco Supply, Inc. 401(k) Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Maxco Supply, Inc. 401(k) Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of Maxco Supply, Inc. 401(k) Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution plan covering all employees of Maxco Supply, Inc. (the “Company”) who are 21 years of age or older and have reached one year of service. The Plan was established on January 1, 1997 and most recently restated for the Cycle 3 Restatement on February 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions:

Eligible employees of the Company may elect to contribute up to the applicable limits allowed under the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. The Company makes safe harbor matching contributions equal to 100% of the employee’s salary deferrals that do not exceed 3% of their compensation, plus 50% of the employee’s salary deferral between 3% and 5% of the employee’s compensation. In addition, the Company may elect discretionary employer contributions. Participants direct the investment of the contributions into various options offered by the Plan.

Vesting:

Participants are immediately vested in their employee deferral contributions, rollover contributions, and the Company’s safe harbor contributions plus actual earnings thereon. The Company’s discretionary contributions are vested at 20% each year after two years of service. A participant is 100% vested after 6 years of credited service or upon death or disability.

Participant Accounts:

The custodian of the Plan maintains an account for each participant. Each participant account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings, and charged with administrative expenses, not paid by the Company. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participant Loans:

The Plan does not permit participant loans.

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description (Cont.)

Payment of Benefits:

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or various options as defined in the Plan. Similar options are available upon termination of employment. The Plan provides a mandatory cash-out on a terminated participant's account with a non-forfeitable balance of less than \$5,000 unless the terminated participant provides rollover instructions. The Plan permits a hardship distribution to a participant prior to and after separation from service in accordance with the Plan's hardship policies.

Forfeited Accounts:

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$5,451 and \$4,445, respectively. Amounts accumulated in the forfeiture account will be used to reduce future employer contributions and administrative fees of the Plan. Forfeitures of \$0 were used to reduce employer contributions or administrative fees during the years ended December 31, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in fair value of investments presented on the statement of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2. Summary of Significant Accounting Policies (Cont.)

Benefits:

Benefits are recorded when paid.

Administrative Expenses:

All Plan investment and trust management fees paid are charged against the Plan's assets, unless otherwise paid by the Company. These fees are allocated to the participants' accounts in the same manner as the allocation of income and loss. Expenses related to specific participant transactions are charged to the respective participant's account. Investment related expenses are included in net appreciation in fair value of investments. The annual audit and tax return preparation fees are paid by the Company.

Use of Estimates:

The preparation of financial statements is in conformity with accounting principles generally accepted in the United States of America. Those standards require management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Date of Management's Review of Subsequent Events:

The Plan has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued. There were no material modifications to the Plan or the plan provisions.

Note 3. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 measurements consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and Level 3 measurements are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or 2 inputs were not available. There are no plan assets requiring the use of Level 1 or 3 inputs for the periods presented.

Level 2 Fair Value Measurements:

The fair values of the pooled separate accounts are based on the number of units in the subaccount held on a particular day by the Plan and multiplied by the unit value on that date. The unit value is based on quoted prices of the underlying investments.

Note 5. Fixed Annuity Contract with Insurance Company

The Plan holds a fully benefit-responsive group annuity investment contract issued by Massachusetts Mutual Life Insurance Company (“MassMutual”). Effective on December 31, 2020, Empower Retirement acquired the retirement business of MassMutual. Through this transaction, business written by MassMutual, including the Guaranteed Interest Account, is reinsured by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on Empower Annuity Insurance Company of America’s ability to meet its financial obligations. Empower Annuity Insurance Company of America’s ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The methodology for calculating the interest crediting rate on the guaranteed interest account is determined by the anticipated investment of the applicable segment of the general investment account for that year; the target spread which is comprised of the annual administrative services revenue, and a risk charge for the interest rate guarantee, investment expenses, and other distribution and administrative costs; and in no event will the guaranteed rate be less than the minimum guaranteed rate, which will be no less than 1% or more than 3%, as determined annually by a formula in the contract. Contributions into the guaranteed interest account are credited with interest at a rate not less than the declared interest rate for the calendar quarter in which they are received, and the interest rate is reset upon various renewal periods of each quarter or annual group as defined in the contract. The crediting interest rates were 1.50% and 2.80% for the plan years ending December 31, 2024 and 2023, respectively.

The Plan may transact according to the terms defined in the contract at any time, however, certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the premature termination of the contracts by the Plan, plan termination, bankruptcy, mergers, and early retirement incentives. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan’s ability to transact at contract value with participants, is probable. The contract may be terminated by the issuer with at least ninety days of advance written notice to the other party.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions set forth in ERISA and the Internal Revenue Code. Upon termination of the Plan, the total net assets of the Plan are to be distributed to the participants in proportion to their account balances.

Note 7. Related Party and Party-in-Interest Transactions

During the plan years December 31, 2024 and 2023, the custodian of the Plan provided participant-level services as defined by the Plan and, therefore, these transactions qualify as party-in-interest. These transactions are covered by an exemption from the “prohibited transaction” provisions of ERISA and the Internal Revenue Code.

Note 8. Income Tax Status and Plan Amendments

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service has determined and informed the sponsor of the non-standardized pre-approved plan that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code. Plan management and the Plan’s tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan’s tax returns remain open for three to four years for income tax examination.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
