## Joyce Motors Corp. 401(k) Plan

### Notes to Financial Statements

#### NOTE 1 - DESCRIPTION OF PLAN

The Joyce Motors Corp. 401(k) Plan (the "Plan") commenced on October 1, 1980. The following description of the plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering all full-time employees of Joyce Motors Corp. (the "Company") who have one year of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to the dollar limitation contained in Section 402(g) of the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an insurance contract as investment options for participants. The Company makes discretionary contributions, which are generally based upon the amount that a participant contributes to the Plan. The Company has elected to make matching contributions equal to 100% of the first 2% of compensation that a participant contributes to the Plan. These contributions are generally made weekly, consistent with the Company's payroll periods and together with the participants' contributions.

##### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and, (b) Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant will be 100% vested after 6 years of credited service.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 4.25-10.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through regular payroll deductions. Loans can not exceed a five-year period.

NOTE 1 - DESCRIPTION OF PLAN *(Continued)*

Payment of Benefits

On termination of service due to death, disability or retirement, a participant receives the vested interest in his or her account as a lump sum or may elect a partial withdrawal and leave the balance in the Plan. If a terminated participant's vested account balance is below \$1,000, a distribution of the entire balance will be paid in a single sum distribution. In-service distributions may be made if a participant has attained the age of 59 ½. The Plan agreement stipulates that distributions must commence no later than April 1 of the year following the year in which the participant reaches the age of 73.

In certain hardship situations, as directed in the Plan agreement, participants may withdraw part of their account balance while actively employed, but such withdrawals are limited to the amount dictated by the hardship. Participant's withdrawals are limited to participant's total deferred compensation as of the date of distribution reduced by the amount of any previous distribution.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$4,893. These amounts will be used to reduce future employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES *(Continued)*

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

All expenses of maintaining the Plan are paid by the Company.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, the respective participant interest, net of termination fees, will be distributed to each participant in accordance with the Plan agreement.

Date of Management's Review

The Plan has evaluated events and transactions that occurred through October 9, 2025, which is the date financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

NOTE 3 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the plan at year-end.

Level 2 Fair Value Measurements

The fair value of the units held in pooled separate accounts are based on the quoted market prices of the underlying investments and are based on the net asset value of the shares held by the Plan at year end.

NOTE 4 - RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by affiliates of Principal Trust Company. Principal Trust Company is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for certain administrative services amounted to \$42,411 for the year ended December 31, 2024.

NOTE 5 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 6 - TAX STATUS

The Plan is a "prototype" plan whereby the Plan document was developed by the Trustee for use with various other companies' 401(k) plans. The Trustee has represented to the Company that it has received a favorable determination from the Internal Revenue Service that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

The Company has identified a number of administrative errors and has corrected them under the Employee Plans Compliance Resolution System Self-Correction Program (SCP). The Company believes it has satisfied the requirements for SCP in order to maintain the Plan's qualified status.

NOTE 7 - INSURANCE CONTRACTS

In 2018, the Plan entered into a benefit-responsive investment contract with Principal Life Insurance Company ("Principal"). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Principal. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield and crediting interest rates were both approximately 1.55% and 1.73% for 2024 and 2023, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1.00% for 2024 and 1.00% for the life of the contract. Interest rates are reviewed on a semiannual basis for resetting.
