Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Southwestern Family of Companies 401(k) and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits - modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements – modified cash basis.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the presentation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Notes to Financial Statements

For the Years Ended December 31, 2024 and 2023

Note 1. **Description of Plan**

The following description of the Southwestern Family of Companies 401(k) and Profit Sharing Plan (formerly the Southwestern/Great American, Inc. Profit Sharing and Employee Savings Plan) (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description.

General

The Plan is a defined contribution profit-sharing retirement plan. Under the terms of the Plan, amounts contributed by Southwestern Family of Companies (the Company) and earnings (losses) thereon are available for Plan participant retirement benefits. The Plan is administered by a Retirement Committee of no less than three persons appointed by the Board of Directors of the Company. Delaware Charter Guarantee and Trust Company dba Principal Trust Company (Principal) currently serves as the Plan Trustee, custodian and recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Upon hire, employees may contribute up to 75% of eligible compensation, as defined in the Plan document, on an annual basis up to the amount permitted under Internal Revenue Codes (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 5% of eligible compensation. The automatic deferral will increase each July 1 by 1% up to a maximum automatic deferral contribution of 20%.

Employees with one year of service or 1,000 hours of service, may participate in the Company's contribution. The Company's contribution is at the discretion of its Board of Directors. The Company's contribution was \$387,751 for the Plan year ended December 31, 2023, which was remitted in 2024. The Company's contribution for Plan year ended December 31, 2024 was \$454,579, which was remitted in 2025. Annual allocation of the contribution and forfeitures of participants' nonvested amounts are accomplished through allocation of points to each participant based on the ratio of individual participant points to total participant points. These points are awarded based on years of service and compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, and allocations of the Company's discretionary contribution and Plan investment results and charged with an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and rollovers plus actual earnings or losses thereon. Vesting in the Company contributions is based on years of continuous service. Participants vest 20% per year after two years of service, with 100% vesting occurring after six years.

Note 1. **Description of Plan**

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 8.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions. Participants may have 3 outstanding loans in any year.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and Company contributions in any of the investment options offered by the Plan.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reasons, a participant or his or her beneficiaries may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants can receive all or a portion of their vested account upon reaching age 59 ½. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

Forfeitures

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$128,107 and \$56,013, respectively. Per the Plan Document, these amounts may be used to pay administrative expenses or are allocated to participant accounts on the same basis as the Company's profit sharing contribution. During the year ended December 31, 2024, forfeitures of \$1,422 were allocated to participant accounts.

Note 2. **Summary of Significant Accounting Policies**

Basis of Presentation

The accompanying financial statements have been prepared on the modified cash basis of accounting which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (US GAAP). This basis of presentation differs from US GAAP in that participant and Company contributions are recognized when received rather than when due.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Note 2. **Summary of Significant Accounting Policies**

Investment Valuation and Income Recognition

Investments in the Plan are reported at fair value, except for the fully benefit-responsive investment, which is reported at contract value, which approximates fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to the fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change of fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Benefits Paid to Participants

Benefits paid to participants are recorded when paid.

Note 3. **Certification**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements, notes, and supplemental schedule was obtained by the Plan Administrator and agreed to or derived from information certified as complete and accurate by Principal, the trustee of the Plan.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and that the Plan has the ability to access.

Level 2 inputs are based on observable inputs corroborated by market data but not quoted on active markets.

Level 3 inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets or liabilities and have the lowest priority.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Registered Investment Companies Funds (Mutual Funds): Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued at the net asset value (NAV) of units of an insurance company's pooled accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the accounts, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self-Directed Brokerage Accounts: Primarily consist of interest bearing cash equivalents, mutual funds, common stocks, unit investment trusts and a corporate bond. Investments, other than the corporate bond are valued at the closing price reported on the active market on which the individual securities are traded. The corporate bond is valued using pricing models maximizing the use of observable inputs for similar securities and include basing value on yields currently available on comparable securities of issuers with similar credit ratings.

Note 4. Fair Value Measurements

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at December 31, 2024 and 2023.

The pooled separate accounts seek to mirror the investment objectives and strategies of the underlying mutual fund for which the pooled account is named.

Note 5. Investment Contract with Insurance Company

The Plan investments in the Principal Fixed Income Guaranteed Option account with Principal totaling \$8,629,976 and \$9,436,864 at December 31, 2024 and 2023, respectively. Principal maintains contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan. The rate credited is the rate in effect on the day when each deposit is directed into the account. Under the terms of the existing contract, the interest credit rate is reset on a semi-annual basis and will never be less than 1% or greater than 3%.

These accounts meet the fully benefit-responsive contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Note 5. **Investment Contract with Insurance Company**

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Principal. No events are probable of occurring that would limit the Plan's ability to transact at contract value with Principal or Plan participants.

Note 6. **Related Party and Party-in-interest Transactions**

Certain plan investments are managed by Principal. Principal is also the trustee and recordkeeper of the Plan and was paid administrative expenses. These transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management and administration services are included in net change in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. All of these party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

Notes receivable from participants qualify as party-in-interest transactions.

Note 7. **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. In the event of Plan termination, participants will become 100% vested in their account balances.

Note 8. **Tax Status**

The Plan adopted a non-standardized form of a prototype plan sponsored by Principal. Principal received its last opinion letter on June 30, 2020, from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC. The Plan has not applied for a separate determination letter.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, no uncertain positions have been taken or are expected to be taken that would require recognition of a liability (or an asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to income tax examinations for years prior to 2021.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10. Subsequent Events

Management has evaluated subsequent events through October 6, 2025, the date on which the financial statements were available for issuance.

The Plan was amended effective January 1, 2025 to change the name of the Plan from the Southwestern/Great American, Inc. Profit Sharing and Employee Savings Plan to the Southwestern Family of Companies 401(k) and Profit Sharing Plan. The Plan was also amended to allow all employees to participate in the Plan including part-time employees and to exclude fringe benefits from compensation.
