## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Arizona Iced Tea 401(K) Plan  
Profit Sharing Plan and Trust

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Arizona Iced Tea 401(K) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Arizona Iced Tea 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Arizona Iced Tea 401(K) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Arizona Iced Tea 401(K) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

**NOTE 1 - Description of Plan**

The Arizona Iced Tea 401(k) Plan (the "Plan") was established by the F&V Distribution Company, LLC; Arizona Beverage Company, LLC; Hornell Brewing Company, Inc.; Arizona Holdings Group LLC, Arizona Beverages USA, LLC, Arizona Southeast Distributors, LLC, AZ Metro Distributors, LLC, Arizona International, LLC and Beverage Marketing Services, LLC, and Beverage Marketing USA, Inc. (the "Employers") on March 1, 1995, for the purpose of providing eligible employees an opportunity to utilize the benefits of a tax-deferred savings plan. On December 18, 2023, the plan was amended to include Maplewood Beverage Packers, LLC, ABUSA Warehouse, LLC and US Beverages, LLC., as participating employer's beginning January 1, 2024. The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for more complete Plan description.

**Administration**

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The record keeper of the Plan is Automatic Data Processing, Inc. Retirement Services and Tax Services Systems. The Plan's investments are held and certified by Reliance Trust Company (the "Trustee").

The Plan is administered by the trustees and plan administrator, who represent the Plan sponsor. The Plan administrator is responsible for the day-to-day administration of the plan.

The Trustees of the Plan are responsible for the safekeeping of the trust fund.

**Eligibility**

The Plan is a defined contribution profit sharing plan covering all employees of the Company who have attained the age of 21 and have completed one month of service. Eligible participants may participate in the month following meeting the eligibility requirements.

**Employee Contributions**

Participants may make voluntary salary pre-tax and Roth after tax contributions up to 50% of eligible compensation, as defined by the plan, subject to certain Internal Revenue Code ("IRC") limitations. For the year ended December 31, 2024, and 2023 the limit capped by the Internal Revenue Service was \$23,000 and \$22,500, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions of \$7,500. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans.

**Employer Contributions**

Matching employer contributions are made to the Plan by the Company on behalf of each eligible participant. Employer matching contributions are equal to 50% of the participant's elective deferral amount. The employer may also make a non-elective contribution and allocate it to employees based on the participant's compensation, without regard to service. No such additional discretionary contribution was made for the year ended December 31, 2024.

**Participant Accounts**

Individual accounts are maintained for each Plan participant with the Trustee. Each participant's account is credited or charged with the participant's contribution, the Employers' matching contribution, investment earnings (losses), and allocations of discretionary contributions and withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investments**

Participants direct the investment of their contributions and Employers' contributions made on their behalf into various investment options offered by the Plan. The participants instruct the Trustee directly as to the allocation of deposits among funds and transfers among funds.

**Vesting**

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Employers' contribution portion of their accounts is based on continuous service. A participant is 100% vested after six years of credited service. Vesting in the Employers' profit-sharing contribution is subject to a six-year graded vesting schedule. Vesting of Employers' matching contributions is according to the following table:

Less than 2 years	0%
2 years but less than 3	20%
3 years but less than 4	40%
4 years but less than 5	60%
5 years but less than 6	80%
6 years or more	100%

**Participant Loans**

Participants may borrow from their accounts a minimum of \$500 and up to a maximum of \$50,000, but no more than 50% of their vested account balance (pre-tax and rollover accounts only). The loans are secured by the balance in the participant's account and bear interest at 1% over the prime rate of interest. Loans outstanding at December 31, 2024, and 2023 bear interest at the rate of between 4.25% - 10.50% and mature through 2029. Principal and interest are paid ratably through payroll deductions over the term of the loan.

**Payment of Benefits**

Participants are entitled to receive a distribution of their vested interest upon the termination of employment, an in-service distribution for elective and matching contributions for participants who have attained the age of 59 ½, participants who have attained full retirement age of 65, and in the event of death or a disability. Participants may make a hardship distribution as permitted by the Plan. Benefits to the participant or their respective beneficiary or beneficiaries are payable, depending upon the circumstances, in the form of a lump sum payment, or substantially equal monthly, quarterly, or annual installments. All distributions are made as administratively feasible. As of December 31, 2024, all employees who elected to withdraw from the Plan had been paid.

**Forfeited Nonvested Accounts**

Upon a participants' termination of employment before normal retirement, disability or death, the portion of their Company contributions not then vested shall be forfeited, the forfeited portion of a participants' account may be used to reduce future Employers' contributions or to pay Plan expenses. At December 31, 2024, forfeited nonvested accounts totaled \$350,469. During 2024 \$402,341 of forfeitures were used to reduce employer contributions.

**Plan Expenses**

Certain expenses for maintaining the Plan are paid directly by the plan sponsor, who is a party in interest, and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 2 -Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions. These estimates are subjective in nature and involve assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported amounts of investment income and deductions during the Plan year. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Common collective trusts are valued at the ended of each business day at fair market value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair market value of investments for such investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

**Benefit Payments**

Benefits are recorded upon distribution.

**Administrative Expenses**

Cost of plan administration may be paid by the Plan; however, certain administrative expenses are paid by the Company.

**Subsequent Events**

The Plan has evaluated subsequent events for recognition and disclosure through October 15, 2025, which was the date these financial statements were available to be issued.

**NOTE 3 - Fair Value Measurements**

The Financial Accounting Standards Board ("FASB") established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

**Registered investment companies (mutual fund)** – The Funds are valued at the daily closing price as reported by the fund. Mutual Funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - Exempt Party-In-Interest Transactions**

Certain employees and officers of the Company, who may also be participants in the Plan, perform administrative services to the Plan at no cost to the Plan. In addition, the Plan provides loans to Plan participants that qualify as exempt party-in-interest transactions. Administrative expenses paid by the Plan in 2024 to ADP, Inc., as record keeper, a party-in interest, amounted to \$141,052.

**NOTE 6 - Plan Termination**

Although it has not expressed any intention to do so, the Employers have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, the Trustee shall distribute to the participants, their beneficiaries, or estates, all assets remaining in the Plan after payment of any expenses properly chargeable to the Plan. Such distribution will be equal to the value of the accounts of the participants as of the date of the termination of the Plan, adjusted to reflect any increments or decrements occurring between such termination date and the date of distribution.

**NOTE 7 - Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS, to satisfy relevant nondiscrimination provisions of the Plan, are recorded as a liability with a corresponding reduction to participant contributions. There were no corrective distributions for the year ending December 31, 2024.

**NOTE 8 - Federal Income Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service ("IRS") stating that the Plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan is relying on IRS approval of a prototype plan dated October 6, 2020, in which the Internal Revenue Service stated that the prototype plan, *Non-standardized-Approved Profit Sharing Plan/Money Purchase/ CODA*, provided by ADP, LLC was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 9- Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
