1. DESCRIPTION OF PLAN

The following description of the Ferraro Foods of New Jersey LLC (the "Company") 401(k) (the "Plan") is provided only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, qualifying under section 401(a) of the Internal Revenue Code ("IRC"), and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan was established and designed to provide retirement income and other benefits primarily for the employees of the following employers:

Ferraro Foods of New Jersey LLC
Ferraro Foods Transport Corp.
Ferraro Foods of North Carolina LLC
Ferraro Foods of Maryland LLC
Ferraro Foods of New York LLC
Ferraro Foods of Connecticut LLC
Ferraro Fine Foods of Florida LLC
Ferraro Foods of New York East LLC
Ferraro Foods of New York North LLC

This group of employers is collectively referred to as the "Company" and the "Employers".

Effective October 8, 2024, Ferraro Foods of New York North LLC DBA Casa Imports was removed as a participating employer. All contributions for employees of Ferraro Foods of New York North, LLC were frozen and suspended as of end of day for the payroll period ending Friday October 4, 2024 (see also Note 11).

Eligibility

Any employee of the Company becomes an eligible participant in the Plan following their date of hire subject to the completion of three months of service and the attainment of twenty-one years of age. Employees subject to a collective bargaining agreement, temporary employees, and certain nonresident aliens are not eligible to participate in the Plan. Participant's entry dates for the Plan are the first day of each month.

Contributions

Contributions are comprised of participant deferral contributions, employer match contributions, and employer discretionary profit sharing contributions as follows:

- a) An employee participating in the Plan may annually contribute through payroll deductions, any amount up to 75 percent of compensation not exceeding amounts as determined by the Internal Revenue Service ("IRS").
- b) Any participant age 50 or over may make additional "catch up" contribution as determined by the IRS. Participants direct the investment of their contributions into various investment options offered by the Plan.
- c) The Company may also make a matching contribution. For the years ended December 31, 2024 and 2023, the Company made matching contributions of an amount equal to 25 percent of such contributing participants' elective deferral which does not exceed 6 percent of the contributing participants' compensation. Effective January 1, 2024 the matching contribution will be funded on a per payroll period basis.
- d) The Company may annually make a discretionary profit sharing contribution. For the years ended December 31, 2024 and 2023, the Company elected not to make a profit sharing contribution.

Participant Accounts

Individuals accounts are established for each Plan participant. Each participant's account is credited with the participant's pre-tax contributions and/or after-tax contributions, the Company contributions, if any, and the proportionate share of dividends, interest and investment gains since the preceding valuation date. The Plan currently offers several mutual funds and a stable value fund as investment options for participants. Each participant's account is reduced by withdrawals, losses on investments, expenses of the Plan, and any forfeitures. The benefit to which a participant is entitled is the benefit that can be provided from the participants's vested account.

Vesting

Vesting in employer contributions is based on years of credited service. Participants become 50% vested for each year of service completed after the first year and are fully vested after three years. A year of service is earned upon completing 12 months of continuous service or at least 1,000 hours of service within a shorter period. Participants are always 100% vested in their own salary deferrals. Unvested employer contributions are forfeited upon termination of employment, except in cases of death or disability, in which full vesting applies. Vesting in employer contributions and related earnings is determined as follows:

Less than 1 year	0%
At least 1 year, but less than 2	0%
At least 2 years, but less than 3	50%
At least 3 years	100%

Notes Receivable - Participant Loans

The Plan permits participant loans for financial needs, which are treated as direct investments of the Plan. Loan repayments of principal and interest are credited to the participant's account. Participants may borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the participant's account balance and bear interest at a reasonable rate, defined as the prime rate published in the Wall Street Journal on the first business day of the month in which the loan is originated, plus 1%. Loans have maturity dates through 2029 and are repaid through weekly payroll deductions. Only one loan may be outstanding per participant at any time.

Participant loans are presented as notes receivable from participants and are measured at the unpaid principal balance plus any accrued but unpaid interest.

Payment of Benefits

On termination of service due to death, disability, or normal retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, installment payments, can roll the amount over into another plan, or delay the distributions until the participant is required by law to receive minimum required distributions. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution, as soon as administratively feasible.

A participant may withdraw up to 100% of their account balance in the event of a participant's financial hardship, as defined in the Plan agreement. Hardship distributions are limited to a participant's vested amount.

Distributions from the Plan will normally be subject to income taxes and in certain circumstances may also be subject to Internal Revenue Service ("IRS") penalties, unless the distribution is transferred to another qualified plan or individual retirement account.

Administrative Expenses

The expenses necessary to administer the Plan, including, but not limited to, retaining necessary professional assistance from an attorney, an accountant, an actuary, or an investment advisor are paid by the Company. Participants are charged service fees for any loan or distribution transactions they request. Certain fees assessed by investment fund managers have been offset against net investment income.

Forfeitures

Forfeitures of terminated employee's non-vested accounts may be used to offset future contributions of the employers and administrative expenses. For the years ended December 31, 2024 and 2023 forfeitures applied to employer contributions were \$57,094 and \$79,061, respectively. As of December 31, 2024 and 2023, unapplied forfeitures were \$2,481 and \$1,635, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the Plan's financial statements in accordance with the accounting principles generally accepted in the United States of America ("US GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value in accordance with ASC 820, Fair Value Measurements. The fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines valuation policies utilizing information provided by the investment advisors, custodians, and other professionals. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. See Note 6 for discussion on fair value measurements.

Notes Receivable from Participants

Notes receivable from participants are measured and reported at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expenses when they are incurred. No allowance for credit losses had been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid by the Plan.

Reclassifications

Certain amounts in the December 31, 2023 financial statements have been reclassified to conform to the current year presentation. These reclassifications had no effect on the changes in net assets available for benefits or on net assets available for benefits as previously reported.

Subsequent Events Evaluation Date

In accordance with FASB ASC 855-10-50, "Subsequent Events," the Plan has evaluated subsequent events and transactions through October 15, 2025, the date the financial statements were available to be issued. See Note 11.

3. CERTIFIED INVESTMENTS

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations of Reporting and Disclosure under ERISA. Accordingly, certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company ("the trustee").

The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by the trustee.

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Financial Accounting Standards Board (FASB) Accounting Standards Codification 820 ("ASC 820"), "Fair Value Measurements and Disclosures", establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1: Level 1 assets and liabilities are those that input to the valuation methodology unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access. All investments recorded at fair value are within Level 1 of the fair value hierarchy.

Level 2: Level 2 asset and liability fair values are based on observable inputs that include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Level 3 assets and liabilities are inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds represent investments with various investment managers. The fair value of these investments are determined by reference to the Fund's underlying assets, which are principally marketable securities and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value as of December 31, 2024 and 2023.

Stable value funds (common collective trusts): Shares of the stable value funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are in funds and accounts that are managed by Reliance, which is a subsidiary of Fidelity National Information Services, Inc. Participant loan and distribution processing fees are paid to Reliance or the third-party administrator/recordkeeper by participants. The Plan paid for third party administrator fees and investment advisory fees which qualify as party-in-interest transactions. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments.

These transactions are not deemed prohibited party-in-interest transactions because they are covered by statutory or administrative exemptions from the IRC and ERISA's rules on prohibited transactions.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participant will become 100% vested in their accounts.

7. INCOME TAX STATUS

The Plan adopted an ADP prototype non-standardized profit sharing 401(k) plan, most recently restated as of October 8, 2024. The Internal Revenue Service has determined and informed ADP by a letter dated October 6, 2020, that the prototype plan and related trust are designed in accordance with applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS.

Accounting principles generally accepted in the United States of America require Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021. In addition, there have been no tax related interest or penalties for periods presented in these financial statements.

8. RISKS AND UNCERTAINTIES

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

10. REFUND OF EXCESS CONTRIBUTIONS

The Plan failed the IRC Section 402(g) limit test and IRC 401(k) Actual Deferral Percentage (“ADP”) and/or Actual Contribution Percentage (“ACP”) compliance tests of employees and employer contributions for the years ended December 31, 2024 and 2023. The Plan corrected the test failure by returning the excess contributions to the respective employees in the following year. The refund included income allocable to the excess contributions. As of December 31, 2024 and 2023, the excess employee contributions payable were \$46,581 and \$3,746, respectively.

During the years ended December 31, 2024 and 2023, the Plan also identified instances where employer matching contributions exceeded the amounts permitted under the Internal Revenue Code or the Plan’s provisions, due to nondiscrimination testing limitations and other eligibility criteria. As a result, excess employer matching contributions totaling \$375 and \$0 for 2024 and 2023 respectively were recorded as refundable to the Plan sponsor or forfeitable by affected participants.

These excess amounts are recorded as a liability in the accompanying financial statements as of December 31, 2024 and 2023, and will either be refunded to the employer or reallocated in accordance with the Plan’s provisions and IRS regulations. The Plan monitors employer contribution limits regularly to minimize the occurrence of excess matching contributions.

11. SUBSEQUENT EVENT

On September 16, 2025, all remaining plan assets of Ferraro Foods of New York North, LLC were transferred into a new, separate plan.
