## Independent Auditor's Report

To the Trustees  
C.A.P.E. 401(k) Employee Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of C.A.P.E. 401(k) Employee Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of C.A.P.E. 401(k) Employee Savings Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 – to the financial statements, is complete and accurate.

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of C.A.P.E. 401(k) Employee Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal controls relevant to the preparation and fair presentation of financial statements that are free from material misstatements, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**Note 1 –Summary of Significant Accounting Policies**

The significant accounting policies followed by the Plan are summarized below.

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

*Use of Estimates*

The Plan administrator uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions could affect the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities, and the reported additions to and deductions from net assets. Actual results could vary from the estimates that were assumed in preparing the financial statements.

*Investments Valuation and Income Recognition*

Pooled separate accounts are made up of mutual funds that are valued at net asset value as a practical expedient as provided by American United Life Insurance Company (American) utilizing quoted market prices of the underlying mutual funds less liabilities on the last business day of the Plan year. Guaranteed investment contracts are reported at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable are recorded as a benefit payment based on the terms of the Plan documents.

Payment of Benefits

Benefits are recorded when paid.

Administrative costs

The administrative costs charged to the Plan are paid by the Plan or the Plan Sponsor at the Plan Sponsor's discretion. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Subsequent events

The Plan's management has evaluated the financial statements for subsequent events occurring through October 10, 2025, the date the financial statements were available to be issued.

**Note 2 – Description of Plan**

The following description of the C.A.P.E. 401(k) Employee Savings Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was commenced and made effective July 8, 1998. The Plan was restated in its entirety effective January 1, 2020. The Plan is a defined contribution plan covering all employees of Community Action Program of Evansville and Vanderburgh County, Inc. The Plan, which provides for retirement, death and disability benefits, is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees can elect to defer up to 100% of their annual compensation, subject to certain limitations and as allowed under Section 401(k) of the Internal Revenue Code. In addition, participants may also make qualifying rollover contributions to the Plan. The Plan provides for an automatic elective defined contribution of 1% unless increased or opted out by participant. Employer contributions are discretionary and are limited by the maximum amount deductible under the Internal Revenue Code. The allocation requirements for an Employer contribution are non-highly compensated plan participants employment on the last day of the Plan year.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at rates currently at 5.5%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

Vesting

Under the Plan, employee contributions are 100% vested at the time of contribution. The employers’ contributions vest at the rates described in the following schedule based on hire date before or after the adoption of the amendment. Upon normal retirement age, or in the event of death or total disability of a participant, the value of each individual account becomes fully vested.

Forfeited Accounts

As of December 31, 2024 and 2023, there was \$0 and \$0 in forfeited accounts, respectively. Forfeited accounts are available to reduce future employer contributions to the Plan. For the years ended December 31, 2024 and 2023 \$28,299 and \$12,667 of forfeitures were used to reduce employer contributions, respectively. For the year ended December 31, 2023 \$770 of forfeitures were used for plan expenses.

Payment of Benefits

Generally, in the event of retirement, disability or death, a participant’s balance may be withdrawn. In special financial hardship situations, participants may be permitted to withdraw their balance. The basic form of distribution is a qualified joint and survivor annuity. However, the participant may elect to receive the balance of his or her account in a lump sum or installment payments. An employee who terminates employment prior to normal retirement date is entitled to the vested benefits in his or her individual account.

Participant Accounts

The Plan maintains participant-directed investment accounts on behalf of each participant. A participant’s account is credited with the participant’s contributions, Plan Sponsor contributions,

and investment earnings based on the investment options elected. Benefits to which a participant is entitled is the benefit that can be provided by participant's vested account.

*Termination*

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, the interest of all participants becomes fully vested and non-forfeitable.

**Note 3 - Fair Value Measurements**

The Plan has categorized its assets that are measured at fair value based on a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to valuation methodologies include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the published net asset value (NAV) of units held by the Plan at year end. (Level 1)

**Note 4 – Tax Status**

The Plan utilizes the One America Financial Partners, Inc. Defined Contribution Volume Submitter Plan which obtained its latest determination letter dated March 31, 2014, in which the Internal Revenue Service stated the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter.

However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**Note 5 – Party-In-Interest Transactions**

Certain Plan investments are managed by American United Life Insurance and Annuity Company (AUL). AUL is the custodian as defined by the Plan and, therefore, these investments and investment transactions qualify as exempt party-in-interest transactions. Plan audit and accounting fees are paid by the Employer/Plan sponsor. Certain administrative functions are performed by officers and employees of the Plan sponsor. These employees are also Plan participants. No such officers or employees received compensation from the Plan.

**Note 6 – Investment Contract with Insurance Company**

The Plan entered into a fully benefit-responsive investment contract with American United Life Insurance Company (AUL). AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The investment contract is fully benefit-responsive and reported at contract value. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting. The crediting interest rate as of December 31, 2024 and 2023 was 1.02% and 3.99%, respectively for the AUL Fixed Option. The crediting interest rate as of December 31, 2024 and 2023 was 1.75% and 1.50%, respectively for the AUL Stable Value Option.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.
