## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Omnissa 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the period from July 15, 2024 (date of inception) to December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Omnissa 401(k) Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the period from July 15, 2024 (date of inception) to December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. 1. Description of Plan

The following description of Omnissa 401(k) Plan (the "Plan") provides only general information for the Plan sponsored by Omnissa, LLC (the "Company"). Participants in the Plan should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan became effective on July 15, 2024, as a defined contribution plan. The Plan covers all non-union, non-leased, resident employees of the Company who have completed 30 days of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may contribute a percentage of their pre-tax, Roth, or after-tax annual compensation, not to exceed the maximum allowed by the Internal Revenue Service ("IRS"). Upon meeting eligibility requirements, employees are automatically enrolled in the Plan at a pre-tax deferral rate of 6%, unless they opt out. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also permits rollover contributions from other qualifying retirement plans. The Company makes safe harbor matching contributions whereby the Company matches 100% of a participant's elective deferrals up to 6% of the participant compensation. Additionally, the Company may make additional qualified matching contributions at its discretion.

Participant Accounts

Employee contributions, employer contributions, and rollover contributions activity are maintained separately in each participant's account. Participants direct the investment of their account balances into various investment options offered by the Plan. Participants may change their investments daily. Each participant's account is credited with the participant's contribution, the Company's contribution, and an allocation of plan earnings and administrative expenses. Allocations are based on participants' compensation or account balances, as defined. A participant is entitled to the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in the salary reduction amount, Company's safe harbor match and the qualified discretionary match.

Payment of Benefits

Generally, a participant becomes eligible to receive benefits on their normal retirement age (59.5), death, disability, termination of employment, or reasons of proven financial hardship. Participants can receive their account distribution in a lump sum, installment or partial withdrawal. Participants are also eligible to take in-service withdrawals once they attain age 59½. If the vested balance is less than \$7,000, a lump sum distribution is made.

1. Description of Plan (Continued)

Hardship Withdrawals

Participants may withdraw all or part of their elective deferral or safe harbor match contributions for immediate and severe financial need. In accordance with IRS regulations, the participant must exhaust all other assets available prior to obtaining the hardship withdrawal. Participants self-certify to qualifying for the hardship withdrawal.

Notes Receivable from Participants

Participants may borrow from their fund a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior 12-month period. A participant can only have one loan outstanding at a time. The loans are secured by the balance in the participant's accounts and shall bear a reasonable rate of interest based on prevailing interest rates charged by persons in the business of lending money. The interest rate is fixed during the duration of the loan. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 were \$2,216,465.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers all invested cash balances to be cash equivalents.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on upon the terms of the plan document.

2. Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are comprised of mutual funds, money market funds, and a self-directed brokerage account. These investments are valued at quoted market prices established in an active market which represent the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized appreciation and depreciation in value of investments are allocated to the participant accounts based on participant holdings in each fund.

Plan Expenses

Certain plan expenses are paid by the plan sponsor as provided by the plan document. Expenses related to specific participant transactions (notes receivable from participant and distributions) are charged directly to the participant's account.

3. Federal Income Taxes

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan document. This document received an opinion letter dated June 30, 2020, in which the IRS stated that the document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). As allowed by the IRS, the Plan is relying on the opinion letter issued on the plan document for its own qualification. The plan document has been amended for changes required by the IRS since receiving the opinion letter. The plan administrator believes the Plan is designed and currently operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the applicable authorities. 8. Party-in-Interest Transactions

Plan investments are managed by Fidelity, the trustee, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee and other parties-in-interest for contract administration, advisory and professional services were \$25,500 for the period from July 15, 2024 (date of inception) to December 31, 2024. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with a party-in-interest. All of these transactions are exempt from being prohibited transactions by ERISA.

9. Subsequent Events

The Company has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 8, 2025, which is the date the financial statements were available to be issued.

In December 2022, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2022 ("SECURE Act 2.0") that continued the retirement system reform previously passed in 2020. Certain provisions of the SECURE Act 2.0 are effective at various dates through 2026, with the plan amendment for the adoption of SECURE Act 2.0 due by December 31, 2026.

Effective August 1, 2025, the Plan was amended to discontinue the safe harbor match and implemented a discretionary match whereby Company will match 100% of a participant's elective deferrals up to 6% of the participant compensation.

Effective September 1, 2025, the Plan was amended to add Omnisssa Federal, LLC as a participating employer in the Plan.

1. Description of Plan

The following description of Omnissa 401(k) Plan (the "Plan") provides only general information for the Plan sponsored by Omnissa, LLC (the "Company"). Participants in the Plan should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan became effective on July 15, 2024, as a defined contribution plan. The Plan covers all non-union, non-leased, resident employees of the Company who have completed 30 days of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may contribute a percentage of their pre-tax, Roth, or after-tax annual compensation, not to exceed the maximum allowed by the Internal Revenue Service ("IRS"). Upon meeting eligibility requirements, employees are automatically enrolled in the Plan at a pre-tax deferral rate of 6%, unless they opt out. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also permits rollover contributions from other qualifying retirement plans. The Company makes safe harbor matching contributions whereby the Company matches 100% of a participant's elective deferrals up to 6% of the participant compensation. Additionally, the Company may make additional qualified matching contributions at its discretion.

Participant Accounts

Employee contributions, employer contributions, and rollover contributions activity are maintained separately in each participant's account. Participants direct the investment of their account balances into various investment options offered by the Plan. Participants may change their investments daily. Each participant's account is credited with the participant's contribution, the Company's contribution, and an allocation of plan earnings and administrative expenses. Allocations are based on participants' compensation or account balances, as defined. A participant is entitled to the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in the salary reduction amount, Company's safe harbor match and the qualified discretionary match.

Payment of Benefits

Generally, a participant becomes eligible to receive benefits on their normal retirement age (59.5), death, disability, termination of employment, or reasons of proven financial hardship. Participants can receive their account distribution in a lump sum, installment or partial withdrawal. Participants are also eligible to take in-service withdrawals once they attain age 59½. If the vested balance is less than \$7,000, a lump sum distribution is made.

Hardship Withdrawals

Participants may withdraw all or part of their elective deferral or safe harbor match contributions for immediate and severe financial need. In accordance with IRS regulations, the participant must exhaust all other assets available prior to obtaining the hardship withdrawal. Participants self-certify to qualifying for the hardship withdrawal.

Notes Receivable from Participants

Participants may borrow from their fund a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior 12-month period. A participant can only have one loan outstanding at a time. The loans are secured by the balance in the participant's accounts and shall bear a reasonable rate of interest based on prevailing interest rates charged by persons in the business of lending money. The interest rate is fixed during the duration of the loan. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 were \$2,216,465.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers all invested cash balances to be cash equivalents.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on upon the terms of the plan document.

Investment Valuation and Income Recognition

Investments are comprised of mutual funds, money market funds, and a self-directed brokerage account. These investments are valued at quoted market prices established in an active market which represent the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized appreciation and depreciation in value of investments are allocated to the participant accounts based on participant holdings in each fund.

Plan Expenses

Certain plan expenses are paid by the plan sponsor as provided by the plan document. Expenses related to specific participant transactions (notes receivable from participant and distributions) are charged directly to the participant's account.

3. Federal Income Taxes

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan document. This document received an opinion letter dated June 30, 2020, in which the IRS stated that the document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). As allowed by the IRS, the Plan is relying on the opinion letter issued on the plan document for its own qualification. The plan document has been amended for changes required by the IRS since receiving the opinion letter. The plan administrator believes the Plan is designed and currently operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the applicable authorities. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan uses Level 2 inputs when market prices are not attainable but other observable inputs are available to arrive at a fair value, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There were no Level 2 or 3 investments in the Plan.

*Level 1 Fair Value Measurements*

The fair value of mutual funds, money market funds and the self-directed brokerage account is based on quoted net asset values of the shares held by the Plan at year end.

7. Risks and Uncertainties

The Plan invests in various investment securities as directed by its participants. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

8. Party-in-Interest Transactions

Plan investments are managed by Fidelity, the trustee, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee and other parties-in-interest for contract administration, advisory and professional services were \$25,500 for the period from July 15, 2024 (date of inception) to December 31, 2024. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with a party-in-interest. All of these transactions are exempt from being prohibited transactions by ERISA.

9. Subsequent Events

The Company has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 8, 2025, which is the date the financial statements were available to be issued.

In December 2022, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2022 ("SECURE Act 2.0") that continued the retirement system reform previously passed in 2020. Certain provisions of the SECURE Act 2.0 are effective at various dates through 2026, with the plan amendment for the adoption of SECURE Act 2.0 due by December 31, 2026.

Effective August 1, 2025, the Plan was amended to discontinue the safe harbor match and implemented a discretionary match whereby Company will match 100% of a participant's elective deferrals up to 6% of the participant compensation.

Effective September 1, 2025, the Plan was amended to add Omnissa Federal, LLC as a participating employer in the Plan.
