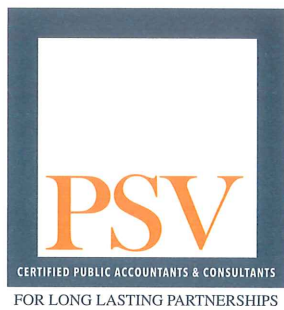

INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements Alight Solutions Caribe, Inc. Basis for Opinion

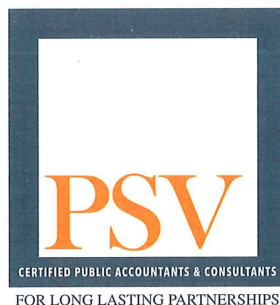

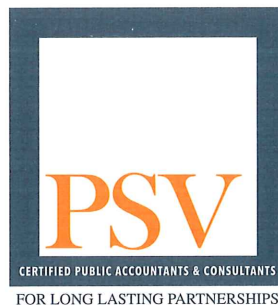


Auditor's Responsibilities for the Audit of the Financial Statements

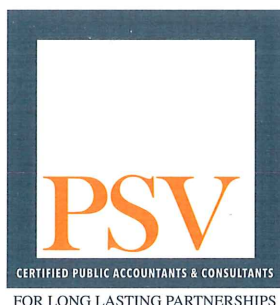

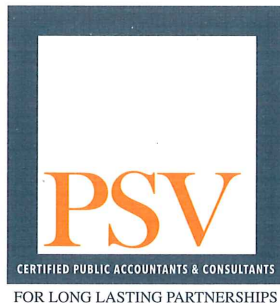

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Alight Solutions Caribe, Inc. Savings Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all employees of Alight Solutions Caribe, Inc. Savings Plan ("the Company"). The Plan was organized effective May 1, 2017, and is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974.

As of December 31, 2024 and 2023 there were 407 and 452 active participants with account balances in the Plan, respectively.

Contributions

For 2024 and 2023, participants' could contribute up to a maximum of \$15,000, respectively, of pre-tax annual compensation, as defined in the Plan. In addition to the maximum amount of pre-tax contributions allowed under the Plan, participants who have attained age 50 or over could make catch-up contributions of up to \$1,500 each plan year. Voluntary after-tax contributions are permitted up to of 10% of the participant's compensation. Participants directed all or a portion of the investment of their contributions into various investment options offered by the Plan. The Company matched participants' contributions at the rate of \$1.00 for each dollar of participant's pre-tax contribution, up to a maximum of 6% of participant's compensation. Additionally, the Company could have made additional contributions out of its net profit in such amounts as the Company determined, if any. No such additional discretionary contributions were made for the years ended December 31, 2024 and 2023. Participants were also allowed to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participants accounts and forfeitures

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's matching contributions and allocations of Company discretionary contributions, and Plan earnings (losses). Company's discretionary contributions are allocated based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants accounts and forfeitures (Cont'd)

The portion of a participant's account not vested at the date of his termination of employment, is forfeited immediately. Forfeitures accrued during a plan year are used to pay administrative expenses, and the unused portion will be added to employer's contribution to the Plan, whichever is decided by the Plan Sponsors annually. At December 31, 2024 and 2023, there were no forfeitures of non-vested accounts.

Vesting period

Participant's vesting period on the Company's discretionary contributions to their accounts plus actual earnings thereon are based on years of continuous service. Participant's vesting percentage on the employer discretionary contribution for the years 2024 and 2023 is as follows:

Payment of benefits

On termination of services due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period normally not exceeding five years. Upon termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to 50% of their vested balance not to exceed \$50,000. The loans are secured by the balance in the participant's account and bear interest equivalent to prime rate of the first day of the month in which the loan is requested plus one percent. Principal and interest are paid ratably through monthly payroll deductions.

Eligibility

To become a participant, an employee had to complete thirty (30) calendar days of service and attain the age of 21.

Administrative expenses

Certain expenses related to the operations and administration of the Plan are paid by the Plan, unless paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation and income recognition

The Plan's investments consist mainly of "units of participation" maintained in various investment funds held by the Trustee. Such investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Participant's loans are valued at the outstanding loan balances.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Estimates

The preparation of financial statements in conformity with U.S.A. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE C - INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)

For the years ended December 31, 2024 and 2023, the Plan's mutual fund investments and fixed annuities including gain and losses on investments bought and sold, as well as held during the years appreciated in value by \$654,999 and \$706,372, respectively.

NOTE D - FAIR VALUE MEASUREMENT

FASB ASC 820-10, "Fair Value Measurements and Disclosures", establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Basis of fair value measurement:

- Level 1- Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.
- Level 2- Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.
- Level 3- Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

NOTE D - FAIR VALUE MEASUREMENT (CONT'D)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market: Valued at the amount of money market.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Security and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed income: Valued at the closing price reported in the active market in which the individual security is traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - PLAN TERMINATION

Although it has not been expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE F - TAX STATUS

The Plan is qualified under Section 1081.01(d) of Internal Revenue Code for a New Puerto Rico of 2011, and therefore the trust is exempt from taxation. In the normal course of business, the Plan is potentially subject to income tax audits in the Commonwealth of Puerto Rico for its taxable years 2020 to 2024, until the applicable statute of limitations expire. Tax audits by their nature are often complex and can require several years to complete.

In general, contributions to a qualified plan are deductible by the Sponsor when made, earnings of the trust are tax exempt, and participants are not taxed on their benefits until withdrawn from the plan.

Management has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements.

NOTE G - RISKS AND UNCERTAINTIES

The plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H - PARTY-IN-INTEREST INVESTMENTS AND PROHIBITED TRANSACTIONS

The trustee and the investment manager receive an administrative fee for the services performed under the Plan Agreement associated with Plan record keeping, accounting, consulting and trustee services. Total Plan administrative fees during the years ended December 31, 2024 and 2023 totaled \$23,447 and \$20,621, respectively. There were no prohibited transactions for the years ended December 31, 2024 and 2023.

NOTE I - ELIGIBLE DISTRIBUTIONS BY PUERTO RICO TREASURY DEPARTMENT

On October 7, 2022, the Sponsor for the Plan authorized withdrawals/distributions of up to \$10,000 for all participants in active employment, as well as to allow for up to the first \$100,000 of total lump-sum distributions to cover eligible expenses incurred due to the recent legislation under the Puerto Rico Internal Revenue Code ("PR Code") Section 1081.01(b)(1)(D) and Circular Letter of Internal Revenue No. 22-13 issued on September 27, 2022 by the Secretary of the Puerto Rico Treasury Department, respectively, effective as of October 7, 2022 for distributions made until December 31, 2022, as this may be amended, extended or superseded.

NOTE J - SUBSEQUENT EVENTS

The date to which events occurring after December 31, 2024 have been evaluated is October 13, 2025, which is the date the financial statements were available to be issued.
