NOTE 1 • DESCRIPTION OF THE PLAN

The following description of The Pruet Companies Salaried Reduction Plan and Trust (hereafter referred to as the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of The Pruet Companies (hereafter referred to as the "Company") who are twenty years of age and have completed one year of service. A year of service is defined as 1,000 hours. An employee may begin participation in the Plan on January 1st, April 1st, July 1st or October 1st following the date the employee meets the requirements for eligibility. The Company's Board of Directors and the Plan Administrator control and manage the operation and administration of the Plan. Minnesota Life Insurance Company – Securian Financial Group served as the custodian of the Plan until it was acquired by The Standard Insurance Company. The Standard Insurance Company now serves as the custodian of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Company is an oil operator existing under the laws of the State of Mississippi. Its primary business is to provide and have an involvement in the oil industry through operations, exploration and/or production of crude oil and natural gas.

Contributions

Participants may contribute a percentage of pre-tax annual compensation, as defined in the Plan. There are no limitations on the percentage the participant can defer; however, the participant is limited by law as to the total contribution amount per year of \$23,000 and \$22,500 for 2024 and 2023, respectively. This amount is adjusted by the Secretary of the Treasury for the percentage increase in the Consumer Price Index each year. Additionally, participants age 50 and older can elect to make additional catch-up deferrals as described in the Plan, but not to exceed the limitation imposed by law of \$7,500 for 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. During 2024 and 2023, the Company's elected discretionary matching contribution was 100 percent of elective deferrals up to six percent contributed by the participant, but not exceeding \$2,700.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings and charged with an allocation of service and investment fees expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. There is no occurrence of forfeitures because accounts are 100 percent vested at all times.

Vesting

Participants are immediately vested in their contributions and the Company's discretionary matching contributions, plus actual earnings thereon.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in any investment option offered by the Plan. Participants may change their investment options daily.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 9.50 percent, which are commensurate with local prevailing rates as determined by the Plan Administrator, but in no case less than the prime rate of interest at the time the loan is made, plus one percent. Principal and interest is paid ratably through monthly automatic deductions from the participants' designated bank account.

Payment of Benefits

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a specified period.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Administrative Expenses

During 2024 and 2023, administrative fees payable to the custodian of the investments were paid by the Plan and all other expenses related to the administration of the Plan were absorbed by the Company.

NOTE 2 • SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis of accounting. The modified cash basis of accounting differs from accounting principles generally accepted in the United States of America in that Plan contributions and interest income from the Plan are recorded when received and administrative expenses are recorded when disbursed.

Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates. Significant estimates include the fair value measurement of investments. It is at least reasonably possible that the significant estimates will change within the next year.

Employee and Employer Contributions

Employee and employer contributions are recognized as additions to net assets when received. Employee rollover contributions are recognized as additions to net assets when received from other qualified plans.

Investment Valuation and Income Recognition

Investments are stated at year-end fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Any unrealized appreciation or depreciation for the year is reflected in the statements of changes in net assets available for benefits on a modified cash basis. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income and dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Participant loans are measured at their unpaid principal balance, and interest income is recorded when received. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Concentration of Credit Risk

The Plan assets include a significant amount of pooled separate accounts, which invest primarily in marketable equity securities and fixed income securities. Accordingly, the performance of the investments is dependent on the equity and debt securities markets which involve price volatility. Additionally, the pooled separate accounts may invest in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage-backed securities, including securities backed by subprime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

Subsequent Events

Subsequent events were evaluated by the Plan through October 13, 2025, which is the date the financial statements were available to be issued.

NOTE 3 • INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and participant loans held at December 31, 2024 and 2023, and net appreciation in fair value of investments, loan interest and interest income for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate. The information was certified by The Standard Insurance Company (current custodian of the Plan) and Minnesota Life Insurance Company – Securian Financial Group (former custodian of the plan) as of and for the years ended December 31, 2024 and 2023, respectively.

NOTE 4 • FAIR VALUE MEASUREMENTS

Fair value measurements define fair value as the price that would be received for an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. Fair value measurements establish a fair value hierarchy that prioritizes the observable and unobservable inputs used to measure fair value into three broad levels:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Primarily valued at net asset value per share based on quoted market prices of underlying investments.

The preceding methods may produce a fair value calculation that may not be indicative of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 • INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

The Plan has entered into a traditional fully benefit-responsive investment contract with Minnesota Life Insurance Company (the "Insurer") totaling \$3,626,626 and \$3,998,645 for December 31, 2024 and 2023, respectively. The Insurer maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon by the issuers. Such interest rates are reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This guaranteed investment contract meets the fully benefit-responsive criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate

permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Insurer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 • PARTY-IN-INTEREST TRANSACTIONS

Plan investments include a pooled separate account and a guaranteed investment contract managed by The Standard Insurance Company (current custodian of the Plan) and Minnesota Life Insurance Company – Securian Financial Group (former custodian of the plan) for 2024 and 2023, respectively. Fees incurred by the Plan for the investment management services qualify as party-in-interest transactions amounting to \$1,150 and \$1,330 for 2024 and 2023, respectively. Such fees are based on customary and reasonable fees for such services.

NOTE 7 • INCOME TAX STATUS

The Plan adopted a volume submitter plan sponsored by Minnesota Life Insurance Company - Securian Financial Group. The volume submitter plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the prototype plan's qualified status. The volume submitter plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan recognizes interest and penalties, if any, related to unrecognized tax benefits as a component of income tax expense.

NOTE 8 • NON-EXEMPT TRANSACTIONS

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. Contributions of \$51,955 and \$7,285 were not remitted within the required time period for the years ended December 31, 2024 and 2023, respectively. Included in the 2024 untimely contributions were contributions of \$17,949 which were not remitted until after the end of the plan year. The Plan has started the process to correct the matters through the Voluntary Fiduciary Correction Program and make the participant accounts whole.

NOTE 9 • SECURE 2.0 ACT

On December 29, 2022, the Securing a Strong Retirement Act of 2022 ("SECURE 2.0") was signed into law. Secure 2.0 has key effective dates which vary by provision. The plan has adopted and implemented all mandatory provisions to date with other provisions to be phased in over the next few years in accordance with applicable law and IRS guidance. Written amendments to the Plan to reflect these operational changes will be adopted at a later date.
