**Note 1 - Description of Plan**

The following description of the Ellendale Electric Company, Inc. (“Company”) 401(K) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**General:**

The Plan is a defined contribution plan where all full-time employees of the Company who have three months of service and are eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:**

The plan is an employee participation plan, which allows deferred compensation contributions as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. In 2024, the Company’s match was 100% of the first \$450 of employee deferred compensation that a participant contributes to the plan. Additional profit-sharing amounts may be contributed at the option of the Company’s board of directors. This allows the employees to determine the placement of their monies into funds on a personal level. Therefore, participant and Company matching contributions in addition to profit-sharing amounts are invested in investments as directed by the participant. The money would still be in the Ellendale Electric 401(K) Profit Sharing account with each participant having access to their individual account on a daily basis.

**Participant Accounts:**

Each participant’s account is credited with the participant’s contribution and the Company’s corresponding matching contribution. These accounts are credited with allocations of (a) the Company’s profit-sharing contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. These allocations are based on the participant’s beginning account balance reduced by forfeitures and benefits paid and adjusted by participant and employee matching contributions. Non-vested amounts forfeited to the remaining plan participants are allocated based on the remaining participant’s individual share of eligible compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting:**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on a six-year graded vesting schedule. A participant is 100% vested after six years of credited service.

**Participant Loans:**

Participant loans are not permitted.

**Payment of Benefits:**

On termination of service due to death, disability, retirement, or other reasons the participant or beneficiary will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account upon request. Benefits due are recorded when paid.

**Forfeited Accounts:**

These accounts will be used to reduce future employer contributions or pay administrative expenses. At December 31, 2024, the balance in forfeitures was \$516. An additional \$2,526 will be transferred due to overfunding in discretionary matching contributions in 2024. At December 31, 2023, the balance in forfeitures was \$660. An additional \$5,567 was transferred due to overfunding in discretionary matching contributions in 2023.

**Note 2 - Summary of Significant Accounting Policies**

**Date of Management's Review:**

Subsequent events were evaluated through the report date, which is the date the financial statements were available to be issued which is October 12, 2025.

**Use of Estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Basis of Accounting:**

The financial statements of the plan are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Payables are not reported.

Investments held by a defined-contribution plan are required to be reported at fair value. The statement of net assets available for benefits presents the fair value of the investment contract from fair value to contract value. The statement of changes in net assets available for benefits is prepared on a fair value basis.

**Investment Valuation and Income Recognition:**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits:**

Benefits are recorded when paid.

**Administrative Expenses:**

All expenses of maintaining the Plan are paid by the Plan.

**Note 3 - Investments Subject to ERISA Section 103(a)(3)(C)**

As to assets held for investment of the plan (investment information) by a bank or similar institution or permitted by ERISA section 103(a)(3)(C), our audit need not extend to any statements or information related insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and net appreciation in value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company (the trustee of the Plan). The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the supplemental schedule.

**Note 5 - Risk and Uncertainties**

The plan invests in various mutual funds. Mutual funds are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of mutual funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 6 - Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated July 17, 1995, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles of the modified cash basis of accounting require the plan administrator to evaluate tax positions taken by the Plan and recognize tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax period in progress. The Plan is no longer subject to income tax examinations for years prior to 2021.

**Note 7 - Parties-in-Interest Transactions**

Plan investments are mutual funds managed by Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services were included as a reduction of the return earned on each fund. Certain administrative fees related to the Plan were paid by the Plan.

During 2024, the Plan paid \$11,785 for the Plan's annual audit to Rowland & Carter, CPAs, PLLC recorded as administrative expense on the statement of changes in net assets available for benefits.

During 2024, the Plan incurred expenses of \$6,156 to ARES Retirement Plan Services, LLC recorded as administrative expense on the statement of changes in net assets available for benefits.

These parties-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note 8 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**Note 9 - Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they can generally provide the most reliable evidence of fair value. No Level 2 inputs were available to the Plan, and Level 3 inputs were only used when Level 1 or Level 2 inputs were available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

**Level 1 Fair Value Measurements**

**Mutual Funds**

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on closing price reported on the active market where the individual securities are traded. The stable value fund invests in a mix of synthetic investment contracts backed by high-quality fixed income securities, such as government, corporate, and asset-backed securities. These contracts are designed to protect the principal of the investments while providing a predictable, stable rate of return.

**Level 2 Fair Value Measurements**

**Pooled Separate Accounts**

These investments are valued using the NAV of units held by the Plan at year end as provided by Fidelity Management Trust Company and are classified as Level 2. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee. The fair value of U.S. government securities are valued using a market approach on yields currently available on comparable securities or issuers with similar credit ratings.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
