INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Board of Directors of
The Sounds True Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Sounds True Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Sounds True Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of Sounds True Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete description of the Plan’s provisions.

General

The Plan was established January 1, 1997 to provide for retirement benefits pursuant to Section 401(k)(1) of the Internal Revenue Code. The Plan is a defined contribution plan, also known as a tax-sheltered annuity plan, covering all eligible employees, sponsored by Sounds True, Inc. (“the Company”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Trustee and Administration of the Plan

As of January 22, 2024, the recordkeeper of the Plan was Empower Retirement, LLC (“recordkeeper”), and the trustees were Empower Trust Company, LLC and Empower Annuity Insurance Company of America. The administrator of the Plan is the Company. Prior to January 22, 2024, the recordkeeper was OneAmerica and the trustee was American United Life Insurance Company, a OneAmerica company, (“trustee” or “AUL”). The trustees hold all assets of the Plan in accordance with the provisions of the service provider contract with the Company.

Contributions and Eligibility

Employees of Sounds True, Inc. are eligible to participate in the Plan beginning on their first day of employment provided they are not specifically excluded. Entry date is the first day of the month following the date of hire. Participants may elect to make salary reduction contributions in an amount not to exceed the limits established by Internal Revenue Service guidelines which were \$23,000 for 2024. Participants who are at least age 50 or will attain age 50 before the end of a calendar year are eligible to defer additional amounts (“catch-up contribution”) to the Plan. The maximum catch-up contribution that one eligible participant can make in 2024 is \$7,500. Participants who are currently employed or eligible employees may also contribute amounts representing distributions from other retirement plans and certain IRAs.

The Company matches 100% of the participants’ contributions up to 4% of compensation, which is 100% vested. Contributions are self-directed by participants within the investment vehicles offered by the Plan. Contributions are allocated to participants’ accounts in accordance with participant elections. Employees have the option to invest in various investment options.

Each participant’s account is credited with his or her contributions and an allocation of the Company’s contributions and of investment earnings and losses. Contributions are accrued as of the date they are withheld from participant compensation and are deposited directly into the investment option selected by the participant.

Vesting

Participants are immediately 100% vested in their voluntary contributions, Company safe-harbor matching contributions, and earnings thereon. Prior to November 1, 2022, the vesting schedule for the employer nonelective contribution was based on the employee's original hiring date, or number of years of service completed:

Effective November 1, 2022, the Plan was amended to provide for 100% vesting in employer nonelective contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of one-half of a participant's vested account balance or \$50,000 reduced by the highest outstanding loan in their account during the prior twelve-month period. Loans bear interest based on prevailing rates charged by persons in the business of lending money for loans and remain fixed throughout the duration of the loan. Principal and interest must be repaid in level payments through after-tax payroll deductions on at least a quarterly basis over a five-year period, unless for the purchase of a principal residence in which case the repayment period may not exceed 10 years from the loan origination date.

Distributions

Withdrawals from the Plan may be made by the participant upon death, total disability, retirement, termination of employment, or financial hardship. Withdrawals may be paid in a lump sum, installment payments or a combination of the two depending upon the amount of the participant's account balance.

Forfeited Accounts

At December 31, 2024 and 2023, the balance held in the forfeiture or unallocated expense account was \$15,517 and \$15,305 respectively. Forfeitures are allocated as follows: a) the Employer may use forfeitures to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan or b) forfeitures can be reallocated to participants as though they are additional Employer Contributions. In 2024 and 2023, no forfeitures were allocated.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA.

NOTE 1 – DESCRIPTION OF PLAN (continued)

Income Tax Status

On November 14, 2022, the IRS stated that the prototype adopted by the Plan, as then designed, is acceptable under IRC 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan was designed and was being operated in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable tax authorities.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Because Plan management believes that the Plan had no taxable income, no income tax returns have been filed for 2024 or prior years.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in assets and liabilities during the reporting periods. Actual results could differ significantly from those estimates.

Risks and Uncertainties

The Plan provides for various investments in pooled separate accounts and guaranteed certificate funds. Investments, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible the changes in the value of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for Plan benefits.

Related Party Transactions and Party in Interest Transactions

The Plan is invested in group annuity contracts managed by Empower Annuity Insurance Company of America. Empower Trust Company is the custodian and recordkeeper for the Plan and, therefore, these transaction qualify as party in interest transactions.

Empower Trust Company, as the Plan's third party administrator, receives indirect compensation from investment fund providers for recordkeeping, administration, communication and other shareholder services provided on behalf of the registered investment companies. Certain indirect compensation is offset against administrative expenses charged to the Plan.

Prior to January 22, 2024, certain Plan investments were shares of registered investment companies or mutual funds managed by AUL. AUL was the asset trustee, and therefore, these transactions qualify as party in interest.

Investment Valuation and Income Recognition

Investments are stated at fair value, with the exception of fully benefit-responsive contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determines the Plan's valuation policies utilizing information provided by the investment advisor and insurance company. See Note 4 for discussion of fair value measurements.

The Plan's fully benefit-responsive investment contract (Note 5) is valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as taxable distributions to the participant in accordance with the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan. Certain transaction-based fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 4 – FAIR VALUE MEASUREMENTS

FASB ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have no been changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed Interest Account: The value of the guaranteed interest account is stated at estimated fair value as reported by Mutual of America Life Insurance Company. The investment is made up of liquid cash and is valued at dollar for dollar and is registered with the National Association of Insurance Commissioners ('NAIC').

Pooled Separate Assets: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Account: The market value is determined through observable inputs to formulas in the contract and related communications. As such, this investment is classified as Level 2.

The inputs or methodology used for valuing securities are not an indication of the risks associated with investing in those securities.

NOTE 5 – INVESTMENT IN INSURANCE FUND

As of December 31, 2024, the Plan held a fully benefit-responsive investment contract, the Empower Investments Fixed Account - Series Class I, with Great-West & Annuity Insurance Company (“Great-West”). Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented at contract value on the face of the statement of net assets available for benefits.

Contract value, as reported by the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, and prevailing market conditions. The interest crediting rate is reset quarterly by Empower Annuity Insurance Company of America. As described in Note 2, contract value is the relevant measurement attribute for this fund.

Certain events limit the ability of the Plan to transact at contract value with Great-West. Such events include premature termination of the contracts by the Plan, layoffs, Plan termination, bankruptcy, mergers and early retirement incentives. The Plan does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable. There are no reserves against contract value for credit risk of Great-West or otherwise.
