Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Children's Health System, Inc. Defined Contribution Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statements of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and for the year then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the 2024 financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the 2024 financial statements.

In preparing the 2024 financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Description of Plan

The following description of the Children’s Health System, Inc. Defined Contribution Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined-contribution plan that is sponsored by Children’s Health System, Inc. (“CHS”). The plan provisions were designed to qualify under Section 403(b) of the Internal Revenue Code (“the IRC”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan’s Employee Benefits Committee is responsible for oversight of the Plan, appropriateness of the Plan’s investment offerings, monitoring investment performance, and reporting to the Children’s Health System, Inc. Board of Directors. The custodians of the Plan are Principal Trust Company (“Principal”) and Nationwide Life Insurance Company (“Nationwide”). The custodians execute investment transactions under a participant-directed arrangement.

In accordance with the terms of the Plan, CHS froze the Plan effective December 31, 2013 with respect to both new participants and additional contributions and will maintain the Plan as a frozen plan as directed by the September 17, 2013 resolution of the Board of Directors of CHS. All subsequent payroll deferrals made by participants who participated in the Plan have been contributed to the CHS 401(k) Plan, effective January 1, 2014. The CHS 401(k) Plan is a defined-contribution plan of a controlled group that provides savings benefits for substantially all employees of the following controlled group entities: CHS, Children’s Hospital of the Kings Daughters, Incorporated, Children’s Surgical Specialty Group, Inc., Children’s Medical Group, Inc., and CMG of North Carolina, Inc.

Eligibility

Substantially all employees of CHS were eligible to become participants upon hire. Participants are eligible for retirement benefits upon attaining age 65. Each retiring participant is eligible to receive an amount equal to the balance in their account, and they are able to choose from various distribution alternatives specified by the Plan.

Contributions

As this Plan is a frozen plan, there were no contributions made in 2024 or 2023.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant’s account is credited with allocations of Plan earnings (losses), and charged with benefit payments, transactions fees related to distributions, and allocations of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined.

Vesting

Participants are 100% vested in their own contributions and in employer-matching contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants are able to borrow against their accounts a minimum of \$1,000 up to a maximum of \$50,000 reduced by the highest outstanding loan balance during the past 12 months, or 50% of their vested account balance, subject to certain plan restrictions. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% as determined by the plan and must be repaid over five years. At December 31, 2024, outstanding loans bore interest rates ranging from 4.25% to 9.50%. If the loan was made for the purchase of a participant's residence, the loan may be repaid over a reasonable period of time that may be longer than five years. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service, normal retirement age of 65, becoming permanently disabled, or death, a participant or their designated beneficiary may elect to receive either a lump-sum amount equal to the value of his or her account or other flexible installments over the life of the participant not to exceed his or her life expectancy. The Plan will make involuntary cash-outs of account balances of terminated vested participants of \$1,000 or less. In addition, eligible rollover distributions of account balances greater than \$1,000 but not greater than \$7,000 will be subject to the automatic rollover requirements. The Plan also allows in-service distributions at age 59½. Participants are also permitted emergency hardship withdrawals, subject to certain plan restrictions.

Forfeitures

There are no forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Employee Benefits Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 3 for discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued and unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan may be paid directly by CHS and are excluded from these financial statements. Management fees and operating expenses of the Plan's investment funds are paid by the investment funds. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments. A portion of the management fees for certain investment funds is returned and allocated to participants who are invested in the funds, which practice is commonly referred to as "revenue-sharing." Additionally, each participant's account is charged a plan service charge, calculated on a basis point formula to cover permissible recordkeeping and custodian fees, as well as investment advisory, audit, and legal related fees. These permissible fees are included in administrative expenses.

ERISA Account

Plan participants are charged with a plan service charge on a monthly basis and these funds are used to pay permitted plan expenses. Plan service charges are charged in terms of a basis point formula in accordance with the Plan Document. In order for the Plan to receive credits as a result of the plan service charge arrangement, and to use these credits to pay plan expenses, an ERISA account was created under the Plan. The ERISA account is a noninterest bearing cash account held outside of the plan and is used to track the redistribution of service charges and expenses that exceed the costs associated with plan administration. The amount of unallocated funds held in the ERISA account at December 31, 2024 and 2023 was \$12,026 and \$11,260, respectively. The Plan allows for the calculated excess in the ERISA account, as determined by the Employee Benefits Committee, to be allocated to participant accounts pro rata in proportion to their account balances. The ERISA account had an excess balance of \$5,876 in 2024 and \$0 in 2023, which was allocated to participant accounts on the same basis as the amounts were initially charged to participants.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025 the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

Fair value is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. There is a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan’s assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Self-Directed Participant Brokerage Account

Accounts primarily consist of mutual funds that are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Fully Benefit-Responsive Investment Contracts

The Plan has a fully benefit-responsive guaranteed investment contracts with Principal and Nationwide with a contract value of \$6,330,716 and \$8,357,458 at December 31, 2024 and 2023, respectively. The contracts meet the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on an agreed upon formula but may not be less than zero. Such interest rates are reviewed on a semi-annual basis for resetting. There are no events that limit the ability of the Plan to transact at contract value with the issuer. The guaranteed annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments

Note 5. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule(s) is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 6. Exempt Party-in-Interest Transactions

Principal, the Plan's recordkeeper, provides certain administrative services to the Plan pursuant to a Service and Expense Agreement (SEA). Certain plan investments are shares in mutual funds affiliated with Principal. Principal is the trustee of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return on each fund. Fees paid by the Plan to Principal were \$159,979 and \$164,044 in 2024 and 2023, respectively. Fees paid for other professional services totaled \$8,515 and \$6,232 for the years ended December 31, 2024 and 2023, respectively.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. However, under no condition will any funds revert to CHS unless otherwise allowed under the IRC.

Note 8. Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code ("Code"). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS). A favorable opinion letter dated March 31, 2017 has been received by Principal and management is relying on this letter as permitted by the IRS. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

Management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
