The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of Gould Medical Group, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution plan covering employees of Gould Medical Group, Inc. (the “Group”). The Plan was established on January 1, 2002, and most recently amended to adopt the Fidelity Pre-approved Plan effective May 1, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions and Vesting:

Participants may direct any amount of their pre-tax annual compensation into the Plan up to the maximum limit established annually by the Internal Revenue Service. The employee may also contribute to the Plan on an after-tax basis. Participants direct the investment of their contributions into various investment options offered by the Plan. Participant contributions and earnings are fully vested and non-forfeitable at all times.

Discretionary nonelective employer contributions may be contributed at the option of the Group’s board. The employer contributed 12% of the participant’s annual compensation to the Plan up to the maximum limits established annually by the Internal Revenue Service. The Group’s discretionary nonelective employer contributions and matching contributions have a three-year cliff vesting schedule, whereby participants become 100% vested after three years of service or upon death, disability or early retirement age of 55.

Participant Accounts:

Fidelity Workplace Services LLC, as agent for the trustee, Fidelity Management Trust Company, maintains an account for each participant. Each participant account is credited with the participant’s contribution and allocation of Plan earnings. The earnings are based on the earnings of the investments selected by the participant. The participant directs the investment of their account into various investment options offered by the Plan.

Notes Receivable from Participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant’s account. Loans bear interest at a rate equal to the prime rate plus 2%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Interest received is credited directly to the borrower’s account.

Note 1. Plan Description (Cont.)

Other Revenue:

The Plan receives revenue credits for amounts paid to the Plan under revenue sharing arrangements. Amounts are allocated to participants as a reverse fee which reduce the direct fees paid out of the Plan. The allocations of the revenue credits are made to eligible participants pro rata based on the participant's average daily balance in the respective fund as defined in the Plan.

Payment of Benefits:

Upon separation of service or other conditions as defined in the Plan, the participants or their beneficiaries are entitled to a lump sum cash payment equal to the value of the participant's vested interest in his or her account, or various options as defined in the Plan. The Plan permits a hardship distribution to a participant in accordance with the Plan's hardship policies.

Administrative Expenses:

All Plan investment and trust management fees paid are charged against the Plan's assets. These fees are allocated to the participants' accounts in the same manner as the allocation of income and loss. Expenses related to specific participant transactions are charged to the respective participant's account.

Forfeited Account:

At December 31, 2024 and 2023, the forfeited non-vested account totaled \$1,828,170 and \$2,860, respectively. Amounts accumulated in the forfeiture account will be used to reduce future employer contributions. Forfeitures of \$94,566 and \$44,748 were used to reduce employer contributions during the years ended December 31, 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note is recorded as a benefit payments based upon the terms of the plan document.

Note 2. Summary of Significant Accounting Policies (Cont.)

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in fair value of investments presented on the statement of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Revenue Credit Program:

The Plan participates in a revenue credit program offered by Fidelity. Under this program, a portion of the revenue generated by certain investment options is credited back to the Plan. These credits are used to offset plan recordkeeping fees and allocated back to eligible participants.

During the year ended December 31, 2024, the Plan received revenue credits totaling \$392,073. Recordkeeping fees incurred during the same period were \$78,338. The excess credits of \$313,735 are presented as other income on the accompanying statement of changes in net assets available for benefits.

Benefits Paid to Participants:

Benefits are recorded when paid.

Use of Estimates:

The preparation of financial statements is in conformity with accounting principles generally accepted in the United States of America. Those standards require management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

Date of Management's Review of Subsequent Events:

The Plan has evaluated subsequent events through October 5, 2025, the date on which the financial statements were available to be issued.

Note 3. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 measurements consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and Level 3 measurements are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Level 1 Fair Value Measurements

Investments in registered investment companies (mutual funds) are stated at the respective fund's NAV, which is determined based on market values at the closing price on the last business day of the year. The NAV is a quoted price in an active market and classified within the Level 1 hierarchy.

Investments in self-directed brokerage accounts consist primarily of common stocks, mutual funds and exchange traded funds that are valued daily based on their quoted market prices and classified within the Level 1 hierarchy.

Upon termination of the Plan, the total net assets of the Plan are to be distributed to the participants in proportion to their account balances.

Note 6. Related Party and Party-in-Interest Transactions

Certain investments in the Plan are issued by an affiliate of Fidelity; and therefore, these transactions qualify as party-in-interest transactions. Also, during the 2024 and 2023 plan years, the trustee of the Plan provided participant-level services as defined by the Plan and; therefore, these transactions qualify as party-in-interest. These transactions are covered by an exemption from the “prohibited transaction” provisions of ERISA and the Internal Revenue Code.

Participants may borrow from their vested account balance. Such loan transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA and the Internal Revenue Code.

Note 7. Income Tax Status and Plan Amendments

The Internal Revenue Service has determined and informed the sponsor of the pre-approved plan by a letter dated June 30, 2020, that the plan is designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has not received an individual determination letter, the plan administrator and management believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code; and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan’s tax returns remain open for three to four years for income tax examination.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
