Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kelley Health Holdings, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kelley Health Holdings, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Kelley Health Holdings, Inc. 401(k) Plan Notes to Financial Statements

Note 1: DESCRIPTION OF THE PLAN

The following description of the Kelley Health Holdings, Inc. 401(k) Plan (the “Plan”) provides only general information. Refer to Plan documents for a more complete description of Plan provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Kelley Health Holdings, Inc. (the “Company”, “Sponsor”, “Employer”, or “Plan Administrator”) and its affiliates (the Plan employers). The Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan’s trustee and management determines the appropriateness of the Plan’s investment offerings and monitors investment performance. Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Principal Life Insurance Company and Principal Trust Company, the custodians and qualified institutions, which invests contributions and Plan earnings, makes investment transactions as directed by participants and provides certain recordkeeping services. The Retirement Advantage, Inc. acts as the third-party consultant for the Plan, which performs certain plan administration and annual ERISA compliance testing.

Eligibility

The Plan covers substantially all full-time employees with exclusions for non-resident aliens who have no earned income from sources within the United States, leased employees, independent contractors and illegal aliens. Employees will become eligible and may enter the Plan on the first day of the calendar month, coincident with or next following the date they attain the age of 21 and complete 90 days of service.

Contributions

Each year, participants may defer a percentage of pretax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. For the year ended December 31, 2024, the Company elected to make a safe harbor matching contribution equal to 100% of the employee contributions that are not in excess of 1% of compensation, plus 50% of the amount of the employee contributions that exceed 1% of compensation but do not exceed 6% of compensation. The plan also has qualified automatic contribution agreement (QACA) for safe harbor automatic enrollment and contributions, which automatically defers 6% of compensation for an eligible employee, but also allows for a eligible participant to opt out, withdraw or select a different deferral percentage if done within the time limits set by the Plan agreement. Additional amounts may be contributed at the option of the Company’s Administrator and none were made during the year.

Kelley Health Holdings, Inc. 401(k) Plan Notes to Financial Statements

Note 1: DESCRIPTION OF THE PLAN (Continued)

During the year ended December 31, 2024, the Company contributed \$183,353, including receivables, in safe harbor employer matching contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company's discretionary matching or safe harbor matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. The Plan has elected a two-year cliff for discretionary non-safe harbor matching contributions, safe harbor matching contributions and QACA contributions. A participant is vesting in these contributions as follows:

A participant's account becomes fully vested upon the participant's death, total disability or attaining normal retirement age.

Receivables

Contributions receivable include those pursuant to formal commitments based on the Plan's adoption agreement. Evidence that a formal commitment existed was based on criteria that (a) the contribution is based on participant compensation that existed for the current plan year and (b) the plan terms require a contribution to be made for the current plan year.

Benefit Payments

On termination of service due to death a beneficiary will receive a single sum amount equal to the value of the participant's vested interest in his or her account or made over the life, or period not greater than life expectancy, of the beneficiary or in the form of minimum required distributions. For termination of service for other reasons, a participant will receive the value of the vested interest in his or her account as a lump sum distribution.

Note 1: DESCRIPTION OF THE PLAN (Continued)

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$266 and \$194 respectively. These accounts will be used to reduce future employer contributions or for administrative expenses. In 2024, employer contributions were reduced by \$33,572 and administrative expenses were reduced by \$25 from forfeited nonvested accounts.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC) and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements. The Plan's administrator, trustee and management determines the Plan's valuation policies utilizing information provided by the custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Distributions to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued, and determined there were no events that occurred that required disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator and Custodian has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company, the qualified institutions:

- a) Total investments, at fair value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Investment income information included in the statement of changes in net assets available for benefits, for the year ended December 31, 2024.
- c) All amounts included in Note 4, *Fair Value Measurements*.
- d) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts ("PSA"): Assets of a pooled separate account are pooled with funds of other investors and invested in stocks or mutual funds. The underlying securities have observable level 1 quoted pricing inputs or the fair value of the underlying investment may be publicly traded with a quoted price. The pooled separate account is not publicly quoted but the net asset value of the account is available to current investors via the Plan website or when Plan participants access the account values. The value is the basis for current transactions and the PSA can be redeemed at net asset value as of the measurement date. Therefore the Plan investments in PSAs have been determined to have a "readily determinable fair value" as is valued as a Level 1 asset.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and valued as a Level 1 asset.

Note 4: FAIR VALUE MEASUREMENTS (Continued)

Common collective trusts ("CCTs"): The Plan's CCTs invest in a stable value fund. The fair value of the collective investment trust does not have a publicly quoted pricing input, but is available to current investors via the Plan website or when Plan participants access their account values. The net asset value is the basis for current transactions and the CCT can be redeemed at net asset value as of the measurement date. Therefore, the Plan investments have been determined to have a "readily determinable fair value" as is valued as a Level 1 asset.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Note 5: TAX STATUS

On June 30, 2020, the IRS stated in an opinion letter that the preapproved profit-sharing plan adopted by the Plan, as then designed, qualifies under IRC Section 401. The preapproved profit-sharing plan has been amended since receiving the opinion letter and the Plan has not received a determination letter specific to the Plan itself. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal Life Insurance Company and Principal Trust Company. Principal Life Insurance Company and Principal Trust Company are the Custodians and record-keepers for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan paid certain expenses related to Plan operations and investment activity to various service providers, as described in Note 1 and 2. These transactions qualify as party-in-interest transactions under ERISA.

Note 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 9: NON-EXEMPT TRANSACTION

In eight instances during 2024, the Company experienced unintentional delays in the remittance of withheld participant contributions to the Plan which was not considered timely in accordance with the plan asset provisions of the Department of Labor (DOL) Regulation 2510.3-102, resulting in a prohibited (or a non-exempt) transaction. The aggregate amount of participant contributions in the late remittances was \$107,758. The accompanying Schedule of Delinquent Participant Contributions discloses this non-exempt transaction in accordance with DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The Company is evaluating this non-exempt transaction during the year ending December 31, 2025, with consideration being given to the DOL's Voluntary Fiduciary Correction Program and funding the impacted Plan participants' accounts for earnings that would have been credited to the participants' accounts if the late remittance had been made on a timely basis.
