NOTE 1 - DESCRIPTION OF THE PLAN

The following description of Fortune Metal Inc. of Rhode Island 401(k) Profit Sharing Plan (the “Plan”), sponsored by Fortune Metal Group Inc. (the “Company”), provides general information only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering all full-time employees of the Company who are at least 21 years of age and have completed at least one year of service and are not excluded employees for purposes of the Plan. Excluded employees include union employees whose employment is governed by a collective bargaining agreement and nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions - Each employee who elects to participate in the Plan may authorize a payroll deduction up to 90% of their annual compensation, not to exceed the limits of Internal Revenue Code Sections 401(k), 404, and 415, to contribute to his or her individual account in the Plan. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes safe harbor matching contributions on a dollar for dollar basis up to the first 4% and 50% on the next 1% of annual compensation contributed by participants. The Company may elect to contribute a discretionary profit sharing amount for its members. Highly compensated and certain other employees are subject to limitations as defined in the plan agreement. Contributions are subject to certain IRS limitations.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company’s matching contribution, if any, and (b) Plan earnings, and is charged with an allocation of administrative expenses, if any, that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately and fully vested in their contributions made to the Plan and actual earnings thereon as well as any safe harbor matching contributions and non-elective employer profit sharing contributions.

Investment Options - Upon enrollment in the Plan, a participant may direct his or her contributions in any of the funds offered by ADP. Participants may elect to change their investment options daily.

Forfeitures - While participants are fully vested at all times, excess contributions may occur and these contributions are forfeited by the participant when identified by the Plan Sponsor. At December 31, 2024 and 2023, forfeited non-vested accounts arising from excess contributions totaled \$206 and \$197, respectively. These accounts will be used to reduce future contributions.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

Payment of Benefits - Benefits are payable upon termination of employment, retirement, death or total disability. Participants may elect to receive benefits in a lump-sum of cash equal to the balance of the participant's vested interest in their account, as a direct rollover, or a combination of both. Participant balances below \$5,000 for terminated employees will be cashed out in accordance with the Plan document.

Hardship Withdrawals - The Plan allows for "hardship" withdrawals in accordance with the Internal Revenue Service regulations as specified in the Plan summary.

Plan Expenses - All costs and expenses with regard to the purchase or sale of investments and plan administration are paid by the plan sponsor. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no charge to the Plan. Expenses that are paid by the Company are excluded from these financial statements.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to an amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan. The payment term for any loan is generally five years except when the loan is used for the purchase of a primary residence, in which case the repayment must be made within a reasonable time. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as defined in the Plan. Principal and interest is paid ratably through weekly payroll deductions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements are presented on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recognized when paid.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Risks and Uncertainties - The Plan provides the participants with various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Fair Value Measurements - ASC Topic 820 *Fair Value Measurements* defines fair value, establishes guidelines for measuring fair value, and expands disclosure regarding fair value measurements.

Disclosure of Subsequent Events - Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

NOTE 3 - TAX STATUS

The Plan uses a prototype plan document sponsored by ADP, LLC. ADP, LLC obtained its latest determination letter on October 6, 2020, in which the Internal Revenue Service stated that the prototype document satisfies the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examination for years prior to 2022.

NOTE 5 - FAIR VALUE MEASUREMENTS

ASC Topic 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value of shares held by the Plan at year-end. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
