Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of the 403(b) Thrift Plan of East End Disability Associates, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of October 7, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 through October 7, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of October 7, 2024 and December 31, 2023, and for the period from January 1, 2024 through October 7, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

Prior to January 1, 2009, records were maintained at a contract, not a plan level; therefore, management has not maintained, and Mutual of America Life Insurance Company did not provide, sufficient accounting records and supporting documentation relating to certain annuity contracts and custodial accounts issued to current and former employees, and supporting documentation is not adequate to assure the completeness and accuracy of the amounts included in the financial statements. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements have been affected by these conditions.



Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America (GAAS) and to issue an auditor's report. However, because of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Notes to Financial Statements

1. Description

The following brief description of the 403(b) Thrift Plan of East End Disability Associates, Inc. (the Plan), which was sponsored by East End Disability Associates, Inc. (the Company), an affiliate of Kinexion, Inc. Network (Kinexion), was provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan was a defined contribution plan under Section 403(b) of the Internal Revenue Code (IRC) and covered all eligible employees of the Company. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Merger

Effective October 7, 2024 (Merger Date), the Plan merged with the 403(b) Retirement Plan for IGHL & CDD (the IGHL-CDD Plan), as both plans were part of Kinexion. All assets and participant accounts were transferred into the IGHL-CDD Plan on October 7, 2024 and the Company became a participating employer of the IGHL-CDD Plan, with their employees being eligible to participate.

Plan Administration

Mutual of America Life Insurance Company (Mutual of America) was the Plan's third-party administrator and the Plan's custodian. The Company, as the Plan sponsor, controlled and managed the operation and administration of the Plan.

Eligibility

All employees that were not excluded employees, as defined by the Plan document, were eligible to participate in the Plan on the first date of employment with the Company. To be eligible for participation in the employer components of the Plan, an employee must have attained the age of 21 and completed at least one year of service (defined as 1,000 hours of service during the Plan year).

Employee Contributions

Participants were able to contribute up to 100% of their compensation for the contribution period, subject to Internal Revenue Service (IRS) limitations of \$23,000 in 2024. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions subject to IRS limitations of \$7,500 in 2024. Participant contributions were recorded in the period during which the participant's salary was reduced under a salary reduction agreement with the Company. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Employer Contributions

The Company could have elected to make discretionary contributions, as approved by the Company, for each Plan year. The participants were immediately 100% vested. The discretionary contributions made by the employer were credited to each participant's account in accordance with the

employee's designated investment mix. There were no employer contributions during the period from January 1, 2024 through October 7, 2024.

Participant Accounts

Each participant's account was credited with the participant's contributions, the employer's contribution, and an allocation of net Plan earnings or losses. Participant accounts were charged with an allocation of certain administrative expenses. Allocations were based on participant earnings, deferrals, or account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the vested portion of their accounts.

Payment of Benefits

A participant's entire interest in the Plan was payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant could have elected to receive a lump-sum amount equal to the vested portion of the participant's account, or annual installments. Participants could have elected to rollover their vested balance to another qualified retirement plan or IRA. Immediate lump-sum distributions could have been made to terminated participants if the participant's vested account balance was \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance could have automatically rolled into an IRA unless otherwise elected. Withdrawals from the Plan could have been made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Participants could have also withdrawn an amount at age 59½ if certain criteria were met.

Plan Loans

Participants were able to borrow directly from Mutual of America a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested accrued benefit of the participant's balance. The participant was required to pledge sufficient collateral. The collateral of the loans must be maintained in their investment accounts.

The loans were not shown in the Plan's statements of net assets available for benefits, as the loans were not made from plan assets and were, therefore, not considered assets of the Plan. Loan interest rates were variable at prevailing interest rates and could have been increased or decreased by Mutual of America principal and interest was paid ratably by the participant directly to Mutual of America. A default charge could have been assessed against the portion of the loan collateral used to foreclose on all or part of any loan.

Loan balances outstanding to Mutual of America from the Plan's participants were \$19,759 and \$23,711 as of October 7, 2024 and December 31, 2023, respectively. There was \$0 and \$23,711 in loan collateral as of October 7, 2024 and December 31, 2023, respectively.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the participant-initiated transactions from participants were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net appreciation in fair value of investments.

2. Summary of Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Financial Reporting Requirement

Prior to January 1, 2009, Mutual of America maintained records at a contract level, not plan level, and administratively decided not to provide accounting records and supporting documentation at the participant or plan level relating to certain annuity and custodial accounts issued to current and former employees. As such, neither the Plan sponsor nor Mutual of America has been able to produce sufficient records and supporting documents relating to certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. As a result, the completeness and the accuracy of the annuity and custodial accounts, related investment income, and distributions related to these accounts, if any, could not be determined.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value with the exception of fully benefit-responsive investment contract. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determined the Plan's valuation policies utilizing information provided by its investment advisers, custodians, and insurance company. See Note 5 for discussion of fair value measurements.

See Note 6 for a discussion of the fully benefit-responsive investment contract valued at contract value.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits were recorded when paid.

3. Risk and Uncertainties

The Plan invested in various investment securities. These investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with

investment securities and the level of uncertainty related to changes in the value of investments, it was at least reasonably possible that changes in the values of investment securities could have occurred in the near term and that such changes could have materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Certified Investment Information

Certain information disclosed in the accompanying financial statements related to investments held at October 7, 2024 and December 31, 2023, and net appreciation in the fair value of investments, dividend and interest income for the period from January 1, 2024 through October 7, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America, a qualified institution.

5. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at October 7, 2024 or December 31, 2023.

Following is a description of the valuation methodology used for assets measured at fair value.

Pooled Separate Accounts (PSAs) - These assets are valued at their accumulation unit value (AUV), which approximates fair value. The AUV is determined daily based on the net asset value of shares of the underlying fund and the separate account charges (i.e., the daily asset charge). The net asset value (NAV), as provided is used as a practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. The Plan's investments in the PSAs may be redeemed daily. There were no redemption fees or notice periods and no unfunded commitments. These were direct filing entities.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of October 7, 2024 and December 31, 2023, the Plan held pooled separate accounts classified at NAV totaling \$0 and \$2,867,420, respectively.

6. Fully Benefit-Responsive Guaranteed Interest Contract

The Plan had a benefit-responsive guaranteed investment contract with Mutual of America. Mutual of America maintains the contributions in a general account. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Because the guaranteed investment contract was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Mutual of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment at contract value. There were no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. On October 7, 2024 the Fully Benefit-Responsive Guaranteed Interest Contract was transferred at full value along with the plans assets.

7. Party-in-Interest Transactions

Certain Plan investments were shares of funds managed by Mutual of America; therefore, these transactions qualify as party-in-interest transactions. Purchases and sales of these funds were open-market transactions at fair market value. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA and applicable exemptions promulgated thereunder.

8. Tax Status

Effective January 1, 2020, the Plan was restated to the adopted Prototype Non-Standardized 403(b) Plan (Prototype 403(b) Plan) sponsored by Mutual of America. The IRS ruled on March 31, 2017 that the Prototype 403(b) Plan qualifies under Section 403(b) of the IRC and, therefore, was not subject to tax under the present income tax law. The Plan was required to operate in conformity with the IRC to maintain its qualification. Although the Plan had been amended since the adoption of the Prototype 403(b) Plan, the Plan administrator believes that the Plan was designed and was operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not have been sustained upon examination by the IRS. The Plan was subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Plan Termination

The Company had the right under the Plan terms to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants' accounts would become fully vested and distributed in accordance with the provisions of the Plan. The Company did not exercise its right to terminate the Plan and, as noted in Note 1, the Plan was merged into the IGHL-CDD Plan, effective October 7, 2024.

10. Subsequent Events

The Plan's management has performed subsequent event procedures through October 15, 2025, the date the financial statements were available to be issued and there were no subsequent events requiring adjustments to the financial statements or disclosures stated therein.
