Independent Auditor's Report

To the Trustees and Participants of
California Frozen Food Industry Pension Trust Fund:

Opinion

We have audited the financial statements of California Frozen Food Industry Pension Trust Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits - in liquidation as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits - in liquidation for the years then ended, and the related notes to the financial statements - in liquidation.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits - in liquidation as of December 31, 2024 and the changes in net assets available for benefits - in liquidation for the year then ended of California Frozen Food Industry Pension Trust Fund in accordance with accounting principles generally accepted in the United States of America.

Qualified Opinion on the December 31, 2023 Financial Statements

In our opinion, except for the effects of the matter described in the Basis for Qualified Opinion, the net assets available for benefits - in liquidation as of December 31, 2023, and the changes in net assets available for benefits - in liquidation for the year then ended present fairly, in all material respects in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of California Frozen Food Industry Pension Trust Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion for the year ended December 31, 2024.

Basis for Qualified Opinion on the December 31, 2023 Financial Statements

As discussed in Note 5, the Plan's financial statements do not disclose information regarding the Plan's accumulated Plan benefits and the changes in accumulated Plan benefits as of and for the year ended December 31, 2023. In our opinion, presentation of that information is required to conform with accounting principles generally accepted in the United States of America. The Plan's actuary has not quantified the amount of, or change in, the Plan's accumulated plan benefits and, in the absence of an actuarial determination, these amounts and their effect on the financial statements are not reasonably determinable.

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of California Frozen Food Industry Pension Trust Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion for the year ended December 31, 2023.

Emphasis of Matter - Terminating Plan

As further discussed in Note 1 to the financial statements, the Board of Trustees approved to suspend the Plan effective July 1, 1989, and the Plan terminated as a result of the withdrawal of every contributing employer. As a result, in accordance with accounting principles generally accepted in the United States of America, these financial statements are presented using the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about California Frozen Food Industry Pension Trust Fund's ability to continue as a going concern for one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of the California Frozen Food Industry Pension Trust Fund (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

California Frozen Food Industry Pension Trust Fund was established on January 1, 1978, pursuant to a collective bargaining agreement by and between the International Brotherhood of Teamsters; Union Locals 865, 890 and 679; and certain employers in the food industry in California. The Plan adopted the California Frozen Food Industry Pension Plan effective July 1, 1977. During 1989, the Trustees approved suspension of the Plan, meaning that there will be no further benefit accruals. In addition, it was determined during 1990 that the Plan terminated by mass withdrawal of substantially all employers. In 1991, the Plan requested an opinion from the general counsel of the PBGC regarding whether the Plan experienced a mass withdrawal of substantially all employers in 1988. The general counsel's response was issued in 1994 and expressed no opinion as to whether a mass withdrawal occurred. On this basis, the Plan has revised and settled its mass withdrawal assessments against each employer on a case-by-case basis.

Contributions

During the years ended December 31, 2024 and 2023, no collective bargaining agreements required contributions to the Plan.

Pension Benefits

Pension and other benefits depend upon the hourly rate of employer contributions on behalf of a participant, the type of retirement for which the participant is eligible, the number of years of service with which the participant is credited, and whether the service was credited before or after the participant's employer began contributing to the Plan.

Normal Pension Benefits

A participant is eligible for a normal pension if they are a participant any time after reaching at least 65 years of age and completing two years of service (without an intervening permanent break in service and consequent forfeiture of benefits earned) since the date of their first covered hour. The participant may also be eligible if they are awarded a normal retirement benefit under Western Conference of Teamsters Pension Plan within five years after their unit contribution date. (The unit contribution date is the date on which contributions to this Plan began for the participant's bargaining unit.)

Early Retirement Pension Benefits

A participant is eligible for an early retirement pension if they are at least age 55 and (1) are fully vested in their pension (with at least 10 years of vesting service), or (2) have earned 10 years of credited service (exclusive of any forfeiture of credited service due to an intervening permanent break in service) and 3,000 covered hours. The participant may also be eligible if they are awarded an early retirement benefit under the Western Conference of Teamsters Pension Plan within five years after their unit contribution date. A participant must cease working in the frozen food industry in order to receive an early retirement pension.

Vesting

The Plan was suspended July 1, 1989. Because the Plan had an unfunded vested benefit liability as of that date, participants who were not vested on that date will not vest or become eligible for normal pension benefits.

2. Summary of Significant Accounting Policies

Liquidation Basis

The Board of Trustees suspended the Plan effective July 1, 1989, and the Plan terminated as a result of the withdrawal of every employer. Accordingly, the assets and liabilities of the Plan were revalued to the amounts expected to be collected and paid. Income and administrative expenses are recognized when earned or incurred, pension benefits are recorded when paid. An actuarial valuation was performed for the year ended December 31, 2019, and as discussed in Note 5, the Plan was instructed by the PBGC to complete the next actuarial valuation for the Plan year ended December 31, 2024. As the future administrative costs cannot be reasonably estimated, and the actuarial valuation is only performed every five years, the accrued costs and income through end of liquidation is not readily determinable. Any fluctuations in estimated revalued amounts are recognized in the period in which they occur.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The significant estimate affecting the financial statements is the Pension Benefit Guaranty Corporation Funding.

Advance Funding and Pension Benefit Guaranty Corporation Funding

PBGC funding includes amounts received from the Pension Benefit Guaranty Corporation (the "PBGC") for estimated benefits and administrative expenses and is received on a semiannual basis. Advance funding includes amounts received from the PBGC during the year for future estimated benefits and administrative expenses and are recorded as a liability.

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan and recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Other Receivables

Other receivables account primarily consists of benefit expenses that were paid to deceased pensioners and the overpayments are in the process of being collected. The Plan has established an estimated allowance for credit losses based on the Plan Administrator's knowledge of the industry and recommendations from the PBGC. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

Subsequent Events

Subsequent events were evaluated through October 9, 2025, the date the financial statements were available to be issued.

3. Plan Termination

As a result of the withdrawal of a substantial number of employers, the Trustees decided to suspend the Plan effective July 1, 1989. In 1990, the Plan terminated pursuant to Employee Retirement Income Security Act of 1974 ("ERISA") Section 4041A(a)(2) as the result of the withdrawal of every employer from the Plan. The rights of all affected participants and former participants who had not incurred a permanent break in service for benefits accrued to the date of the suspension were nonforfeitable to the extent funded as of such date.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

The PBGC guarantees vested benefits at the level in effect on the date of Plan termination or insolvency subject to the conditions described in the balance of this paragraph. If benefits have been increased within the five years before Plan termination or insolvency, the whole amount of the Plan's vested benefits or the benefit increase may not be guaranteed. In addition, there is a ceiling on the amount of monthly benefits guaranteed by the PBGC.

All assets, if any, remaining in the Plan after the payment of all expenses incurred in terminating or administering the Plan will be allocated to the benefit of employees, retired employees, surviving spouses and contingent beneficiaries, according to one of the following methods:

1. Subject to the provisions of applicable law, if the Plan receives notice from the PBGC that the assets held under the Plan are sufficient to discharge the obligations of the Plan as determined by the PBGC, then the Plan's assets shall be allocated to provide benefits on the basis of an actuarial study and report by a qualified actuary, to be designated by the Trustees, in accordance with applicable laws and regulations. Benefits with respect to a participant who has attained their normal retirement date will be distributed in the form of an immediate pension benefit. All other benefits will be in the form of a paid-up deferred pension with payments commencing on each participant's normal retirement date.
2. If the PBGC institutes proceedings to terminate the Plan, the PBGC will be responsible for determining the degree of insurance coverage, the priority of claims, and the distributions of assets and insurance proceeds to all claimants.

If, after the provisions of (1) have been applied, any balance remains in the Plan funds, such remaining balance shall be allocated among all participants in accordance with a non-discriminatory formula to be determined by the Trustees.

4. Tax Status

The IRS has determined and informed the Trustees by a letter dated May 6, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The Plan's management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; as of December 31, 2024 and 2023, the Plan is under audit by the Department of Labor.

5. Actuarial Present Value of Accumulated Plan Benefits

Effective July 1, 2019, the PBGC amended its reporting and disclosure information for multiemployer plans terminated by mass withdrawal. The amendments reduce administrative burden by allowing a Plan sponsor to perform an actuarial valuation every five years if the present value of the Plan's nonforfeitable benefits is \$50 million or less. In November 2020, the Plan was instructed by the PBGC to complete the next actuarial valuation for the year ended December 31, 2024. Accordingly, the accompanying financial statements do not include disclosure of the Plan's December 31, 2023, actuarial present value of accumulated Plan benefits required by accounting principles generally accepted in the United States of America. Prior to December 31, 2024, the Plan's most recent actuarial valuation was completed for the year ended December 31, 2019; the estimated present value of accumulated plan benefits as of December 31, 2019 was \$3,488,904.

The actuarial present value of accumulated plan benefits is determined by the Plan's independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.
