Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan of the Community Action Organization of Western New York, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Notes to Financial Statements

December 31, 2024 and 2023

1. DESCRIPTION OF PLAN:

The following description of the 403(b) Thrift Plan of the Community Action Organization of Western New York, Inc. provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

GENERAL

The Plan was established on May 1, 2004, and is sponsored by the Community Action Organization of Western New York, Inc. (the Organization). The Plan is a contributory defined contribution plan which covers substantially all employees of the Organization. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The audit, finance and pension committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Organization's board of directors.

ELIGIBILITY

Employees become eligible to participate in the Plan immediately following employment. Employees become eligible to participate in base and matching contributions from the Organization upon attainment of 21 years of age and completion of 1,000 hours during a 12-month period following the participant's date of hire. Employees are automatically enrolled in the Plan at the time they become eligible, unless they submit a signed form to opt out of participation.

CONTRIBUTIONS

Contributions to the Plan are made by the participants through salary reductions and by the Organization through base and matching contributions. Participants may elect to contribute a specific percentage of their compensation, subject to certain limitations under Section 403(b) and 415 of the Internal Revenue Code. Participants who are age 50 and over are able to elect to contribute an additional amount as a catch-up contribution allowed under Section 414(v). Base contributions to the Plan are made by the Organization in an amount equal to 3% of participant compensation. Matching contributions to the Plan are made by the Organization in an amount equal to 25% of the participant's compensation reduction up to a maximum match of 1% of the participant's compensation.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and Organization's matching and base contributions, and Plan earnings and charged with an allocation of administrative expenses that are paid from the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are vested immediately in their contributions and actual earnings thereon.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 2% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

PAYMENT OF BENEFITS

Upon termination of service due to death, disability, retirement, or obtaining age 59 1/2 participants may request lump-sum cash distributions from their retirement account. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for hardship purposes.

2. SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

ESTIMATES

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments generally are reported at fair value, but may also be reported at contract value or cost. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion of fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

2. SIGNIFICANT ACCOUNTING POLICIES, continued:

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

In 2024 and 2023, the necessary expenses to administer the Plan were paid primarily by the Organization. Expenses paid by the Plan included participant charges. Investment related expenses are included in net appreciation in fair value of investments in the accompanying statements of changes in net assets available for benefits.

RECLASSIFICATION

Certain amounts in the 2023 financial statements have been reclassified to conform to current year presentation.

3. INFORMATION CERTIFIED BY QUALIFIED INSTITUTIONS:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information disclosed in the accompanying financial statements and ERISA-required supplemental schedule as of and for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc. (LFG) and Mutual of America Life Insurance Company (MoA) (the custodians and qualified institutions).

4. FAIR VALUE MEASUREMENTS:

The Fair Value Measurements and Disclosure topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

Level 1 Fair Value Measurements

Mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The carrying value of interest-bearing cash approximates fair value due to its short-term nature and liquidity.

Level 2 Fair Value Measurements

Pooled separate accounts are invested in mutual funds. The underlying investments are generally valued using market quotations obtained from independent pricing services.

5. FULLY-BENEFIT RESPONSIVE TRADITIONAL INVESTMENT CONTRACT

The Plan holds a fully benefit-responsive investment contract with Lincoln Life & Annuity Company of New York (LLAC-NY or Issuer) that is reported at contract value. The contract value of the contract as of December 31, 2024 and 2023, was \$3,600,103 and \$3,335,862, respectively. LLAC-NY maintains the contributions in its general account. The account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the Issuer or otherwise.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Issuer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the Issuer's ability to meet its financial obligations. The Issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the Issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the Issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the Issuer.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. TAX STATUS:

The Plan has adopted a prototype plan document sponsored by CCH Incorporated, DBA ftwilliam.com. The prototype plan document has obtained an opinion letter from the Internal Revenue Service dated March 31, 2017, in which it states that the prototype plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is operating in compliance with the applicable requirements of the Internal Revenue Code.

An operational failure was identified wherein certain participants did not receive an automatic increase in salary deferrals in accordance with the plan document. The Organization is making corrective contributions in the amount of \$49,956 during 2025 to bring the Plan into compliance with its plan document. The Plan administrator and Plan's counsel, therefore, believe that the Plan will remain qualified.

8. PARTIES-IN-INTEREST:

Certain investments for the Plan are funds managed by LFG and MoA. LFG and MoA are custodians or issuers, and recordkeepers for the Plan; therefore, these transactions qualify as party-in-interest transactions.

Direct fees of \$85,181 and \$1,638 were paid to LFG and MoA, respectively, by the Plan for recordkeeping and investment management services for the year ended December 31, 2024. Direct fees of \$6,429 were paid to MoA by the Plan for recordkeeping and investment management services for the year ended December 31, 2023.

9. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through October 15, 2025, which represents the date the financial statements were available to be issued. Subsequent events after that date have not been evaluated.
