Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Brookline Bancorp, Inc. 401(k) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Brookline Bancorp, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

1. Description of Plan

The following brief description of the Brookline Bancorp 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan was established for the benefit of the employees of Bank Rhode Island (the “Bank”), effective May 1, 1996. Bank Rhode Island was acquired by Brookline Bancorp, Inc. (the “Parent”) in 2011. Effective January 1, 2015, the Parent’s 401(k) Plan merged into the Bank’s 401(k) Plan, with the merged plan renamed Brookline Bancorp 401(k) Plan. Accordingly, all assets are managed by a single trustee who has assumed all administrative duties for the Brookline Bancorp 401(k) Plan participant balances. In accordance with the Internal Revenue Service (“IRS”) Cycle 3 restatement requirement, the Plan was restated effective May 27, 2021.

The Plan is a defined contribution plan covering all eligible employees of Brookline Bancorp, Inc. and its subsidiaries (“Plan Sponsor”). Employees who elect to contribute to the Plan must meet the service requirements of the Plan, as explained below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is administered by the Parent and the assets of the Plan are held and invested by Fidelity Management Trust Company (the “Trustee”).

Eligibility

Employees who are 21 years of age are eligible to participate in the Plan on the first day of the month following the date the eligibility requirements are satisfied. Effective January 1, 2015, the Plan implemented an auto enrollment feature that will result in eligible participants being enrolled in the Plan three months after meeting the eligibility requirements with a deferral rate of 3% of pretax annual compensation unless another option is elected by the participant.

Contributions

Each year, participants may contribute up to 75% of their eligible compensation, as defined by the Plan, not to exceed annual limitations as provided by the Internal Revenue Code (“IRC”), on a pre-tax or after-tax (Roth) basis. Participants may contribute amounts representing distributions from other qualified plans (rollover contributions). The Plan also provides for participant catch-up contributions.

Brookline Bancorp, Inc. (the “Plan Sponsor”) matches, under safe harbor provisions, participant contributions equal to 100% of each participant’s contributions, up to a maximum of 5% of the participant’s eligible compensation. The Plan also allows for the Plan Sponsor to make discretionary employer contributions. No such discretionary employer matching contributions were made during the year ended December 31, 2024.

1. Description of Plan (*continued*)

Participant Accounts

Each participant's account is credited with the participant's contributions, the corresponding employer matching contribution and an allocation of Plan earnings. Allocations are based upon account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting for employer safe harbor and discretionary contributions and associated earnings is immediate upon entering the Plan.

Payment of Benefits

Upon retirement of service, disability, or termination of employment, a participant may elect to receive a lump sum distribution or payment in various forms of installment payments of his/her account. In the event of death, benefits are payable to the participant's surviving spouse or designated beneficiary. Participants are entitled to receive distributions if a financial hardship exists. Financial hardship means an immediate financial need of a participant to meet extraordinary and emergency expenses.

Plan Expenses

The Plan Sponsor and the Plan participants share in Plan expenses. Certain Plan expenses are deducted from participants' accounts or investment income.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate equal to prime rate plus 1% at the date of loan issuance. Loans are repayable over a period of up to five years, unless used for the purchase of a primary residence. Principal and interest are paid ratably through weekly or bi-weekly payroll deductions depending upon the participating employee's payroll cycle.

Forfeitures

Under the Parent's pre-merger employee benefit plan, employer matching and profit sharing contributions had a three-year cliff vesting schedule. Upon merger of the plans, all nonvested accounts for participants not employed by the Parent at January 1, 2015 were forfeited and maintained in separate non-vested forfeiture accounts within the Plan. Forfeited nonvested accounts may be used to reduce administrative expenses. Forfeitures of \$0 were used to reduce Plan Sponsor contributions or pay administrative expenses for the year ended December 31, 2024. At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$24,469 and \$22,232.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

2. Summary of Significant Accounting Policies *(continued)*

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Common stock in the brokerage account is valued at the daily closing price as reported by the major exchange upon which the stock is traded. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are deemed to be actively traded. These mutual funds are required to publish their daily net asset value and to transact at that price. The common/collective trust is valued at the NAV, as provided by the trustee, which is used as a practical expedient based on the fund's underlying investments and as a result is not categorized within the fair value hierarchy. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of the Plan are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 13, 2025.

Berkshire Hills Bancorp and Brookline Bancorp have merged to form a new entity named Beacon Financial Corporation, which will operate as Beacon Bank. The merger was formalized in August 2025.

5. Common/Collective Trust

The Galliard Stable Return Fund M (“Galliard”) is a common/collective trust. The Fund primarily invests in investment contracts, including security-backed contracts issued by insurance companies and other financial institutions.

The Galliard Fund is designed to pay all permitted unitholder-initiated transactions at NAV. Permitted unitholder-initiated transactions are those transactions allowed by the underlying defined contribution plans (typically this would include withdrawals for benefits, loans, or transfers to non-competing portfolios within the Plan) excluding certain withdrawals that are deemed to be caused by the actions of the Plan Sponsor. The wrap contracts limit the ability of the Galliard Fund to transact at NAV upon the occurrence of certain Plan Sponsor events. These events include: the Plan’s failure to qualify under Section 401(a) or Section 401(k) of the IRC; the establishment of a defined contribution plan that competes with the Plan for employee contributions; any substantive modification of the Galliard Fund or the administration of the Galliard Fund that is not consented to by the wrap issuer; any change in law, regulation or administrative ruling applicable to the Plan that could have a material adverse effect on the Galliard Fund’s cash flow; any communication given to unitholders by the Plan Sponsor, any other Plan fiduciary that is designed to induce or influence unitholders not to invest in the portfolio or to transfer assets out of the portfolio; any transfer of assets from the portfolio directly to a competing investment option.

NAV per unit is determined each business day. Issues and redemptions of units are recorded, upon receipt of unitholder’s instructions in good order, based on the next determined NAV per unit normally each day. In unusual market conditions, the trustee may impose restrictions on issues and redemptions of units. The Plan has no unfunded commitments to Galliard Fund at December 31, 2024 and 2023.

6. Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

7. Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by the Trustee, as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits. Additionally, certain investment offerings of the Plan pay a quarterly revenue credit to participants holding such investments, with such credit reported as other additions in the accompanying statement of changes in net assets available for benefits.

8. Tax Status

The IRS has determined and informed the prototype plan document preparer by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The plan administrator believes the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

9. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

1. Description of Plan

The following brief description of the Brookline Bancorp 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan was established for the benefit of the employees of Bank Rhode Island (the “Bank”), effective May 1, 1996. Bank Rhode Island was acquired by Brookline Bancorp, Inc. (the “Parent”) in 2011. Effective January 1, 2015, the Parent’s 401(k) Plan merged into the Bank’s 401(k) Plan, with the merged plan renamed Brookline Bancorp 401(k) Plan. Accordingly, all assets are managed by a single trustee who has assumed all administrative duties for the Brookline Bancorp 401(k) Plan participant balances. In accordance with the Internal Revenue Service (“IRS”) Cycle 3 restatement requirement, the Plan was restated effective May 27, 2021.

The Plan is a defined contribution plan covering all eligible employees of Brookline Bancorp, Inc. and its subsidiaries (“Plan Sponsor”). Employees who elect to contribute to the Plan must meet the service requirements of the Plan, as explained below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is administered by the Parent and the assets of the Plan are held and invested by Fidelity Management Trust Company (the “Trustee”).

Eligibility

Employees who are 21 years of age are eligible to participate in the Plan on the first day of the month following the date the eligibility requirements are satisfied. Effective January 1, 2015, the Plan implemented an auto enrollment feature that will result in eligible participants being enrolled in the Plan three months after meeting the eligibility requirements with a deferral rate of 3% of pretax annual compensation unless another option is elected by the participant.

Contributions

Each year, participants may contribute up to 75% of their eligible compensation, as defined by the Plan, not to exceed annual limitations as provided by the Internal Revenue Code (“IRC”), on a pre-tax or after-tax (Roth) basis. Participants may contribute amounts representing distributions from other qualified plans (rollover contributions). The Plan also provides for participant catch-up contributions.

Brookline Bancorp, Inc. (the “Plan Sponsor”) matches, under safe harbor provisions, participant contributions equal to 100% of each participant’s contributions, up to a maximum of 5% of the participant’s eligible compensation. The Plan also allows for the Plan Sponsor to make discretionary employer contributions. No such discretionary employer matching contributions were made during the year ended December 31, 2024.

1. Description of Plan (*continued*)

Participant Accounts

Each participant's account is credited with the participant's contributions, the corresponding employer matching contribution and an allocation of Plan earnings. Allocations are based upon account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting for employer safe harbor and discretionary contributions and associated earnings is immediate upon entering the Plan.

Payment of Benefits

Upon retirement of service, disability, or termination of employment, a participant may elect to receive a lump sum distribution or payment in various forms of installment payments of his/her account. In the event of death, benefits are payable to the participant's surviving spouse or designated beneficiary. Participants are entitled to receive distributions if a financial hardship exists. Financial hardship means an immediate financial need of a participant to meet extraordinary and emergency expenses.

Plan Expenses

The Plan Sponsor and the Plan participants share in Plan expenses. Certain Plan expenses are deducted from participants' accounts or investment income.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate equal to prime rate plus 1% at the date of loan issuance. Loans are repayable over a period of up to five years, unless used for the purchase of a primary residence. Principal and interest are paid ratably through weekly or bi-weekly payroll deductions depending upon the participating employee's payroll cycle.

Forfeitures

Under the Parent's pre-merger employee benefit plan, employer matching and profit sharing contributions had a three-year cliff vesting schedule. Upon merger of the plans, all nonvested accounts for participants not employed by the Parent at January 1, 2015 were forfeited and maintained in separate non-vested forfeiture accounts within the Plan. Forfeited nonvested accounts may be used to reduce administrative expenses. Forfeitures of \$0 were used to reduce Plan Sponsor contributions or pay administrative expenses for the year ended December 31, 2024. At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$24,469 and \$22,232.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Common stock in the brokerage account is valued at the daily closing price as reported by the major exchange upon which the stock is traded. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are deemed to be actively traded. These mutual funds are required to publish their daily net asset value and to transact at that price. The common/collective trust is valued at the NAV, as provided by the trustee, which is used as a practical expedient based on the fund's underlying investments and as a result is not categorized within the fair value hierarchy. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of the Plan are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 13, 2025.

Berkshire Hills Bancorp and Brookline Bancorp have merged to form a new entity named Beacon Financial Corporation, which will operate as Beacon Bank. The merger was formalized in August 2025.

5. Common/Collective Trust

The Galliard Stable Return Fund M (“Galliard”) is a common/collective trust. The Fund primarily invests in investment contracts, including security-backed contracts issued by insurance companies and other financial institutions.

The Galliard Fund is designed to pay all permitted unitholder-initiated transactions at NAV. Permitted unitholder-initiated transactions are those transactions allowed by the underlying defined contribution plans (typically this would include withdrawals for benefits, loans, or transfers to non-competing portfolios within the Plan) excluding certain withdrawals that are deemed to be caused by the actions of the Plan Sponsor. The wrap contracts limit the ability of the Galliard Fund to transact at NAV upon the occurrence of certain Plan Sponsor events. These events include: the Plan’s failure to qualify under Section 401(a) or Section 401(k) of the IRC; the establishment of a defined contribution plan that competes with the Plan for employee contributions; any substantive modification of the Galliard Fund or the administration of the Galliard Fund that is not consented to by the wrap issuer; any change in law, regulation or administrative ruling applicable to the Plan that could have a material adverse effect on the Galliard Fund’s cash flow; any communication given to unitholders by the Plan Sponsor, any other Plan fiduciary that is designed to induce or influence unitholders not to invest in the portfolio or to transfer assets out of the portfolio; any transfer of assets from the portfolio directly to a competing investment option.

NAV per unit is determined each business day. Issues and redemptions of units are recorded, upon receipt of unitholder’s instructions in good order, based on the next determined NAV per unit normally each day. In unusual market conditions, the trustee may impose restrictions on issues and redemptions of units. The Plan has no unfunded commitments to Galliard Fund at December 31, 2024 and 2023.

6. Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

7. Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by the Trustee, as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits. Additionally, certain investment offerings of the Plan pay a quarterly revenue credit to participants holding such investments, with such credit reported as other additions in the accompanying statement of changes in net assets available for benefits.

8. Tax Status

The IRS has determined and informed the prototype plan document preparer by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The plan administrator believes the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

9. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
