### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Frontier Logistical Services, LLC 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Note 1 - Description of Plan

The following description of Frontier Logistical Services, LLC 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, which are available from the plan administrator.

#### General

The Plan is a defined contribution retirement plan sponsored by Frontier Logistical Services, LLC (the "Company") for the benefit of its employees who are age twenty-one (21) or older and have completed three (3) months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Participants may contribute up to eighty percent (80%) of their annual eligible compensation, subject to Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants may also make Roth contributions to the Plan. Eligible employees are automatically enrolled in the Plan at a one percent (1%) contribution rate unless the employee elects otherwise.

The Plan is a safe harbor plan, as defined by the IRC, and requires a safe harbor matching contribution of one hundred percent (100%) of eligible employees' elective deferrals up to five percent (5%) of such employees' eligible compensation. The Company may also make qualified non-elective contributions to the Plan. There were no qualified non-elective contributions in 2024 or 2023.

#### Participant investment account options

The Plan allows participants to direct varying portions of their contributions and account balances among different investment options held by Reliance Trust Company, which includes a diversified selection of mutual funds and common/collective trust funds.

#### Participant accounts

Each participant's account is credited with the participant's contribution and the Company's safe harbor matching contributions and qualified non-elective contributions, if any, plus a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting in the Company's qualified non-elective contributions is based on a three year cliff, where participants are zero percent (0%) vested until three (3) years of credited service. In the event of death, disability, normal retirement age (65), or if the Plan is discontinued, participants become 100% vested in all account balances.

#### Payment of benefits

Upon termination of service for any reason, a participant may request the value of his or her account as a lump sum distribution or installments over a period of time as defined by the plan document. Withdrawals by a participant while still employed are limited to those requested due to events of financial hardship as defined by the plan document or upon the attainment of age 59½. Participants may also request in-service distributions from rollover accounts at any time.

#### Forfeited accounts

If an employee terminates before his or her Company non-elective contribution accounts have become fully vested, such portion of the account is forfeited. Forfeitures may be used to pay plan expenses or reduce any future employer contributions.

### Note 2 - Summary of significant accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

#### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

#### Investment valuation and income recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of benefits

Benefits are recorded when paid.

#### Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of benefits paid to participants are charged directly to the respective participant's account. Certain investment related expenses are included in the net appreciation in fair value of investments.

#### Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### Note 3 - Information prepared and certified by the trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee for the Plan, has certified that the following data included in the accompanying financial statements and the schedule of assets (held at end of year) is complete and accurate:

- Investments at fair value
- Net appreciation in fair value of investments
- Dividend income
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the schedule of assets (held at end of year).

### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described below.

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust funds:* Valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common/collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations will be carried out in an orderly business manner.

*Stable value common collective trust funds:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

### Note 5 - Related party transactions and party-in-interest transactions

Plan investments are held by Reliance Trust Company, the trustee as defined by the Plan. These investments and related investment transactions qualify as party-in-interest transactions. ADP Retirement Services is the Plan's recordkeeper and therefore related transactions also qualify as party-in-interest transactions. The Plan made direct payments to parties-in-interest totaling \$7,457 and \$2,070 in 2024 and 2023, respectively. Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The plan sponsor pays directly any other fees related to the Plan's operations.

### Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Effective November 1, 2024, the plan sponsor was acquired by another company. As of such date, contributions to the Plan ceased.

### Note 7 - Tax status

The IRS has determined that the Volume Submitter Profit Sharing 401(k) Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and informed the recordkeeper of such in a letter dated October 6, 2020. The plan administrator has adopted the prototype plan and believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### Note 8 - Concentrations, risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that

changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2024 and 2023, approximately 20% and 23% of the Plan's investments were invested in the T. Rowe Price Retirement 2030 Fund, respectively. As of December 31, 2024, approximately 16% of the Plan's investments were invested in the T. Rowe Price Growth Stock Fund.

### Note 9 - Subsequent events

Plan management has evaluated subsequent events through October 3, 2025, which is the date that the financial statements were available to be issued. No significant matters were identified for disclosure.
