December 31, 2024

1. Description of the Plan

The following brief description of the Onto Innovation, Inc. 401(k) Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for complete information regarding the Plan's definitions, benefits, eligibility, and other matters.

General

The Plan is a defined contribution plan available to all eligible employees of Onto Innovation, Inc. (the Company). A full-time employee is eligible to participate in the Plan immediately upon hire, and part-time employees become eligible upon completion of required service hours.

The Onto Innovation, Inc. 401(k) Savings Plan Committee (the Committee) is responsible for the general administration of the Plan. Fidelity Management Trust Company (Fidelity) is the trustee and recordkeeper for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Investments

The Committee periodically reviews and may make changes to investment options for participants. Participants may invest in various stock and bond mutual funds, a money market fund and a common collective trust.

Contributions

Participants may contribute up to the lesser of 90% of eligible compensation with a maximum of \$23,000 in 2024 or \$22,500 in 2023. Participants who have attained age 50 during the year are eligible to make catch-up contributions up to \$7,500 in 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions).

The Company provided a 50% discretionary match of all employee contributions up to 6% of the employee's salary during 2024 and 2023, as defined in the Plan Document. In addition, the Company may make additional discretionary contributions to the Plan each year. The Company made no additional discretionary contributions during 2024 or 2023. All contributions are subject to certain limitations of the Internal Revenue Code (the Code).

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. If a participant is automatically enrolled, the participant's contributions are invested in Fidelity's Freedom Funds until the participant changes his or her election. The Company's contributions are allocated in the same manner as that of the participant's elective contributions.

Participant Loans

The Plan allows participants to borrow from the Plan against their individual account balances in accordance with the Plan's provisions. The minimum amount participants may borrow is \$1,000, and the maximum amount is one-half of the value of the participant's vested account balance up to \$50,000. The participant pays a loan initiation fee and a required minimum distribution fee, if applicable.

The rate of interest is one percentage point more than the prime rate as reported by Thomson Reuters as of the first business day of the month in which the loan is made and is fixed over the term of the loan. Principal and interest are to be repaid via payroll deductions in substantially equal payments, no less than quarterly. The term of the loan cannot exceed five years, except in the case where the loan is used to acquire a principal residence, in which case the term of the loan can extend to ten years. A participant may not have more than one loan outstanding at any point in time. Interest rates for 2024 ranged 4.25%–9.5% and 2023 ranged from 4.00% –10.5% with ending maturity dates through 2025 and 2033, respectively.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service. Employer discretionary matching and other discretionary contributions vest as follows:

Forfeitures

Participants terminating employment for any reason other than retirement, death, or disability will forfeit their non-vested interest in Company discretionary matching and other discretionary contributions. Such forfeited amounts may be used to reduce future matching contributions. Unallocated forfeitures balances of \$159,115 and \$91,922 were utilized to reduce employer matching contributions for the years ended December 31, 2024 and 2023, respectively. The remaining balance in the forfeiture account was \$168,396 and \$56,977 at December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of the Company's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided for by the participant's vested account.

Payment of Benefits

Upon separation from service with the Company due to death, disability, retirement, or termination, a participant whose vested account balance exceeds \$1,000 may elect to receive either a lump-sum distribution or a direct rollover distribution into another IRA or eligible retirement plan. A participant whose vested account balance is \$1,000 or less will automatically receive an immediate lump-sum distribution equal to the participant's vested account balance. In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS), and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

1. Description of the Plan (continued)

Administrative Expenses

The Plan's administrative expenses may be passed through to the participants of the Plan, as provided by the Plan's provisions. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate, including consulting service fees paid through Fidelity to Ameriprise Financial Services, Inc., and are included in net appreciation or depreciation of fair value of investments in the statements of changes in net assets available for benefits.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

2. Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in money market instruments and stock and bond mutual funds are stated at fair value, as determined by quoted market prices.

The Fidelity Advisor Stable Value Portfolio is a common collective trust that invests in fully benefit-responsive investment contracts. This investment is recorded at fair value, as quoted by the issuer.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

3. Information Certified by the Trustee

Certain investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based the lowest level of input that is significant to the fair value measurement in its entirety.

4. Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Stock and bond mutual funds, and money market funds: Valued at quoted market prices.

Common collective trust: Valued using the NAV, which is determined daily, published, and is the basis for current transactions with the fund's investment manager or issuer.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. 5. Tax Status

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Services (IRS), dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Internal Code and, therefore, the related trust is tax-exempt. The plan administrator has determined that it is eligible to, and has chosen to, rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Party-In-Interest Transactions

The Plan holds units of mutual funds, money market accounts, and common collective trust funds managed by Fidelity, the trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

9. Subsequent Events

The Plan evaluated these financial statements for subsequent events through October 15, 2025, the date the financial statements were available to be issued.
