INDEPENDENT AUDITORS' REPORT

To the Trustees of
the Invisors, LLC 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Invisors, LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS**

A. DESCRIPTION OF PLAN

The following description of the Invisors, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan sponsor is Invisors, LLC (the "Employer"). The Plan is a defined contribution plan covering substantially all employees of the Employer who have completed three consecutive months of service and are age twenty one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Board of Trustees determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Plan Amendment

Effective March 4, 2024, the Plan had a restatement of the previously-adopted plan as a result of the change in platforms used under John Hancock. There were no other significant changes in the plan as a result of this restatement.

Contributions

For 2024, participants elected to contribute as little as 0% or as much as 100% of pretax annual compensation up to the annual IRS maximum 401(k) deferral limit of \$23,000 in 2024. Participants ages 50 or over were permitted up to an additional \$7,500 pretax contribution as "Employee Catch-up Contributions". The Plan allows for contributions to be made as Roth contributions. These contributions are made in the same manner as the pretax contributions except that Roth contributions are made to the Plan on an after-tax basis. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans (rollover).

The Employer elected to adopt safe harbor provisions for the Plan wherein the Employer matches participant contributions at a rate of 100% of the first 3% of the participant's salary contributed to the Plan and 50% of the next 2% of the participant's salary contributed to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. These safe harbor contributions are 100% vested. During the year ended December 31, 2024, the Employer made safe harbor matching contributions totaling \$1,272,533. The Employer may also make profit sharing contributions for participants who have completed at least 1,000 hours of service during the plan year and are employed by the Employer on the last day of the plan year. During the year ended December 31, 2024, no such profit sharing contributions were made to the Plan.

Participants may direct the investments of their contributions in one percentage point increments into the various investment options offered by the Plan. Participants can change investment options daily.

A. DESCRIPTION OF PLAN (CONTINUED)

Participant's Accounts

Each participant's account is credited with the participant's contribution, rollover contributions, the allocation of the Employer's contribution, the allocation of the profit sharing contribution, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant's earnings or accounts balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their elective deferral account, rollover contribution account, qualified non-elective contribution accounts, safe harbor matching contribution account and profit sharing contribution account.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or partial withdrawals or installments, but only with respect to participant or designated beneficiary who must receive minimum required distribution, over a period of not more than the assumed life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum or have them directly rolled over into another qualified plan or an Individual Retirement Account.

Hardship Withdrawals

The Plan allows for withdrawals due to financial hardship. A hardship distribution may only be made for payment of the following:

- expenses for medical care (described in Section 213(d) of the Internal Revenue Code) previously incurred by the participant or his/her spouse, dependents or beneficiaries to obtain medical care.
- costs directly related to the purchase of the participant's principal residence (excluding mortgage payments).
- tuition, related educational fees, and room and board expenses for the next twelve (12) months of post-secondary education for the participant or his/her spouse, dependents or beneficiaries.
- amounts necessary to prevent eviction from the participant's principal residence or foreclosure on the mortgage of the participant's principal residence.
- payments for burial or funeral expenses for the participant's deceased parent, spouse, children, other dependents or beneficiaries.
- expenses for the repair of damage to the participant's principal residence that would qualify for the casualty deduction under the Internal Revenue Code.
- expenses for disasters arising from federally declared disasters, such as participant expenses and losses (including loss of income) attributable to that disaster, provided your principal residence or place of employment was in an area FEMA designates as qualifying for individual assistance.

A. DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow the lesser of 50% of their vested account balance or \$50,000, (reduced by the highest outstanding loan balance, if any, during the one-year period ending on the day before the new loan is made). The minimum loan amount is \$1,000. Notes are secured by the balance in the participant's account and bear interest at an agreed-upon percentage based on prevailing market rates. Principal and interest is paid ratably through payroll deductions.

Rollovers

Rollovers represent transfer of eligible cash distributions from any other qualified plan through a direct transfer from such plan.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of significant accounting policies followed by the Plan.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Plan Year

The effective date of the Plan was January 1, 2018 and the Plan reports on a calendar year basis. The Board of Directors of the Employer established the Plan.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investment includes the Plan's gains and losses on investment bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. There were no delinquent notes receivable that needed to be reclassified during 2024.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Administration of Plan Assets

At the start of the fiscal year, the Employer and participants' contributions were managed and held by the recordkeeper, John Hancock Life Insurance Company, who invested the contributions and actual earnings as directed by the participants. John Hancock Life Insurance Company also administered the payment of interest and principal on loans granted to a participant. Participants made loan repayments to the Employer, who then forwarded them to John Hancock.

Effective March 4, 2024, the Plan engaged a new recordkeeper and administrator, John Hancock Trust Company LLC ("John Hancock"). John Hancock invests the contributions and actual earnings as directed by the participant. John Hancock also administers the payment of interest and principal on loans granted to a participant. The participant makes loan repayments to the Employer, which then forwards them to John Hancock.

Certain administrative and Trustee functions are performed by officers or employees of Invisors, LLC who received no compensation from the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Mutual fund transaction costs are charged to the Plan and allocated among the participants based on their respective account value to the total Plan assets.

Date of Management Review

The Plan has evaluated subsequent events through October 15, 2025, which is the date that the financial statements were available to be issued.

C. FAIR VALUE MEASUREMENTS

Accounting Standard Codification (ASC) 820, *Fair Value Measurement*, defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Topic 820 also specifies a fair value hierarchy which requires a Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

C. FAIR VALUE MEASUREMENTS (continued)

The standard describes three levels of inputs that may be used to measure fair value.

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset's and liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is the description of the valuation methodologies and inputs used for assets and liabilities measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets and liabilities pursuant to the valuation hierarchy.

Effective March 4, 2024, the Plan's investments were converted from separate pooled subaccounts to investments in registered investment companies (e.g. mutual funds), as held by the new Trustee, John Hancock. Mutual funds are valued at the daily closing price as reported by the fund. The mutual funds are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Prior to the Plan Amendment and change from the former recordkeeper to the new Trustee during 2024, the Plan held investments in John Hancock Life Insurance Company subaccounts. Investments in John Hancock Life Insurance Company subaccounts were invested in the underlying investment (i.e., mutual funds, collective investment trust, or exchange-traded fund) on behalf of the participants. The valuation technique used to measure fair value of these subaccounts is by a "unit value," whose value is the result of the market value of the underlying investment. The Plan's subaccount investments were valued at Level 2 because the quoted market prices at per unit value are not available. The value of these investments is calculated daily by the fund administrator. Its value is determined by taking the market value of the total underlying investments in the subaccount and dividing it by the number of units held in the subaccount. As of December 31, 2024, the Plan's investments are held in mutual fund accounts that are deemed to be Level 1 investments.

D. RISK AND UNCERTAINTIES

The Plan invests in various investment securities, primarily mutual funds. Investment securities are exposed to various risks, such as interest rates, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in risks, it is reasonably possible that in the near term these uncertainties would materially affect balances and the amounts reported in the statements of plan net assets available for benefits and the statement of changes in net assets available for benefits.

E. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

F. TAX STATUS

The underlying volume submitter plan has received an opinion letter from the IRS dated June 30, 2020 stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS volume submitter plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the opinion, the Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024, the Plan does not believe that it has taken any tax position that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would increase or decrease within the next twelve months. The Plan's federal tax returns are currently open for examination by the Internal Revenue Service and applicable state authorities. Statutes of limitation generally range from three to five years.

G. RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds or units of pooled separate accounts managed by John Hancock. John Hancock is the recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest. During the year ended December 31, 2024, fees paid by the Plan for record keeping services amounted to \$33,409.

During the fiscal year ended December 31, 2024, the Plan received a contribution of \$10,450 from the Employer for audit fees.

H. CERTIFIED FINANCIAL DATA

All financial information contained in the Statements of Net Assets Available for Benefits and the Statement of Changes in Nets Assets Available for Benefits regarding investments and investment income has been certified by John Hancock Life Insurance Company, recordkeeper as an agent for the trustees, and John Hancock Trust Company LLC, as record keeping and trustee, as complete and accurate in accordance with Regulation 2520.103-5 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Act of 1974.
