Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note A – Description of the Plan

The following description of the OpTech, LLC 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a 401(k) profit-sharing plan covering essentially all full-time employees of OpTech, LLC, OpTech Solutions, LLC, and GTech Services, LLC (collectively referred to as the “Company”), meeting all age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to the statutory deferral limit, the employer-provided limit, and the average ADP test limit, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The amount of the participant’s deferred compensation is treated as a participant elective contribution, allocated to that participant’s elective account, and is 100 percent vested at the time of contribution. Any portion of this contribution can be elected by the participant as a Roth contribution. The Company may contribute a discretionary percentage, as determined annually, to the Plan each year. The employer may also make a discretionary profit-sharing contribution, to be determined by the Company annually. Contributions are subject to certain IRS limitations.

The Plan includes an automatic salary deferral feature. The automatic deferral provisions apply to all participants except who have a salary deferral agreement in place on the automatic deferral effective date. Participants have the option of receiving a refund of their deferral within 90 days of the first automatic deferral providing notification to the employer within a reasonable time period prior to the end of the 90-day period.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, Company discretionary matching contributions, Company discretionary profit-sharing contributions, as well as allocations of Plan earnings and forfeitures; and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants have no vested interest in the Company contributions until they have completed one year of service, at which time they become 20 percent vested. Vesting increases by 20 percent each year. A participant is 100 percent vested after five years of credited service and plan participation. An employee is considered to have completed one year of service for purposes of vesting upon the completion of 1,000 hours of service at any time during a plan year.

Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of 50 percent of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account. The loan interest rate is set at a rate that commensurate with local prevailing rates as determined by the plan administrator. The term of such loans may not exceed five years, except in the case of a loan for the purchase of a principal residence which may not exceed thirty-nine years. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive either a lump-sum or payments over a certain period in the amount equal to the value of the participant's vested interest in his or her account. If the participants vested balance is less than or equal to \$5,000, the entire sum will be distributed as soon as possible following the participant's separation from service.

Forfeitures

Forfeitures may be allocated to offset contributions or fees at the discretion of the Company.

Note B – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year. See Note H for the discussion of fair value measurements.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

The participant accounts absorb the costs to administer the Plan. These costs are charged as reasonable statement fees allocated pro rata based on their account balances.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Subsequent Events

Subsequent events have been evaluated through September 22, 2025, which is the date the financial statements were available to be issued, and no issues have come to our attention that would require recognition.

Note C – Tax Status

The Plan adopted a volume submitter plan document on April 10, 2014. A determination letter, in which the Internal Revenue Service states that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC), was obtained. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's third party administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan is no longer subject to income tax examinations for years prior to 2021.

Note D – Information Certified by the Custodian (Unaudited)

At December 31, 2024 and 2023, the Plan's investments were held and certified by the custodian, Fidelity Management Trust Company ("Fidelity"). The following is a list of the Plan's financial information that is included in the financial statements based on information certified by the custodian as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974:

- Total investments and participant notes receivable as shown in the Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Net investment income (loss) as shown in the Statement of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023.
- Assets as shown in the Schedule of Assets Held for Investment at End of Year as of December 31, 2024.
- Transactions as shown in the Schedule of Reportable Transactions for the year ended December 31, 2024.

Note E – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions and the net assets would be distributed to the participants according to the participant's account balances.

Note F – Party-in-Interest Transactions

Certain plan investments are shares of money market funds or mutual funds managed by Mid Atlantic, the custodian and recordkeeper of the Plan. Fees paid by the Plan for investment management services were included as a reduction of the return on each fund. The plan sponsor pays for certain administrative expenses on behalf of the Plan.

Note G – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note H – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means;

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of this asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lower level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Management reviews and approves fair value measurement policies and procedures annually, and determines if the valuation techniques used to measure assets at fair value remain appropriate.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. All assets are measured at fair value on a recurring basis.

Money market funds: Valued at the daily closing price as reported in the active market in which the underlying funds are traded.

Mutual funds: Valued at the closing price reported in the active market in which the underlying mutual funds are traded.

Common / collective trusts: The fair value of the Plan's interest in common/collective trust funds is based on the net asset value after adjustments to reflect all fund investments at fair value. The net asset value is quoted on a private market that is not active; however, the unit price is based on underlying investments that are traded on an active market. Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates.
