We have performed audits of the financial statements of First Farmers Financial Corp. 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1. Description of the Plan

General

The following description of First Farmers Financial Corp. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by First Farmers Financial Corporation (Company) for the benefit of its employees who have completed at least 500 hours of service in a six-month period and are age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Northwest Bank (trustee), is the appointed trustee and custodian for the Plan. Empower Annuity Insurance Company of America and Empower Trust Company, LLC are also custodians of the other Plan assets. Retirement Plan Concepts & Services, Inc. (RPCSI) serves as the Plan's record keeper.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company's matching and profit-sharing contributions are discretionary as determined by the Company's Board of Directors. Contributions are subject to certain limitations. Forfeitures are first used to pay administrative expenses of the Plan with any remaining amounts used to reduce Company contributions.

Participant Investment Account Options

Investment account options available include various funds, including Company stock. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual increase in the percentage deferred and is ultimately capped at 6%.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after six years of continuous service or attainment of the Plan's defined retirement age. The nonvested balance is forfeited upon termination of service. Forfeitures are first used to pay administrative expenses of the Plan with any remaining amount used to reduce Company contributions.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the vested interest in their account, annual installments over a future period, or a joint and survivor annuity. Upon termination of service for other reasons, a participant may receive the value of the vested interest in their account only as a lump-sum distribution.

Voting Rights

The trustee shall not vote any shares of First Farmers Financial Corporation stock held by the trust except in accordance with the written instructions of the Company, the investment fiduciary or to the extent provided in the Adoption Agreement. The trustee may, in the absence of instructions, vote "present" for the sole purpose of allowing such shares to be counted for establishment of a quorum at a shareholders' meeting.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$48,914 and \$64,977, respectively. During the years ended December 31, 2024 and 2023, forfeited nonvested accounts of \$45,626 and \$24,841, respectively, were used to pay Plan expenses. These accounts will be used to pay Plan expenses or reduce Company contributions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds and money market funds are valued at the quoted market net asset value (NAV) of shares held by the Plan at year-end.

The common shares of the Company are valued at estimated fair value on December 31, 2024 and 2023, as determined by an independent appraisal.

Fully benefit-responsive investments in guaranteed investment contracts is recorded at contract value. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan operates under a standardized adoption agreement in connection with a prototype retirement plan and trust sponsored by Retirement Plan Concepts & Services, Inc. This prototype Plan Document has been filed with the appropriate agency. The Plan has not requested or obtained a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was exempt from tax as of the financial statement date.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

Note 3. Certification by Plan Custodians and Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Northwest Bank, Empower Annuity Insurance Company of America, and Empower Trust Company, LLC, qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023, except for value of investment in Company common stock of \$4,279,859 and \$4,304,122, respectively.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, except for net appreciation in the fair value of Company common stock of \$160,203 and \$479,054, respectively.
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024, except for value of investment in Company common stock of \$4,279,859

The Plan's independent auditors did not perform procedures with respect to this certified investments information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan invests in Company stock. As of December 31, 2024 and 2023, the Plan held an investment of 71,035 and 74,209 shares, respectively, of Company common stock with a fair value of \$4,279,859 and \$4,304,122, respectively. During the years ended December 31, 2024 and 2023, the Plan recorded dividend income of \$139,339 and \$142,668, respectively, from its investment in Company common stock.

Additionally, the Plan hold investments in a guaranteed investment contract issued by the Plan custodian. The Plan paid \$155,038 and \$134,981 of recordkeeping, custodial, and trustee fees to Empower Retirement, Northwest Bank, and RPCSI during 2024 and 2023, respectively. The Company provides certain administrative services and pays certain Plan expenses at no cost to the Plan.

Note 5. Plan Amendments

Effective January 1, 2023, the Plan was amended to automatically enroll participants hired on or after November 1, 2014 at an annual deferral rate of 6% of eligible compensation.

Effective April 15, 2023, the Plan was amended to allow for participants to change election deferrals each pay period.

Effective January 1, 2024, the Plan was amended to raise the threshold which a terminated participant's account is forced out from \$5,000 to \$7,000.

Note 6. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Investments

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. Level 1 investments include mutual funds and money market funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. The Plan has no Level 2 investments. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. Level 3 investments include First Farmers Financial Corporation common stock.

Fair value determinations for Level 3 measurements of securities are the responsibility of the Finance Department who contracts with pricing and valuation specialists to generate estimates. The Finance Department reviews and challenges the reasonableness of the assumptions used and the methodology to ensure the estimated fair value complies with accounting standards generally accepted in the United States of America.

Note 7. Investment Contract With Insurance Company

The Plan entered into a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America. Contributions are maintained in a general account. The guaranteed investment contract is classified as a traditional investment contract. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Empower Retirement, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The guaranteed investment contract is a traditional investment contract.

Note 8. Reconciliation of Financial Statements to Form 5500

Differences between the Annual Report/Report of Employee Benefit Plan (Form 5500) filed with the Internal Revenue Service and the accompanying financial statements consist of classification differences.

Note 9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 10. Risks and Uncertainties

The Plan invests in various investment securities and Company stock, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 11. Subsequent Events

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.
