Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Gut, P.C. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A DESCRIPTION OF PLAN

The following description of the Gut, P.C. Profit Sharing Plan ("the Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Gut, P.C., ("the Company"), except leased employees, union employees, and non-resident aliens, who have attained one year of service. Plan entry dates are January 1 and July 1 of each year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees oversees governance of the Plan, determines the appropriateness of the Plan's investments, and monitors investment performance. Service with Gastroenterology Associates of Dothan, P.C.; Epix Healthcare; and Alabama Medical Group, P.C. will be recognized for eligibility purposes with respect to all plan components.

Contributions

Each year, participants may contribute up to the maximum percentage allowable not to exceed the 401(k) Section of the Internal Revenue Code ("IRC"), as defined by the Plan, including catch-up contributions for participants aged 50 and over. Contributions may also be designated as after-tax Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Participants direct the investment of their contributions in various investment options offered by the Plan. The Plan currently offers various mutual funds and self-directed investment accounts as investment options for participants.

The Company contributes a safe-harbor non-elective contribution of 3.00% of participants' compensation, as defined. The Company also contributes a discretionary profit sharing contribution to the Plan based on profitability. To be eligible for the profit sharing contribution, an employee must have 1,000 hours of service and be employed on the last day of the plan year. The profit-sharing contribution allocation is based on individual classifications, aggregated into two rate groups which are: (1) physicians and (2) others. The profit-sharing contribution for eligible physicians was 10.18% of the participating physicians' compensation for the years ended December 31, 2024 and 2023. The profit-sharing contribution for other employees for the years ended December 31, 2024 and 2023 was 2.00% of the participants' compensation. The contribution is invested based on participants' allocation of investments. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's safe harbor non-elective and discretionary profit sharing contributions and (b) plan earnings (losses), and charged with an allocation of administrative expenses, when applicable.

NOTE A DESCRIPTION OF PLAN (cont'd)

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of its accounts is graded based on years of credited service. A participant becomes 20% vested after two years of credited service and becomes an additional 20% vested after each additional year of credited service. A participant is 100% vested after six years of credited service. A participant is 100% vested upon death or normal retirement (age 65).

Notes Receivable from Participants

The Plan does not allow for participant loans.

Payment of Benefits

On termination of service due to death or retirement, a participant may elect to receive an amount equal to the value of the participant's interest in his or her account in a lump-sum amount. Upon these events, vesting is accelerated to 100%. For termination of service due to other reasons, as defined, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If a participant's vested account balance is less than \$5,000 upon termination, a distribution of the participant's account may be made automatically. In-service distributions are permitted for a minimum of \$1,000 from a participant's non-elective contribution account after 5 years of participation and at any time from a participant's rollover contribution account.

Forfeited Accounts

There was \$49,361 and \$28,493 in forfeited nonvested accounts at December 31, 2024 and 2023, respectively. Forfeitures may be used to restore forfeitures, reduce Company contributions, or for payment of administrative expenses. No forfeited nonvested accounts were used during 2024.

NOTE B SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

NOTE B SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (cont'd)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and insurance company. (See Note C for discussion of fair value measurements.)

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which contributions are withheld from employees. The safe harbor non-elective and profit-sharing contributions from the Employer are recorded in the year in which participant compensation is earned.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the plan sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

NOTE C FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to

unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts: Accounts primarily consist of mutual funds, common stocks, and exchange-traded funds that are valued on the basis of readily determinable market prices. These investments contained within the self-directed brokerage accounts are deemed to be actively traded.

NOTE E RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are mutual funds managed by an affiliate of Capital Bank and Trust Company, the custodian. Transactions in these funds qualify as party-in-interest transactions. Most fees incurred by the Plan for the investment management services are transactional fees which are included in net appreciation (depreciation) in fair value of the investments. Fees directly paid by the Plan are reported as administrative fees on the statement of changes in net assets available for benefits. Fees directly paid by the Plan to Capital Bank and Trust amounted to \$750 for the year ended December 31, 2024.

The Company performs certain administrative functions of the Plan at no cost to the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE F PROHIBITED TRANSACTIONS

During the year ended December 31, 2024, the plan sponsor failed to remit to the Plan's custodian certain employee contributions totaling \$44,661 within the period prescribed by the Department of Labor regulations. The delays in remitting were due to administrative error. All employee contributions have since been remitted to the Plan.

The plan sponsor believes that the delinquent contributions constitute nonexempt prohibited transactions. The plan sponsor believes that these transactions do not affect the tax status of the Plan.

NOTE G PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

NOTE H TAX STATUS

The Company adopted the CCH Incorporated DBA ftwilliam.com non-standardized pre-approved profit sharing plan with CODA. On June 30, 2020, the Internal Revenue Service ("IRS") determined and informed CCH Incorporated DBA ftwilliam.com by letter that the Plan is designed in accordance with applicable sections of the IRC. The Company elected not to file for an individual determination letter and relies on the letter issued to CCH Incorporated DBA ftwilliam.com. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE J SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 9, 2025, the date the Plan's financial statements were available to be issued.
