Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cahaba Medical Care Foundation 401k Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank, or similar institution, or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

These procedures include comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves and other additional procedures in accordance with generally accepted auditing standards. 1. Description of Plan:

The following description of Cahaba Medical Care Foundation 401k Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General – The Plan is a defined contribution plan covering qualifying employees of the Cahaba Medical Care Foundation (the Organization). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The effective date of the Plan was January 1, 2013.

Eligibility – All employees who have three months of service are eligible to participate in the Plan.

Contributions – The Organization contributes every payroll period a safe harbor matching contribution equal to 100 percent of employee deferral contributions up to 4 percent of compensation. Employee deferral contributions are permitted up to 90 percent of compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Each plan year, the Organization may make nonelective profit-sharing contributions to eligible participants in the Plan in the amount determined by the Organization at its discretion. Participants may direct contributions to any of the available options offered by the Plan. The Plan allows participants of the Plan to designate contributions as Roth contributions. The Plan also allows participants to rollover amounts from other qualified plans. Contributions are subject to Internal Revenue Code (IRC) annual limitations.

Participant accounts – Each participant’s account is credited with the participant’s contributions and allocations of (a) the Organization’s contribution, (b) the Plan’s earnings and losses, and (c) forfeitures of terminated participants’ nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their salary deferral contributions, safe harbor matching contributions, and actual earnings thereon. Vesting in the Organization’s nonelective contribution is based on years of service as set forth in the following table:

Participants’ Years of Service	Vested Percentage
Less than 3	0%
3	100%

The participant’s total account balance becomes fully vested upon termination of employment due to death, disability, or attainment of age 65.

Benefit payments – Normal retirement under the Plan occurs at age 65. The Plan provides for retirement distributions to persons under age 65 if certain conditions are met as specified in the plan document. Participants or their beneficiaries are eligible to receive payment of benefits in the event of the participant’s retirement, death, disability, or termination of the Plan. Benefits are distributed according to provisions set forth in the plan document.

1. Description of Plan (continued):

Benefit payments (continued) – Participants’ nonforfeitable account balances of \$5,000 or less may be distributed in a lump-sum payment. If the vested amount exceeds \$5,000, participants may elect for the benefits to be distributed in a lump-sum payment or rollover, distributed in installments, partially withdrawn, or deferred until age 70 and one half. Benefits are recorded when paid. There were no benefits payable to persons who have withdrawn from participation in the earnings and operations of the Plan at December 31, 2024 or 2023.

Notes receivable from participants – Participants may borrow from their account upon approval of the plan administrator. Up to three active loans are permitted at one time. The amount of the note cannot be less than \$500 each and are limited in total to one-half of the total value of the participant’s vested account balance, up to \$50,000. Principal and interest are paid ratably through payroll deductions. The term of the note may not exceed five years. The note is secured by the balance in the participant’s account and bears interest at a fixed rate for the duration of the loan.

Administration of the Plan – The Plan is administered by the Organization in the form of an advisory committee. Plan assets are invested in accordance with the employee’s instructions. Records of participant account activity are processed and maintained by Automatic Data Processing, Inc., which also performs other administrative support services for the Plan. Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan. Administrative expenses are paid by either the Plan or the Plan’s sponsor, as provided by the plan document.

Forfeited accounts – Plan forfeitures arise as a result of participants who terminate service with the Organization before becoming fully vested in the Organization’s contributions. These amounts get allocated to participants based on participant account balances. For the years ended December 31, 2024 and 2023, there were no forfeitures.

Plan termination – Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the participants would become 100 percent vested in their accounts.

2. Summary of Significant Accounting Policies:

Basis of accounting – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, as well as the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of shares are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held, during the year.

2. Summary of Significant Accounting Policies (continued):

Investment valuation and income recognition – The fair value of the Plan’s assets is based on quoted market prices, determined by pricing services from Reliance Trust Company and other reliable sources. Shares of registered investment companies (mutual funds) are reported at fair value based on the quoted market price of the fund, which represents the net asset value of the shares held by the fund at year end. Shares held in bank common/collective trust funds are reported at fair value based on the unit prices quoted by the fund, representing the contract value of the underlying investments. See Note 5 for discussion of fair value measurements.

Administrative expenses – The Organization pays certain administrative expenses on behalf of the Plan. Administrative expenses may be reduced by nonvested account forfeitures during the plan year.

Subsequent events – In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 3, 2025, the date the financial statements were available to be issued.

3. Information Certified by the Plan Custodian:

Reliance Trust Company, the custodian of the Plan, has supplied the plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental Schedule H, Line 4i – schedule of assets held at end of year as of December 31, 2024.

4. Investments at Contract Value:

The Plan’s fully benefit-responsive stable value option with Invesco is maintained in Invesco’s general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The stable value option issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Invesco, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion of their investment, at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the plan sponsor to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

5. Fair Value Measurements:

Financial Accounting Standards Board *Accounting Standards Codification* 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs, other than quoted prices, that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value:

- **Mutual funds** – Mutual funds are valued at the net asset value of shares held by the Plan at year end.
- **Common/collective trusts** – The fair value of the units held in common/collective trusts is based on quoted market prices of the underlying investments in the fund and is based on the net asset value of the shares held by the Plan at year end. The common/collective trusts have a readily determinable fair value as the underlying investments are actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in fair value levels – The availability of observable market data is monitored to assess the appropriate classifications of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2, or 3.

6. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

The Plan has a concentration of investments in PIMCO Total Return Fund A, Amercent One Choice 2050 A, and State Street S&P 500 Index IX. A change in the value of these funds could cause the value of the Plan's net assets available for benefits to change due to this concentration. In addition, as a result of funds being selected by participants, certain other funds may individually represent a concentration of greater than 10 percent of the Plan's investments at fair value in the statements of net assets available for benefits. Although these individual funds maintain a level of diversification by investing in multiple equity, debt, or other instruments, there may be a concentration of risk because the funds are invested at the direction of a single fund manager. At December 31, 2024 and 2023, PIMCO Total Return Fund A, Amercent One Choice 2050 A, and State Street S&P 500 Index IX each individually represented greater than 10 percent of the Plan's investments at fair value.

7. Plan Tax Status:

The Plan is placing reliance on an opinion letter dated July 8, 2014, received from the Internal Revenue Service (IRS) on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under current income tax law. Accordingly, no provisions for income taxes have been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status. However, there are no audits for any tax periods in progress.

8. Party-in-interest Transactions:

Certain plan investments are managed by Reliance Trust Company. Reliance Trust Company is the custodian as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of investments as they are paid through revenue sharing, rather than direct payment.

Other party-in-interest transactions are as follows:

- The plan sponsor provides to the Plan certain accounting and administrative services for which no fees are charged to the Plan. The employees that provide these services also are participants in the Plan.
- The Plan relies on a third-party service provider, Automatic Data Processing, Inc., to process the Plan's investment transactions, prepare the IRS Form 5500, and manage the individual participant accounts of the Plan.
