INDEPENDENT AUDITOR'S REPORT

To the Trustee and Participants of the Plan
Aztec Engineering Group, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Aztec Engineering Group, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

The following description of the Aztec Engineering Group, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions, a copy of which is available from Aztec Engineering Group, Inc. (the "Plan Sponsor").

General

The Plan was established on January 1, 1997 (restated July 1, 2022), as a defined contribution plan, that covers all employees of Aztec Engineering Group, Inc. and Beiswenger, Hoch & Associates Inc. Employees are eligible to participate in the Plan upon completion of two months of service. The Plan provides for employee pre-tax and after-tax salary deferrals, employer matching contributions as well as discretionary employer profit sharing contributions in accordance with Section 401 of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participant contributions to the 401(k) component of the Plan are directed by the participant into investment funds. Participants may contribute between a minimum of 1% and up to 60% of their compensation up to the maximum limits established by the Internal Revenue Service ("IRS"). Participants who have attained the age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions ("rollovers") from other qualified defined benefit or defined contribution plans. Contributions are subject to certain IRS limitations.

The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate initially set at 3% of eligible compensation, increasing each Plan year on a graduated scale up to 6%, as defined by the Plan, and their contributions invested in a designated fund until changed by the participant.

In order to maintain the qualified automatic enrollment arrangements safe harbor status, the Plan Sponsor is required to make a contribution ("safe harbor matching contribution") equal to 100% of the participant's salary deferral not to exceed 1% of participant compensation plus 50% of the salary deferral between 1% and 6% of the participant's compensation. Participants who make salary deferrals into the Plan are eligible upon completion of two months of service for the safe harbor matching contribution. Contributions from participants and employer matching contributions are recorded in the year in which participant compensation is earned.

Employer profit sharing contributions are discretionary, and participants are eligible to share in the employer profit sharing contribution upon completion of one year of service (1,000 hours) during the Plan year. A participant, regardless of the amount of service completed in a Plan year, is eligible to share in the employer profit sharing contribution in the year of their death, disability or retirement. Each participant will be allocated a percentage of the employer profit sharing contribution based on their compensation as compared to total compensation of all participants eligible to share in the employer contribution.

Participant Accounts

Each participant's account is credited with the participant's contributions, Plan earnings, as well as employer safe harbor matching contributions, and allocations of the employer's profit sharing contribution, if eligible. Participant accounts are charged with an allocation of administrative expenses paid for by the Plan. Allocations are based on participant earnings, account balances, number of participants in the Plan or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS

Description of the Plan (continued)

Vesting

Participants are vested immediately in their contributions, rollovers, safe harbor matching contributions and related earnings. Participants become vested in the employer's profit sharing contributions portion of their account balance on a graduated scale, vesting fully after five years of service. A participant becomes 100% vested in the employer's profit sharing contribution upon death, disability or retirement. To earn a year of service a participant must be credited with at least 1,000 hours of service during a Plan year.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. Participant loans bear interest at a rate equal to 1% above the prime rate and are generally repaid through payroll deductions. Participant loans are secured by the vested balance of the participant's account.

Benefit Payments

Upon termination of service a participant may elect to receive a lump-sum amount equal to the value of the participant's vested account balance, installments over a period not to exceed the participants or beneficiaries assumed life expectancy, partial withdrawal or defer benefit payments until April 1st following the year in which the participant reaches age 72 (70 ½ if age reached before January 1, 2020, age 73 for persons born in 1951 to 1959 and age 75 for persons born in 1960 and after), if the account balance exceeds \$5,000. For account balances less than \$5,000, the benefit will be automatically distributed in the form of a single lump-sum payment. In addition, a participant is eligible for an in-service distribution once they have reached the age 59 ½ or qualify for a hardship withdrawal as outlined in the Plan document. Participants may also withdraw amounts from their rollover accounts any time before severance. Benefit payments to participants are recorded when paid.

Forfeitures

Forfeitures of employer profit sharing contributions may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed by the Plan sponsor. During 2024, \$8,896 was used towards reducing employer match or Plan expenses. During 2023, no amounts were used towards reducing employer match or Plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10 and \$11, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer profit sharing contributions and earnings thereon.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

NOTES TO FINANCIAL STATEMENTS

Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of the fair value measurement of the Plan's investments in mutual funds and money market fund.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as a distribution based on the terms of the Plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from the financial statements. Fees related to notes receivable from participants and benefit payments are charged directly to the participant's account. Expenses incurred in connection with the general administration of the Plan and investment advisor fees are allocated amongst the participants based on their account balance or an equal dollar amount based on the number of participants in the Plan. The method of allocating expenses depends on the nature of the expense itself.

Risks and Uncertainties

The Plan provides for investments in mutual funds and a money market fund. These investments are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

3. Information Certified and Provided by the Custodian

The following is a summary of the plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Reliance Trust Company, the custodian of the Plan. The Plan Sponsor has obtained certifications from the custodian that information provided to the Plan Sponsor by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

The custodian also certified to the completeness and accuracy of \$3,188,411 of investment income, and \$14,355 of interest income related to the aforementioned assets for the year ended December 31, 2024.

4. Fair Value Measurements

U.S. GAAP provides a framework for measuring fair value of financial assets and liabilities on a recurring basis. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable or substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

NOTES TO FINANCIAL STATEMENTS

Fair Value Measurements (continued)

Mutual funds: Stated at fair value based on unadjusted quoted prices in an active market for each share held by the fund. The Plan's mutual funds are given Level 1 status since fair value per share for these instruments is determined and published and the basis for current transactions.

Money market fund: Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value and to transact at that price. The money market fund is deemed to be actively traded. The Plan's money market mutual fund is given Level 1 status since fair value per share for these instruments is determined and published and the basis for current transactions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

On October 6, 2020, the IRS stated that the prototype non-standardized profit sharing plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the IRC and, therefore, is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the determination letter, the Plan Sponsor believes the Plan is being operated in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified and is tax exempt.

NOTES TO FINANCIAL STATEMENTS

Tax Status (continued)

Management evaluated the Plan's tax positions in accordance with the accounting standard on accounting for uncertainty in income taxes and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's tax returns are subject to examination by federal taxing authorities, generally for three years after they are filed.

The Plan recognizes interest and penalties in administrative expenses and accounts payable in the accompanying financial statements. During the years ended December 31, 2024 and 2023, the Plan did not recognize any interest and penalties.

6. Related Party Transactions and Party In Interest Transactions

As described in Note 2, the Plan contracted with an investment advisor. These services qualify as party in interest transactions. In addition, fees paid by the Plan Sponsor on behalf of the Plan during the year ended December 31, 2024 are considered a party in interest transaction and are based upon customary and reasonable rates for such services and are excluded from the financial statements.
