Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed an audit of the financial statements of Global Paratransit, Inc. 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS

NOTE 1 - PLAN DESCRIPTION

The following description of the Global Paratransit, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for more complete information on the Plan's provisions.

General

The Plan, a defined contribution plan, was established on January 1, 2012 and restated and amended at various dates through December 31, 2024 to comply with applicable laws and regulations. The Plan covers all employees of Global Paratransit, Inc. (the Company) who meet certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's owner.

The trustee of the Plan is Reliance Trust Company (Reliance). All participant account balances are held by Reliance. Automatic Data Processing, Inc. (ADP) is the recordkeeper of the Plan and is responsible for administering all investment transactions directed by the Plan participants.

Eligibility

Employees who are 21 years of age or older who have completed six months of service are eligible to participate in the Plan. Employees are eligible to participate in the Plan the first day of the month coinciding with the date they satisfy the eligibility requirement.

Contributions

Participants may elect to defer up to 70% of their compensation as an employee pre-tax or Roth contribution, subject to certain limitations under the IRC. Plan participants over the age of 50 may defer catch-up contributions, subject to the IRC limitations. Participants may also contribute rollovers representing distributions from other qualified defined benefit or contribution plans.

In accordance with the Plan document, the Company may elect to make matching and nonelective contributions to the Plan. Participants must make elective deferrals to the Plan to receive matching contributions. The nonelective contributions will be allocated to all employees eligible to participate in the Plan as of the end of each Plan year. The Company had made \$20,924 and \$16,589 matching contribution for the years ended December 31, 2024 and 2023. No nonelective contributions to the Plan was made during the year ended December 31, 2024 and 2023.

Contributions - Continued

The participant directs the investment of their contributions and their share of employer contributions into various investment options offered by the Plan, and may change their investment directive at any time.

Vesting

Participants are 100% vested in their elective contributions plus actual earnings thereon. Vesting in the employer contributions and earnings thereon is based on years of continuous service as follows:

3	40%

6 or more years	100%

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures are first used to reduce employer contributions. Any remaining forfeitures are applied against Plan administrative expenses. As of December 31, 2024 and 2023, there were no forfeitures available for future use.

Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions (including those rolled over from another qualifying plan or trust) and related employer contributions, if any, as well as the participant's share of the Plan's income and expenses. Allocation is based on the proportion that each participant's account balance has to the total of all participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 - PLAN DESCRIPTION – CONTINUED

Payment of Benefits

Upon termination of services due to severance from employment, death, disability, or retirement, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Payment of account balances in excess of \$5,000 may be deferred until the age of 70½. If the vested account balance is \$1,000 or less, the entire balance will be paid out.

For balances between \$1,000 and \$5,000, the participant may elect to either directly transfer the vested account balance to an Independent Retirement Account (IRA) or another qualified plan or receive the vested benefits in a lump-sum payment. If no election is made, vested benefits are transferred to a separate IRA established by the Plan. In addition, hardship distributions are permitted if certain criteria are met.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum limited to the lesser of: (1) \$50,000 or (2) 50% of the participant's vested account balance. Each loan bears a reasonable rate of interest, which is determined by the trustee of the Plan and is repaid on an installment basis through payroll deductions over a period not to exceed five years, unless the funds are used by the participant to acquire a principal residence. Should employment with the Company be terminated prior to the full repayment of the loan, all remaining unpaid principal and interest shall be considered an immediate distribution of benefits under the Plan and reported as taxable income to the participant. In accordance with the Plan Provisions, the rate of interest on participant loans ranges between 5.25 and 10.5 percent as of December 31, 2024, with maturities through October 2028.

Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Audit fees and other administrative expenses are paid by the Company.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100 percent vested in their accounts, and the net assets of the Plan will be allocated as prescribed by ERISAs and its related regulations.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets at the date of the financial statements, and the reported amounts of additions and deductions from net assets available for benefits during the reporting period as well as disclosure of any contingent assets or liabilities. Actual results could differ from these estimates.

Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statements of net assets available for benefits

Investment Valuation and Income Recognition

Plan assets invested in mutual funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. Additional information about fair value measurements can be found in *Note 5*.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefits Paid to Participants

Benefit payments to participants are recorded when paid. At December 31, 2024, there were no benefits processed and approved for payment, but not paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, while others are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain investment related expenses are included in net appreciation in fair value of investments and other investment related expenses are included in administrative expenses.

Subsequent Events

In accordance with GAAP, events occurring between December 31, 2024 and October 14, 2025, the date these financial statements were available to be issued, were evaluated, and no material subsequent events that required recognition in these financial statements were noted.

NOTE 3 - CERTIFIED INFORMATION (UNAUDITED)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net investment income (loss), and interest income on notes receivable from participants for the years ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

NOTE 4 - INCOME TAX STATUS

The Plan has adopted a Prototype 401(k) and Profit Sharing Plan that received a favorable opinion letter from the Internal Revenue applicable requirements of the IRC. The Plan has been amended since receiving the Service (IRS) dated March 31, 2008, which stated that the Plan was in compliance with the opinion letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and. Therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

In accordance with GAAP, the Plan management is required to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. As a result, the Plan has recognized no interest or penalties related to uncertain tax positions.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to tax examinations for years prior to 2020.

NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Following is a description of the Valuation methodology used for assets measured at fair value on a recurring basis:

Shares of registered investment companies

Valued at the daily closing prices provided by the trustee. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust account

Valued at the net asset value per unit as provided by the trustee of the Plan. Collective investment funds are generally available only via employer sponsored retirement plans, pension plans, and insurance companies. The net asset value per unit is derived from values of similar investments that have quoted prices in active markets. The net asset value is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments less liabilities
