### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Verdantas LLC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Note 1—Description of the Plan

The following brief description of the Verdantas LLC Retirement Plan (the “Plan”) is provided for general information. Participants should refer to the Plan document for a more comprehensive description of the Plan’s provisions.

*General* – The Plan, restated on January 1, 2024 (adopted on January 1, 1991), is a defined contribution plan covering substantially all employees of Verdantas LLC and its subsidiaries (the “Company” or “Employer”), excluding union employees, nonresident aliens, and leased employees. Employees must have attained the age of 21 and completed one month of service to participant in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

During the year ended December 31, 2024, the following defined contribution employee benefit plans were merged with the Plan:

- Borton-Lawson Engineering, Inc. 401(k) Profit Sharing Plan,
- Leighton Group, Inc. Savings & Investment Plan,
- Clemson Engineering Hydraulics 401(k) Profit Sharing Plan and Trust,
- WatCon Consulting Engineering LLC 401(k) Profit Sharing Plan and Trust,
- Certain net assets of the Insperity 401(k) Plan (MEP) related to employees of Intelligence Group, LLC,
- GRP Engineering, Inc. 401(k) Plan.

As a result of these mergers net assets of approximately \$62,184,000 were transferred into the Plan.

*Plan Administration* – The Plan is administered by the Company. The Plan’s assets are maintained and administered by Reliance Trust Company, the “qualified institution” of the Plan. The Plan administrator is responsible for the oversight of the Plan including the appropriateness of the Plan’s investment offerings and monitoring of the investment performance.

*Employee Contributions* – The Plan provides for employee pre-tax and Roth deferrals up to 90% of eligible wages, as defined in the Plan document, without exceeding limitations prescribed by the Internal Revenue Code (“IRC”). Participants may also rollover amounts representing distributions from other qualified plans. Additionally, participants ages 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their contribution rate set at 6% of eligible compensation, as defined, and their contributions are automatically invested in a designated balanced fund until changed by the participant.

*Employer Contributions* – Under the Plan, the Company matches participant contributions as follows:

- 75% match on the first 1% of eligible compensation contributed by the participant,
- 50% match on the next 5% of eligible compensation contributed.

The Company may elect to make non-elective and profit-sharing contributions to the Plan. During 2024, the Company did not make any non-elective contributions or profit-sharing contributions. Participants are eligible for Employer contributions after one month of service with the Company.

*Participant Investment Account Options* – Participants direct the investment of all contributions into various investment options offered by the Plan. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at their discretion.

### Note 1—Description of the Plan (continued)

*Participant Accounts* – Each participant’s account is credited and/or reduced with the participant’s elective deferral contributions and distributions as well as allocation of: (a) the Company’s contributions, (b) Plan earnings (losses), (c) forfeitures, and (d) administrative expenses. Allocations are based on participant earnings or account balances, as defined.

*Vesting* – Participants are immediately vested in their voluntary contributions plus actual earnings or losses thereon. Participants hired on or prior to December 31, 2020, are fully vested in Employer contributions. Effective January 1, 2021, vesting in the Employer contributions plus earnings or losses is based on years of continuous service. A participant is 100% vested after three years of credited service based on the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 1 year	0%
1 year	33%
2 years	67%
3 years	100%

Participants are also fully vested when they become disabled or deceased while still employed by the Company.

*Forfeitures* – Forfeitures of terminated nonvested account balances may be used to pay the Plan’s administrative expenses or to reduce Employer contributions. During the year ended December 31, 2024, forfeitures totaling approximately \$123,000 were used to pay administrative expenses and approximately \$99,000 were used to reduce Employer contributions. As of December 31, 2024, and 2023, forfeited nonvested accounts totaled approximately \$7,000 and \$6,800, respectively.

*Notes Receivable from Participants* – Participants may borrow from their individual accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance and may have no more than two loans outstanding. The notes are secured by the vested portion of the participant’s account balance. Each note shall be repaid within a specified period of time, in accordance with the Plan document. The notes will bear interest at prime rate plus 1%. As of December 31, 2024, the interest rate on outstanding notes range from 3.25% to 9.50%. Principal and interest is collected ratably through payroll deductions.

*Payment of Benefits* – Upon termination of service due to death, disability, or retirement or other reasons, the Plan provides for a lump-sum distribution or installment payments equal to the total value of the participant’s deferral contribution account, and the vested portion of a participant’s matching contribution and non-elective contribution accounts. Participants are allowed in service withdrawals of their vested participant’s vested interest in his or her account upon attainment of retirement age or in the event of a financial hardship. The Plan provides for involuntary cash-out distributions for terminated employees with a vested balance of less than \$5,000.

*Hardship Distributions* – Hardship distributions are permitted if the distribution is due to expenses incurred or necessary for medical care described in the IRC Section 213(d), purchase of a principal residence, payment of tuition, to prevent eviction from or foreclosure of the principal residence, or any other condition which the Commissioner of the IRS determines is deemed an immediate and financial need of the participant. Any distributions will be taken first from the participant’s pre-tax deferral account and then from the participant’s Roth deferral account.

### Note 2—Summary of significant accounting policies

*Basis of Presentation* – The accompanying financial statements of the Plan have been prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Contribution Receivable* – The amounts of participant-related contributions that have been deducted from the participant’s payroll as of the end of the year but have not been deposited with the Plan until after the end of the year is reflected as participant contributions receivable in the Plan’s financial statements. In addition, any contributions due and payable by the Company are reflected as Company contributions receivable in the Plan’s financial statements.

*Investment Valuation and Income Recognition* – Investments in mutual funds and common collective trusts are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date.

The Plan’s investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held, during the year.

*Fair Value Measurements* – The Plan follows the Fair Value Measurements topic of the Financial Accounting Standards Board Accounting Standards Codification which defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs may be used to measure fair value:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques are used to maximize the use of observable inputs and minimize the use of unobservable inputs. There were no transfers between levels during the year ended December 31, 2024.

### **Note 2—Summary of significant accounting policies (continued)**

The following are the descriptions of the valuation methodologies used to measure the Plan's investment at fair value, including, the general classification of such instruments pursuant to the valuation hierarchy:

*Mutual Funds* – Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are included within Level 1 of the fair value hierarchy.

*Common Collective Trusts* – This investment is a public investment vehicle valued using NAV of units of a bank collective trust. NAV, as provided by the qualified institution, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the trust less its liabilities and then divided by the number of shares outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Transactions (purchases and sales) may occur daily. These investments measured using NAV practical expedient are exempt from classification under the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

*Payment of Benefits* – Benefits are recorded when they have been processed and paid by the Plan.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Company and are, therefore, excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants and certain participants distributions are included in administrative expenses and charged directly to the participant's account.

#### **Note 5—Fully benefit-responsive investment contract**

The Plan has invested in an investment contract at December 31, 2024, which includes a guaranteed investment account, which was determined to be fully benefit-responsive. As a result of the contract being fully benefit-responsive, the contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by the qualified institution, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The general investment account does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### **Note 6—Party-in-interest transactions**

Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. While these transactions qualify as party-in-interest activity, they are expressly exempted from the prohibited transaction rules.

#### **Note 7—Plan termination**

Although it has not expressed any intent to do so, the Company reserves the right at any time to amend, modify, or terminate the Plan without the consent of any participant or beneficiary subject to the provisions of ERISA. In the event of such termination, the Plan provides that the participants shall become fully vested in their accounts.

#### **Note 8—Income tax status**

The Plan sponsor adopted a non-standardized pre-approved profit sharing plan which received a favorable opinion letter from the IRS on October 6, 2020, which stated the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the prototype plan has been amended since receiving the opinion letter. However, the Plan sponsor believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. The Plan sponsor believes the Plan has no income subject to unrelated business income tax.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9—Risks and uncertainties**

The Plan provides for various investment options which are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to the changes in the value of investment securities, it is at least reasonably possible that changes in the fair value of investments will occur in the near term and that such change could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**Note 11—Subsequent events**

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent to the statements of net assets available for benefits date of December 31, 2024 through October 15, 2025, which is the date these financial statements were available to be issued. During this period, four amendments effecting the 2025 Plan were adopted, the most recent of which became effective on April 1, 2025. These amendments include:

**Safe Harbor Matching Contributions** – The Employer will make matching contributions intended to satisfy the QACA “ADP test safe harbor” requirements. These contributions will be made to the accounts of all eligible participants who make elective deferrals. The matching formula will be structured as a flexible discretionary match, allowing the employer to determine the matching rate annually, subject to compliance with applicable nondiscrimination rules.

**Safe Harbor Vesting Schedule** – For the safe harbor matching contributions under the QACA, participants will become 100% vested after completing two years of service.

**Vesting for Employer Nonelective and Matching Contributions** – Vesting for non-safe harbor employer contributions are as follows:
