Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Basis for Opinion

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The following description of the American Bulk Commodities Retirement Savings Plan (the “Plan”) provides only general information purposes only. The Plan is sponsored by American Bulk Commodities, Inc. (the “Plan Sponsor”) and is a single employer plan. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) profit sharing plan covering substantially all full-time employees who are employed by American Bulk Commodities, Inc. and affiliated employers as defined in the Plan agreement. Employees are eligible to participate in the Plan on the first of the month after the date of employment and attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The plan administrator and Trustees are responsible for the oversight of the Plan and determine the appropriateness of the Plan’s investment offerings and monitor investment performance.

Contributions

Participants may contribute to the Plan exclusively through pre-tax salary deferrals. Participants may make voluntary contributions up to 100% of their annual base compensation, as defined in the Plan agreement, subject to applicable IRS limits. Participants who have attained the age of 50 before the end of the Plan year are permitted to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

In addition, after a participant has enrolled, the Plan Sponsor may make matching contributions equal to a discretionary percentage of up to 4% of a participant’s compensation depending on the years of service with the Plan Sponsor. The employer match, which is determined by the participant’s years of service, is set forth as follows:

PARTICIPANTS' YEARS OF SERVICE	MATCHING PERCENTAGE OF THE FIRST 4% DEFERRED
0 and under 10	50%
10 and under 20	75%
20 and over	100%

Participants' voluntary contributions and employer's matching contributions are designated under a qualified deferred arrangement as allowed by Section 401(k) and 401(m) of the Internal Revenue Code. During the year ended December 31, 2024, matching contributions totaled \$775,418. The Plan Sponsor may also make additional discretionary profit-sharing contributions to be allocated per the Plan documents. For the year ended December 31, 2024, the Plan Sponsor did not make a profit-sharing contribution.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Participants' Accounts

Each participant's account is credited with their voluntary contribution and employer's profit sharing and matching contributions, and an allocation of the Plan's net earnings as defined by the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, plus actual earnings thereon. Participants are 100% vested in the Plan Sponsor's profit sharing and matching contributions and actual earnings thereon after three years of service or upon death.

Forfeitures

Upon termination of a participant, the Plan Sponsor's profit sharing and matching contributions in which the participant is not vested will be forfeited when the participant incurs a five-year break in service and such forfeitures will be forfeited when the participants are eligible to share in such allocation as a discretionary match proportional to each participant's employer match received for the year. Forfeitures totaled \$79,306 and \$33,052 for the years ended December 31, 2024 and 2023, respectively.

Payment of Benefits

On termination of service due to death, disability, retirement or other, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants are entitled to receive in-service withdrawals upon attainment of age 59½ or as a hardship distribution, as defined in the Plan agreement.

Plan Costs

The Plan is responsible for paying investment management fees, audit costs, and certain administrative expenses incurred in the operation and oversight of the Plan. These expenses are paid directly from Plan assets, in accordance with the provisions outlined in the Plan document.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Notes receivable transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Notes receivable may be repaid in full or part at any time, however, the term is not to exceed five years. The notes receivable are secured by the balance in the participant's account and bear interest at a rate commensurate with the prevailing rates as determined monthly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and could cause our reported performance of the Plan to vary significantly from period to period.

Subsequent Events

Management evaluated all activity of the Plan through October 15, 2025, the date the financial statements were available to be issued.

NOTE C – INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule of assets (held at end of year), that was prepared by or derived from information prepared by the trustee Mid Atlantic Trust Company (MATC), and furnished to the plan administrator.

NOTE D - FAIR VALUE MEASUREMENTS

FASB ASC 820 establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 inputs) and the lowest priority to unobservable inputs (Level 3 inputs).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish daily pricing information, and fair value is determined based on the closing price reported by each fund. These investments are classified as Level 1 under the fair value hierarchy. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust

Composed primarily of fully-benefit responsive investment contracts and is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate the fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There are no participant redemption restrictions for these investments and the redemption notice period of 12 months is applicable only at the Plan level.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE F - INCOME TAX STATUS

The Plan obtained its latest determination letter dated October 1, 2021, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, however, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

AMI Benefit Plan Administrators Inc ("AMI") is the Plan's third-party administrator. MATC is the Plan's custodian. Therefore, transactions with AMI and MATC qualify as party-in-interest transactions. Fees paid by the Plan for administrative services amounted to \$140,896 for the year ended December 31, 2024. Additionally, investment management fees paid to other parties-in-interest totaled \$53,471 for the year ended December 31, 2024.

NOTE J - NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan Sponsor discovered that certain participant contributions totaling \$3,286, plus related Plan Sponsor matching contributions of \$885 were not remitted timely to the Plan as required by the Department of Labor Regulation 2510.3-102. The Plan Sponsor is in the process of self-correcting these delinquent contributions and remitting the lost earnings thereon.

The Plan Sponsor failed to withhold and remit certain participant contributions totaling \$2,113, and related Plan Sponsor matching contributions of \$1,673. The Plan Sponsor is in the process of self-correcting these nonexempt transactions by depositing the missed participant and employer matching contributions plus lost earnings thereon.
