### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Power Test, LLC 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### Note 1. Description of Plan

The following description of the Power Test, LLC 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan established by Power Test, LLC (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All nonleased employees who have completed 500 hours of service during the first six months of service or the completion of a year of service and are 18 years or older are eligible to participate in the Plan. Employees are allowed to enter the Plan on the first day of each month upon becoming eligible. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance. Effective March 1, 2023, the Plan was renamed from the Power Test, Inc. 401(k) Retirement Savings Plan to the Power Test, LLC 401(k) Retirement Savings Plan.

**Contributions:** Each year, participants may contribute up to 90% of eligible annual compensation, as defined in the Plan document, up to the maximum limits of the Internal Revenue Code (IRC). Contributions can be in the form of pretax or Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan includes a provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation. Previously auto enrolled participants who have a deferral rate of less than 8% will have an automatic contribution increase of 1% annually on April 1, unless they affirmatively elect not to be increased.

The Company's match is discretionary. For the year ended December 31, 2024, the Company's discretionary matching contribution was 25% of employee contributions on the first 8% of eligible compensation with a maximum match of 2%.

In addition, the Company may contribute a profit-sharing contribution at the discretion of the Company's Board of Directors. Employees must work over 1,000 hours during the plan year and be employed on the last day of the plan year to receive an allocation of the profit-sharing contribution. The Company did not have a profit-sharing contribution for the year ended December 31, 2024.

**Participant accounts:** Each participant's account is credited with the participant's contributions, rollover contributions, Company's discretionary matching contributions, as well as an allocation of the profit-sharing contribution and Plan earnings and losses thereon (net of administrative expenses). Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment options:** Upon enrollment in the Plan, participants may direct their account balance in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

**Vesting:** Participants are vested immediately in their contributions and rollover contributions plus actual earnings thereon. Participants who leave the Plan because of death or normal retirement, as defined by the Plan, are considered 100% vested. The Company's discretionary matching contributions, profit-sharing contributions and earnings thereon vest in accordance with provisions of the Plan as follows:

**Forfeited accounts:** Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions or pay administrative expenses. The forfeiture account had \$15,195 of loss due to market activity during the year ended December 31, 2024. At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$6,936 and \$22,131, respectively.

**Payment of benefits:** Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the Plan document. The Plan provides for normal retirement at age 65 and allows for in-service withdrawals when the participant reaches age 59½. Benefits can be paid in the form of a lump sum or installments over a specific period not to exceed the life of the participant. The amount paid equals the value of the participant's vested interest in their account. In addition, the Plan allows for hardship distributions if certain criteria are met.

The Plan provides for the automatic distribution of participant account balances of \$5,000 or less upon termination of employment, in line with Internal Revenue Service (IRS) and Department of Labor regulations. If a participant does not elect a direct rollover, balances under \$1,000 are paid out as a lump sum, while balances between \$1,000 and \$5,000 are automatically rolled over to an IRA selected by the Plan Administrator.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's vested account and bear interest at reasonable rates, which are commensurate with local prevailing rates at the inception of the loan. Terms range from one to five years or greater for the purchase of a primary residence. Principal and interest is paid ratably through payroll deductions.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisors and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold, as well as held, during the year.

**Contributions:** Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the participant contributions are withheld from amounts paid.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded at December 31, 2024 and 2023. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit is recorded.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Certain fees incurred by the Plan are allocated proportionately to Plan participants based on their respective account balances.

**Payment of benefits:** Benefits paid to participants are recorded when paid.

**Subsequent events:** The Plan has evaluated subsequent events for potential recognition or disclosure through October 15, 2025, the date the financial statements were available to be issued.

#### Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

#### Note 3. Fair Value Measurements (Continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Money market fund:** Shares of the money market fund do not have a published daily NAV through an exchange. Rather, the price per share is published by fund provider to be \$1 per share.

**Collective trust funds:** Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### **Note 5. Related-Party and Party-in-Interest Transactions**

Certain of the Plan's investments are managed by Associated Bank Company, N.A., the trustee; therefore, these transactions qualify as party-in-interest transactions. Fees paid to the trustee by the Plan for administrative expenses were \$66,065 for the year ended December 31, 2024.

Certain accounting and administrative functions of the Plan are performed by officers or employees of the Company for which no compensation is received from the Plan.

#### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

#### **Note 7. Tax Status**

The Plan adopted a nonstandardized form of a pre-approved profit-sharing plan. The pre-approved plan provider, Associated Trust Company, N.A., has received an opinion letter dated June 30, 2020 from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
