Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Recovery Network of Programs, Inc. 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of the Plan

The following description of The Recovery Network of Programs, Inc. 403(b) Retirement Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan provisions.

General

The Plan is a 403(b) defined contribution plan, which was established by Recovery Network of Programs, Inc. (the “Company” or “Employer”) to provide retirement benefits for substantially all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Participation

Eligible employees of the Company are eligible to participate in the Plan (employee deferrals) immediately upon hire. All eligible employees are automatically enrolled in the Plan with a 2% employee deferral percentage, unless the employee elects a different percentage, even if the percentage is 0%. Employees are eligible to participate in employer discretionary contributions upon completion of one year of service, which will be determined by the Employer with respect to each plan year’s eligible participants.

Contributions

Plan participants are allowed to make a pre-tax or after-tax (Roth) basis, contribution up to the maximum allowed by law of their eligible compensation (subject to Internal Revenue Code (“IRC”) Section 402(g) elective deferral maximums). The Employer may contribute a discretionary base contribution to the Plan. For the 2024 plan year a contribution of \$218,781 was made to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans to their account at any time during the Plan year (“rollovers”).

Participants self-direct the investment of both participant and employer contributions into their accounts into various investment options offered by the Plan. If no investment election is made, contributions will be invested in a qualified default investment alternative comprised of target date funds.

Vesting

Participants are immediately vested in all amounts credited to their accounts.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions and (b) Plan earnings (losses) and (c) administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of the Plan (continued)

Notes Receivable from Participants

Participants may borrow from their accounts varying amounts between a minimum of \$1,000 and a cumulative maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Participants may have up to three loans outstanding, however, they may only obtain one new loan during any consecutive 12 month period. All loans must have a definite repayment schedule, which provides for principal and interest payments to be made on a quarterly basis directly by the participant to the record keeper over a period not to exceed five years, except for loans used for the purchase of a residence that may be repaid over a period not to exceed ten years. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%, as defined in the Plan document. The Plan imposes a 3% annual administrative loan charge.

Payment of Benefits

In-service withdrawals are permitted in the case of demonstrated financial hardship or after attaining age 59½. Upon the earliest of retirement, death, disability or termination of employment, participants become eligible for a lump-sum distribution of their accounts. The automatic form of benefit under the Plan is an annuity or qualified joint and survivor annuity for married participants. At age 73 there is a required distribution of a portion of the account balance, based on the life expectancy of the individual. However, if a participant is still employed at the age of 73, they can defer receipt of their required minimum distribution until after termination of employment. The Plan allows for involuntary cash out distributions of terminated participants with balances of \$1,000 or less. Account balances that are greater than \$1,000 but less than \$5,000 will be subject to the applicable automatic IRA rollover requirements of Code Section 401(a)(31)(B). Participants who demonstrate that a hardship (as defined under Internal Revenue Service ("IRS") Regulations) exists, may withdraw funds from their accounts.

Plan Expenses

The Plan permits the payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. However, substantially all administrative expenses of the Plan are paid by the Company and excluded from these financial statements. Expenses relating to specific participant transactions (i.e. loan setup, distribution request, annual account fee, etc.) are charged directly against the appropriate participant's account.

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan’s mutual fund investments, were valued at fair value, valued using Level 1 inputs. No Level 2 or Level 3 investments were held.

Investment Valuation and Income Recognition

All investments of the Plan are stated at fair value except for the insurance company general accounts, which are stated at contract value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price.

The insurance company general accounts and pooled separate account are reported at contract value, which represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Reclassification

Certain prior year balances have been reclassified to conform with current year presentation. These reclassifications have no effect on the previously reported changes in net assets available for benefits.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 15, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company and Transamerica Financial Life Insurance Company (“TFLIC”), qualified institutions.

4. Insurance Company General Accounts

The TFLIC Fixed Fund and Stable Fund (the “Accounts”) are investment choices held by the general account of TFLIC. The assets in the general accounts are supported by the financial stability of TFLIC. While TFLIC declares interest rates and backs the principal and interest of these investment choices, any guarantees are subject to the claims paying ability of the insurance company. For the TFLIC Fixed Fund no monies may be transferred by participants to fixed income funds (competing funds). Monies transferred to non-fixed income funds may not be transferred to fixed income funds or back for 90 days. Monies transferred back or withdrawn within the 90 day period are subject to a 5% charge. Monies withdrawn or transferred by the Employer and monies withdrawn by participants not due to benefit withdrawals, hardships and loans may be subject to a withdrawal charge.

4. Insurance Company General Accounts *(continued)*

For the TFLIC Stable Fund, no monies may be transferred by participants to fixed income funds (competing funds) except at a segment maturity date. Monies transferred to non-fixed income funds may not be transferred to fixed income funds or back for three months. Monies withdrawn or transferred by the Employer at any time and/or by participants during the 6 month period preceding contract suspension may be subject to restriction and/or adjustment in accordance with contract provisions.

Because the Accounts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Accounts.

The crediting interest rate for the TFLIC Fixed Fund and Stable Funds is based on a formula agreed upon with the issuer, but may not be less than 3.5%. The crediting rate is reviewed on a quarterly basis for resetting.

The Accounts represent approximately 21% and 22% of the Plan's net assets available for benefits at December 31, 2024 and 2023. The credit risk of TFLIC was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best Company (A as of June 2025), Moody's Investors Service (A1 as of June 2025) and Standard and Poor's (A+ as of June 2025).

5. Pooled Separate Account

The Government Fixed Fund is offered as a guaranteed separate account through a group annuity contract issued by TFLIC. TFLIC fully guarantees the principal and interest. Guarantees are backed by the financial strength of TFLIC's general account. The Fund invests in obligations of the US Government and its Agencies, and provides a book value guarantee in all market environments. The Fund seeks to provide higher yields than short-term fixed maturity alternatives. No monies may be transferred by participants to fixed income funds (competing funds). Monies transferred to non-fixed income funds may not be transferred to fixed income funds or back to the Government Fixed Fund for 90 days. Monies transferred back to the Government Fixed Fund or withdrawn within the 90-day period are subject to a 5% charge. Monies withdrawn or transferred by the Employer and monies withdrawn by participants not due to benefit withdrawals, hardships and loans may be subject to a withdrawal charge.

Because the Account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Account.

The crediting interest rate for the Government Fixed Fund is declared quarterly for new deposits received that quarter and are guaranteed for the balance of that calendar year. Renewal rates are declared annually on a calendar year basis for existing assets.

5. Pooled Separate Account *(continued)*

The Account represents approximately 6% of the Plan's net assets available for benefits at December 31, 2024 and 2023. The credit risk of TFLIC was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best Company (A as of June 2025), Moody's Investors Service (A1 as of June 2025) and Standard and Poor's (A+ as of June 2025).

6. Tax Status

The prototype plan document, for which the Plan has adopted a nonstandardized adoption agreement, obtained its latest opinion on March 31, 2017, in which the IRS stated that the prototype plan as then designed was in accordance with sections of the IRC. The Plan's adoption agreement, as originally adopted by the Plan's administrator on July 1, 1972, has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Company may at any time terminate the Plan and discontinue all contributions, subject to the applicable provisions of ERISA.

8. Party-in-Interest Transactions

All investments of the Plan are managed by TFLIC. TFLIC is the trustee as defined by the Plan document and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Transamerica Retirement Solutions is the record-keeper for the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the employer perform administrative services to the Plan at no cost to the Plan.

9. Risks and Uncertainties

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
