## **INDEPENDENT AUDITORS' REPORT**

To the Plan Committee of the

### **Opinion**

**NOTE 1 - PLAN DESCRIPTION AND BASIS OF PRESENTATION**

The following description of the RRM Design Group, Inc. Employee Stock Ownership Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

RRM Design Group, Inc. (the Company) established the RRM Design Group, Inc. Employee Stock Ownership Plan (the Plan) effective as of January 1, 2013. The Plan operates as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Plan Committee appointed by the Company's board of directors. The Company's board of directors has appointed an independent third-party as the Plan's trustee.

On October 26, 2018, the Plan purchased 402,500 shares of the Company's common stock with loans from the Company and selling shareholders. The Company holds the common stock in a trust established under the Plan. The stock was purchased at a price of \$16.53 per share, for an aggregate purchase price of \$6,653,325.

The loan is collateralized by the unallocated shares of common stock. The Company has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated common stock (allocated), and (b) common stock not yet allocated to employees (unallocated).

Eligibility

To be eligible to participate in the Plan, an eligible employee must be credited with 1,000 hours of service during an eligibility computation period. The eligibility computation period begins on the employee's employment commencement date. Upon completing 1,000 Hours of Service, the employee will become eligible retroactively to the first day of the Plan Year in which the employee meets this requirement. Entry date for the Plan is on January 1st. The plan excludes the following classes of employees: (1) employees covered by a collective bargaining agreement, (2) non-resident aliens, (3) leased employees.

Contributions

The Company is obligated to make contributions to the Plan in amounts determined by the Company's Board of Directors. Such contributions, which may be made in the form of cash or shares of Company stock valued at fair market value, shall not exceed the maximum amounts deductible under Section 404(a)(3) and Section 404(a)(9) of the Internal Revenue Code. While contributions are used to enable the Plan to meet its regularly scheduled payments of principal and interest due on its loan, additional contributions may be made at the discretion of the Board of Directors. Employee contributions are not permitted.

Participants are eligible to receive an allocation of unallocated common stock released as a result of payments made on the Plan's acquisition loan if they are both employed on the last day of the year and credited with at least 1,000 hours of service during the year. A participant who terminates because of retirement, death, or disability will be eligible to receive an allocation regardless of the number of hours of service.

Payment of Benefits

The Plan provides for the distribution of the participant's account upon normal retirement, disability, death, or termination of employment. For any reason other than termination of employment, distribution of a participant's account balance will commence for accounts not exceeding \$5,000 in year following the year of termination and for accounts greater than \$5,000 during the year following the year in which their retirement, disability or death occurred. For termination of employment, distribution of a participant's vested account balance will commence as follows if the participant is not reemployed by the end of the fifth Plan Year following the Plan Year in which their employment terminates, distribution will begin during the sixth Plan Year, as soon as administratively feasible. Distributions shall be paid as a lump sum for accounts not exceeding \$7,000, or in substantially equal annual installments over a period of five years for accounts exceeding \$7,000. The period over which distributions of a participant's account is to occur may be increased by one year, up to five additional years, for each \$205,000 (or fraction thereof) by which the total balance of the participant's account exceeds \$1,035,000. These dollar limits will be adjusted at the same time and in the same manner as provided in Code §415(d).

Administrative Expenses

As provided in the Plan Agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has paid the majority of operating expenses for the Plan for the year ended December 31, 2024.

Voting Rights

All Company stock held by the Trust is voted by the Trustee in accordance with instructions from the Plan Committee. In the event of any corporate matter that involves the voting common stock which would constitute a merger, consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all assets, each participant and/or beneficiaries who has been allocated shares of stock may instruct the Trustee as to the voting of those shares. The Trustee shall vote any unallocated shares held by the Trust as well as any allocated shares for which a participant has failed to give timely voting direction.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of cash and shares of the Company's stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company and have worked a minimum of 1,000 hours in the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. The vesting schedule is as follows:

Put Option

Under federal income tax regulations, the employer stock held by the Plan and distributed to participants, includes a put option if the stock is not readily tradable on an established market or is subject to trading limitations. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. As determined by the Plan Committee, the Company may pay for the purchase of shares in a single payment or up to five (5) equal annual installments (with interest on the unpaid principal balance at a reasonable rate of interest). The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25% of shares allocated to their account, less any shares previously diversified. In the sixth year, this limit increases to 50%. Participants who elect to diversify receive a cash distribution. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

Forfeited Accounts

Plan forfeitures are generally allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures allocated to participants during the year ended December 31, 2024, totaled \$34,573. There were no forfeited non-vested accounts to be allocated to participant accounts in future years as of December 31, 2024 and 2023.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition

The shares of Company common stock are reported at fair value. See Note 4 for a discussion of the fair value measurements. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued, and concluded that there were no events that require recording or disclosure in the financial statements as of December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Interest-bearing cash consists of treasury money market funds. The carrying value is believed to be representative of its fair value based on its short term nature and is classified within level 1 of the fair value table.

The valuation process involves the selection of an appraiser by the Trustee. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a report of estimated per share value that a participant will receive upon distribution. Plan managements reviews and approves the report. The trustee is responsible for determining the share price.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - LOAN PAYABLE**

On November 2018, the Plan entered into various term loan agreements with various shareholders of the Company totaling \$3,253,325. The proceeds of the loan were used to purchase Company common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 16,876 shares being released and allocated for the plan year ended December 31, 2024.

The agreements provide for the loans to be repaid over terms ranging from 7 to 15 years. The loans bear interest at a rate of 7.00%. The scheduled amortization of the loans for the next 5 years is as follows:

In addition, effective November 2018, the Plan entered into a term loan agreement with the Company for \$2,000,000. The proceeds of the loan were used to purchase Company common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 17,285 shares being released and allocated for the plan year ended December 31, 2024.

**NOTE 6 - RELATED PARTIES AND PARTIES IN INTEREST TRANSACTIONS**

The Plan invests in Company common stock and has a loan with the Company. These are related party and party in interest transactions. As described in Note 1, the Company pays the majority of plan expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**NOTE 8 - PLAN TERMINATION**

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Plan Committee directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. Participants will become 100% vested if the Plan is terminated or partially terminated.

**NOTE 9 - TAX STATUS**

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated July 8, 2014, stating that the Plan is qualified under the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
