Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bay Surgery Center LP / Pain & Rehabilitative Consultants 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. 1. PLAN DESCRIPTION

The following description of the Bay Surgery Center LP / Pain & Rehabilitative Consultants 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete discussion of the Plan's provisions.

General and eligibility - The Plan is a defined contribution plan covering all eligible employees of Bay Surgery Center LP / Pain & Rehabilitative Consultants Medical Group (Company). The Plan became effective January 1, 2002 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 401 (a) of the Internal Revenue Code (IRC). All employees of the Company who are at least twenty-one years of age or older and have completed one year of service are eligible to participate in the Plan. Employees who are covered by a collective bargaining agreement and per diem nurses are not eligible to participate in the Plan.

Plan administration - The Company administers the Plan and is the Plan's named fiduciary. Ascensus Trust Company (Trustee) is the directed trustee and Ascensus, Inc. is the third party administrator. The Company has assigned the power to hold title to Plan assets to the Trustee.

Contributions - Eligible participants may contribute up to the Internal Revenue Service (IRS) limitations of their eligible annual pretax compensation, as defined. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan provides for automatic enrollment of eligible participants at a deferral rate of 3% of eligible pay, unless the participant affirmatively elects otherwise. Participants may also make rollover contributions from other qualified plans. Participants are allowed to designate all or a portion of their contributions as Roth Contributions.

The Company makes annual safe harbor matching contributions. For the year ended December 31, 2024, the Company safe harbor matching contribution was 100% of the first 4% of annual pretax compensation that a participant contributed to the Plan. Matching contributions totaled \$351,343 for 2024, of which \$0 was paid using forfeiture funds, and \$268,523 for 2023, of which \$0 was paid using forfeiture funds, as allowed by the Plan. The Company may make an annual discretionary profit sharing contribution as determined by the Board. There was no profit sharing contribution for the years ended December 31, 2024 and 2023.

Participant accounts - Each participant's account is credited with the Company's contributions and the salary deferral contributions as elected by the participant. An allocation of Plan earnings or losses is also credited to the participant's account. Allocations are based on the participant's account balance and individual investment directions.

Vesting - Participant account balances from salary deferral contributions and safe harbor matching contributions are 100% vested at all times. Participant account balances from profit sharing contributions vest at a rate of 20% per year of service with full vesting after six years of service.

Benefits and withdrawals - The Plan provides for the payment of benefits to the participant or the participant's beneficiary at retirement, death, disability or termination of employment with the Company. Participants may request in-service distributions if they have attained the age 59.5. The Plan permits involuntary distributions of account balances under \$5,000 if a participant terminates employment.

Forfeited accounts - The Plan is allowed to use forfeitures to reduce future Company discretionary contributions. At December 31, 2024 and 2023, there were \$1,598 and \$873, respectively, in forfeitures available to reduce employer contributions.

1. PLAN DESCRIPTION (CONTINUED)

CARES Act - The Coronavirus Aid, Relief, and Economic Security (CARES) Act became law on March 27, 2020. It was a response to the market volatility and instability resulting from the coronavirus pandemic, and includes several relief provisions available to tax-qualified retirement plans and their participants. Plan management evaluated the relief provisions available to plan participants under the CARES act and has implemented the following provision: special coronavirus distributions up to \$100,000. The plan was formally amended to adopt this CARES act provision during 2022.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting - The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting and in accordance with generally accepted accounting principles.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures. Consequently, actual results may differ from such estimates.

Investment valuation and income recognition - The Plan's investments are stated at fair value. The Plan's trustee certifies the fair market value of all investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are reflected on a trade-date basis. Interest and dividend income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits - Benefits are recorded when paid.

Administrative expenses - Certain expenses of maintaining the Plan are paid by the Company.

4. FAIR VALUE MEASUREMENTS

The FASB *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Money Market and Mutual funds: Valued at the net asset value (NAV) of shares, based on quoted market prices, held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan management believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

Ascensus Trust Company serves as the trustee of the plan's assets. Ascensus, Inc. serves as the third party administrator of the plan. All transactions with Ascensus, Inc. qualify as party-in-interest transactions. Administrative expenses and transaction fees are paid by the Plan.

6. TAX STATUS

The Plan has adopted a prototype plan sponsored by a third party. The prototype plan received a letter dated June 30, 2020 from the Internal Revenue Service stating the prototype plan, as then designed, meets the applicable requirements of the IRC. Though the Plan has been amended, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. PLAN TERMINATION

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to amend or terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the Trustees will distribute the entire net assets available for benefits to the participants or their beneficiaries in accordance with the terms and provisions of the Plan and ERISA.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.
