## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits*

We have performed audits of the financial statements of Franklin D. ### **Note 1. Description of Plan**

The following description of the Franklin D. Azar & Associates, P.C. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan rules and regulations for a more complete description of the Plan's provisions.

**General** – The Plan, which was established effective August 1, 1999, is a 401(k) plan available to qualifying employees of Franklin D. Azar & Associates, P.C. (the "Company"). The amended and restated provisions of the Plan became effective July 15, 2022. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

American United Life Insurance Company, a OneAmerica Company, is the issuer of the insurance products and record-keeper ("Issuer" or "AUL").

**Eligibility** – Employees, excluding nonresident aliens who have no earned income from sources within the United States, leased employees, and employees represented by a bargaining unit that has bargained with the Company in good faith on the subject of retirement benefits, are eligible to participate in the Plan immediately upon hire. There are no age or service requirements for eligibility for any contribution type. Employees are automatically enrolled in the Plan at a 3 percent pre-tax deferral rate unless they opt out of the Plan or make an affirmative election to contribute a different amount

**Contributions** – Each year, participants may contribute up to certain limits of their pretax annual compensation, subject to certain limitations as defined by the Plan and the Internal Revenue Code (IRC). The Company may make employer discretionary contributions to the Plan, which may be contributed at the option of the Company's Board of Directors. The Plan allows catch-up contributions for participants at least age 50 by the end of the year based on IRC limitations (\$7,500 for 2024). Participants may also contribute amounts (rollovers) representing distribution from other qualified plans, subject to applicable laws and regulations, even if not yet a participant in the Plan.

**Participant Accounts** – Each participant's account is credited with the participant's contributions, employer's contributions, and allocations of Plan net earnings depending on the investment options selected by the participant. Participant accounts are also charged with distributions and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. Upon enrollment in the Plan, participants may direct their contributions into any of the investment options available. A separate account is maintained for each participant, and interest and dividends earned by each fund may be reinvested in that fund. Participants may change their investment options at their discretion.

**Vesting** – Participants are immediately vested in their contributions and rollover contributions, plus actual earnings thereon. Discretionary employer contributions are based on years of service as defined. A participant is 100% vested after six years of credited service as follows:

**Notes Receivable from Participants** – Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant’s account. The loan interest rate is based on rates available for similar loans from commercial lending institutions. The Loan Administrator periodically examines the rates such lenders are using. Once a loan is granted, the interest rate on that loan will not change. Principal and interest are repaid through payroll deductions. Loans considered uncollectible are treated as deemed distributions; therefore, there is no allowance for uncollectible loans.

**Payment of Benefits** – Upon termination of employment due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the Participant’s vested interest in their account or annual installments. For termination of services due to other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution. Additionally, the Plan provides for in-service distributions at age 59 ½ and hardship withdrawals, as defined, if certain criteria are met.

Terminated participants with balances greater than \$5,000, may choose to keep their funds in the Plan. Participant consent for distribution is not required for terminated participants with vested account balances under \$5,000.

**Retirement Age** – The Plan’s normal retirement age is 65.

### **Note 2. Summary of Significant Accounting Policies**

**Basis of Accounting** – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United State of America (U.S. GAAP).

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are reported at fair value, except for the Plan’s investments in a guaranteed investment contract valued at contract value (see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Benefits** – Benefits are recorded when paid.

**Administrative Expenses** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value investments.

### **Note 3. Certified Investment Information**

The following information disclosed in the accompanying financial statements and ERISA-required supplemental schedules was obtained by management and agreed to or derived from information certified as complete and accurate by AUL, the custodian of the Plan:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- Investment amounts and activity, as shown in Notes 4 and 5;
- Interest income on notes receivable from participants;
- Investment income (loss), as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024; and
- The investment information in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown as a supplemental schedule.

### **Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5. Investment Contract

The Plan has a fully benefit responsive investment contract with AUL. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. AUL is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for the portion of the net asset available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or in portion of their investment at contract value, subject to certain restrictions such as an equity wash. An equity wash generally requires that transfers must be directed to a non-competing investment option under the Plan for 90 days before such transferred amounts may be directed to any competing Plan investment option available under the Plan. Competing Plan investment options include other guaranteed investment options, or fixed income, money market, or bond funds that ever had an average duration of 3 years or less.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$644,544 and \$659,990, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include:

- 1) Amendments to the Plan documents, complete or partial merger with another plan;
- 2) Changes to the Plan's prohibition on competing investment options for deletion of equity wash provisions;
- 3) Bankruptcy of the Plan sponsor or other Plan sponsor events such as divestitures or spin-offs of a subsidiary, that cause a significant withdrawal from the Plan; and
- 4) The failure of the Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are unlikely to occur. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### **Note 6. Risks and Uncertainties**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination or participant accounts will become fully vested and non-forfeitable.

### **Note 8. Tax Status**

The Company has adopted a pre-approved plan document subject to a favorable opinion letter from the Internal Revenue Service (IRS) dated August 19, 2020. The plan administrator believes the Plan has been operated in accordance with the applicable provisions of the Internal Revenue Code (IRC). The Company routinely self-reviews the administration of the Plan and self-corrects any compliance issues in accordance with the Employee Plan Compliance Resolution System. Accordingly, the plan administrator believes that the Plan is designed in accordance with applicable sections of the IRC and, accordingly, is exempt from income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 9. Party-in-Interest Transactions**

American United Life Insurance Company, a OneAmerica Company, is the Custodian of the Plan and holds and manages investments. Transactions with American United Life Insurance Company, a OneAmerica Company, are exempt party-in-interest transactions, as defined by ERISA.

### **Note 10. Delinquent Participant Contributions**

During the year ended December 31, 2024, participant contributions totaling \$25,727 were not remitted to the Plan within the timeframe prescribed by the Department of Labor. These late remittances constitute prohibited transactions under ERISA and the Internal Revenue Code. Plan management is aware of the late remittances and is in the process of correcting the prohibited transactions, which will include remitting the delinquent contributions and depositing applicable lost earnings to the affected participant accounts.

### **Note 11. Amendments**

Effective February 1, 2024, the Plan was amended to remove all age and service requirements for eligibility. Under the amended provisions, all employees (other than nonresident aliens with no U.S. source income, leased employees, and employees covered by a collective bargaining agreement that does not provide for participation) are eligible to participate in the Plan immediately upon hire, for all contribution types. Automatic enrollment continues to apply at a 3 percent pre-tax deferral rate unless the participant elects otherwise.

### **Note 12. Subsequent Events**

In preparing these financial statements, Management has evaluated events and transactions that occurred after December 31, 2024, for potential recognition or disclosure in the financial statements. These events and transactions were evaluated through October 14, 2025, the date that the financial statements were available to be issued, and no items have come to the attention of management that require recognition or disclosure.
