Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Hawaiian Financial Federal Credit Union 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

1. Description of Plan

The following description of the Hawaiian Financial Federal Credit Union 401(k) Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan covering the employees of Hawaiian Financial Federal Credit Union (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Standard Insurance Company (Standard) serves as custodian and recordkeeper for the Plan. The Company serves as the Plan Sponsor and certain members of the Company's management are the trustees.

b. Eligibility

Employees become eligible for participation with attainment of age 21 and completion of 12 months of service.

c. Contributions

Participants may elect to defer up to 100 percent of their annual compensation, subject to certain limitations defined by the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan also provides for discretionary employer matching and profit sharing contributions as determined and approved on an annual basis by the Company's Board of Directors, subject to the limitation that the contributions do not exceed the maximum amount deductible under applicable provisions of the IRC. For the year ended December 31, 2024, the Company made a discretionary matching contribution equal to 50 percent of the first ten percent of eligible compensation contributed by the participant and a profit sharing contribution equal to five percent of eligible compensation for each participant.

1. Description of Plan (continued)

d. Participant Accounts

Each participant's account is credited with the participant's contributions, the employer's discretionary contributions, and an allocation of Plan earnings and expenses. Earnings and expenses from the Plan's investments are allocated to participants' accounts in proportion to the balances of such accounts, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their accounts into various investment options offered by the Plan.

e. Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's discretionary contributions, plus actual earnings thereon, is based on years of service. A participant vests 20 percent per year of credited service and is 100 percent vested after completing five years of credited service, as defined in the Plan document. A participant becomes fully vested upon death, permanent disability or the attainment of normal retirement age, as defined in the Plan document.

f. Forfeitures

Termination of employment for reasons other than retirement, disability or death results in the forfeiture of the non-vested portion of the participant's account balance. Forfeited balances are used to reduce future Company contributions or pay the expenses of the Plan. During 2024, there were \$14,305 of forfeitures and \$849 of investment income earned. The Plan used \$20,218 to reduce employer contributions. Unallocated forfeiture balances as of December 31, 2024 and 2023 were \$15,154 and 20,218, respectively.

g. Notes Receivable from Participants

Participants may borrow from their accounts an amount not to exceed the lesser of 50 percent of their vested account balance or \$50,000 less certain adjustments, as defined. Loans are secured by the balance in the participant's account, bear fixed interest at a commercially reasonable rate as determined by the Plan Administrator, and are to be repaid over a reasonable period of time not to exceed five years, unless the loan was used to acquire a primary residence. Principal and interest are paid ratably through semi-monthly or monthly payroll deductions or direct monthly payments to the custodian. Loans outstanding as of December 31, 2024 bear interest at rates ranging from 4.50 to 10.50 percent and are due at various dates through October 2049.

h. Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination for other reasons, a participant may elect to receive in the form of (1) a lump-sum distribution equal to the value of his or her vested account balance, (2) installments over a defined period designated by the participant, or (3) a direct rollover to an eligible retirement plan. Prior to termination of employment, certain withdrawals pertaining to death, disability, or hardship are permitted, as provided for in the Plan documents.

i. Administrative Expenses

Administrative expenses of the Plan are paid by the Plan or the Company, as provided for in the Plan documents.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

b. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements applicable to the Plan's investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

c. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan.

2. Summary of Significant Accounting Policies (continued)

d. Contributions Receivable

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Employer contributions are based on the same compensation.

e. Payment of Benefits

Benefits paid to participants are recorded upon distribution.

f. Management's Use of Estimates

The preparation of financial statements in conformity with the accrual basis of accounting requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and changes therein, and disclosure of contingent assets. Actual results could differ from those estimates.

g. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value of participants' account balances and investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompany statements of net assets available for benefits.

h. Subsequent Events

The Plan Administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued, and it was determined that all subsequent events have been properly accounted for.

4. Fair Value Measurements

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for the asset; and inputs that are derived principally from or can be corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

An asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Plan assets are represented by a unit of account and a per unit value whose value is a result of the accumulated value of the underlying investments. The underlying investments include mutual funds. Mutual funds are valued based on quoted market prices of each fund, which represents the net asset value of shares held.

Minnesota Life general account: Valued at contract value which is the most reasonable estimate of fair value, as participant-initiated withdrawals, when allowed under the terms of the contract as described in Note 5, are always made at contract value. Also, while the liquidation charge, if any, is applicable to the general account, it would only apply upon contract termination and should not be taken into account when determining fair value, unless contract termination is probable.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Minnesota Life General Account

The Plan's investment options include the Minnesota Life general account (General Account), investments in which are issued under a group annuity contract between the Plan and MLIC. The General Account is a direct filing entity and following are some features and characteristics of the General Account:

- Current year participant contributions made into the account are credited for earnings based on current market conditions.
- Prior balances of participant contributions are credited for earnings based on the average return from prior Minnesota Life General Account investments.
- Participant withdrawals prior to contract liquidation are made at book value (principal invested plus interest earned).
- A participant may transfer up to 20% of the participant's General Account accumulation value or \$2,000, whichever is greater, out of the General Account once during any 12 month period.
- The General Account assets are invested in the general assets of MLIC and backed by the full faith and credit of MLIC.
- General Account assets are predominately in high quality, fixed income investments (bonds, mortgages, private placements). Average maturity for these assets is near 10 years, average duration is between 5 and 6 years.

MLIC is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The Plan's ability to receive amounts due is dependent on MLIC's ability to meet its financial obligations which may be affected by future economic and regulatory developments.

The General Account is benefit-responsive, in that the full contract value is accessible, but not all at once in the case of certain transfers. The General Account transfer provisions in the contract described above prevent the contract from meeting the definition of fully benefit-responsive, since the participant is not allowed immediate full access to the General Account balance at contract value in all situations. Reasons for withdrawing money from the General Account include participant termination, retirement, death, disability, hardship, loans, contract termination, and participant-initiated transfer between funds. The first six of these types of withdrawals occur at contract value without any conditions, limits, or restrictions. In the case of a contract termination, a market value adjustment and/or liquidation charge may apply.

Certain other events might limit the ability of the Plan to transact at contract value with MLIC. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (3) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with MLIC and that would also limit the ability of the plan to transact at contract value with the participants.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accounts of all participants affected by the termination shall become fully vested and the assets of the Plan would be allocated among the participants and their beneficiaries.

7. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Services (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC and that the Plan continues to be tax-exempt. Hawaii income tax law conforms to the IRC. Therefore, no provision for federal and state income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Plan years from December 31, 2021 are open for examination for federal tax purposes.

8. Exempt Party-in-Interest Transactions

Notes receivable from participants are considered exempt party-in-interest transactions.
