Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Blended Health Services 401(K) Plan (formerly the Addiction Campuses 401(K) Plan), (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statement or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

(1) Description of plan

The following description of the Blended Health Services 401(K) Plan (formerly the Addiction Campuses 401(K) Plan) (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan maintained under Section 401(k) of the internal revenue code and covers substantially all employees of Blended Health Services, LLC, formerly Addiction Campuses (the "Plan Sponsor"). The Plan covers substantially all employees ("participants"). The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Each employee is eligible to participate in the Plan on the earliest monthly entry date, following the date the employee has attained the age of 21.

Effective January 1, 2024, the Plan changed its name to Blended Health Services 401(k) Plan and engaged Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company ("Principal") as the trustee of the Plan.

Effective January 1, 2024, the Connections Wellness 401(k) Plan merged into the Blended Health Services 401(k) Plan, transferring assets totaling \$2,913,073, including notes receivable from participants. The net assets were recognized in the participants' accounts of the Blended Health Services 401(k) Plan as previously carried in the accounts of the Connections Wellness Group 401(k) Plan

(b) Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC") or may be made after-tax in the form of a Roth contribution. Participants direct the investment of their contributions into various investment options offered by the Plan. Participant contributions are permitted up to 90% of eligible compensation subject to certain IRC limitations.

Beginning in May 2023, the Plan Sponsor may make a discretionary matching contribution. However, no matching contribution was made in 2024 and 2023. The Plan provides that the Plan Sponsor may contribute each year a discretionary profit-sharing contribution to the Plan; however, this profit-sharing contribution by the Plan Sponsor is not required. For the years ended December 31, 2024 and 2023, profit-sharing contributions totaled \$424,542 and \$91,577, respectively.

Eligible participants are automatically enrolled in the Plan with a deferral of 3% of eligible compensation, unless the eligible participant elects not to make a deferral or elects to make a higher or lower percentage of elective deferral contribution. Employees that are automatically enrolled will have their deferral percentage increased by 1% each year on January 1, to a maximum of 10%, unless they elect differently.

Plan Sponsor and participant contributions may not exceed the maximum amount allowable for federal income tax purposes.

(c) Participant accounts

Each participant's account is credited or charged with the participant's contributions, Plan Sponsor contributions, allocations of investment earnings or losses and administrative expenses. Allocations are based on a participant's compensation or account balances as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

(d) Vesting

Effective January 1, 2024 Participants are immediately vested in their elective salary deferral, employer's matching contributions, and profit-sharing contributions plus actual earnings (losses) thereon. Prior to January 1, 2024, participants were 20% vested in the Plan Sponsor's discretionary profit sharing contribution after two years of service, with vesting increasing an additional 20% each year thereafter, until participants were 100% vested after six years of credited service. Prior to January 1, 2024, participants were also 25% vested in the Plan Sponsor's matching contributions after one year of service, with vesting increasing an additional 25% each year thereafter, until participants were 100% vested after four years of credited service.

(e) Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes receivable from participants are secured by the balance in the participant's account and bear interest at fixed rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined at the time of the note receivable by the Plan administrator. Principal and interest are paid ratably through payroll deductions in installments over a period not to exceed five years.

(f) Payment of benefits

On termination of service due to death, permanent disability, retirement, or other reasons a participant may take a distribution of his or her entire account balance in a single lump sum or elect to receive annual installments over a specified period. For termination of service due to other reasons, a participant will be entitled to receive only the vested interest in his or her account balance.

(g) Forfeited accounts

If a participant terminates employment prior to being fully vested in the Plan Sponsor's discretionary matching and profit sharing contribution and earnings thereon for any reason except death, disability, or qualification for retirement, then the unvested contributions will be forfeited. Such forfeitures may first be used to pay administrative expenses. Remaining forfeitures, if any, may be used to reduce employer contributions made after the forfeitures are determined. During 2024, forfeitures of approximately \$34,000 were used to reduce employer matching contributions. During 2023, no forfeitures were utilized to reduce employer matching contributions. As of December 31, 2024, there were no forfeited non-vested account balances. As of December 31, 2023, forfeited non-vested accounts totaled \$1,857.

(h) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½.

(i) Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. All reasonable expenses of administration that are incurred by the Plan are charged directly to the applicable participant's accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

(j) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan agreement.

(d) Payment of benefits

Benefits are recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between December 31, 2024 and October 14, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including the fair value of investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest income, and interest on notes receivable from participants for the year ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal as of and for the year ended December 31, 2024 and Reliance Trust Company ("Reliance") as of and for the year ended December 31, 2023

(4) Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- (i) *Mutual funds*: Valued based on the funds' reported closing net asset value ("NAV") as of the last business day of the Plan year end. The funds are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Income tax status

The Plan adopted a non-standardized pre-approved profit sharing plan, which received a favorable determination letter on June 30, 2020, which stated the non-standardized pre-approved profit sharing plan was in compliance with the applicable requirements of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under section 401(a) of the IRC. The Plan is required to operate in conformity with the IRC to maintain its qualification. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Generally accepted accounting principles requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Party-in-interest transactions

As described in Note 1, the Plan paid expenses to various service providers which qualify as party-in-interest transactions. The Plan holds notes receivable from participants which also qualify as party-in-interest transactions.
