## Independent Auditor's Report

To the Plan Administrator

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Gemma Power Systems 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

#### **Note 1 - Description of Plan**

The following description of the Gemma Power Systems 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

##### **General**

The Plan is a defined contribution profit sharing plan effective January 1, 1998, and was most recently amended effective January 1, 2024, covering employees of Gemma Power Systems, LLC; Gemma Power Systems California, Inc.; Gemma Power, Inc.; Gemma Power Hartford, LLC; Gemma Renewable Power, LLC; Gemma Plant Operations, LLC; Argan Inc; and Atlantic Projects Company, Inc. (collectively, the "Company") who have attained the age of 21, so long as they are not leased employees, nonresident aliens who have no earned income from sources within the U.S., residents of Puerto Rico, or employees under a collective bargaining agreement, as defined in the Plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The 401(k) Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Effective January 1, 2024, Argan Inc. 401(k) Plan merged into the Plan from the previous service provider Fidelity.

##### **Contributions**

Contributions consist of safe harbor matching contributions, discretionary employer profit sharing contributions, discretionary employer matching contributions, and voluntary pre-tax employee contributions, subject to certain Internal Revenue Service ("IRS") limitations. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Employee contributions, other than rollovers, are limited to 80% of compensation. Employer safe harbor matching contributions are limited to 100% of the first 3% of compensation plus 50% of compensation that exceeds 3% not to exceed 5% of compensation and discretionary employer matching contributions are limited to 4% of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of both their contributions and employer contributions into various investment options offered by the Plan. Company matching and profit sharing contributions, if any, are recorded annually. The Company made \$1,277,409 of safe harbor matching contributions and \$1,171,282 of discretionary matching contributions in 2024. Voluntary pre-tax employee contributions were made in accordance with the Plan document. Voluntary pre-tax employee contributions are recorded in the period during which the Company makes payroll deductions from participants' earnings.

##### **Participant accounts**

Each participant's account is credited with the participant's contributions, employer safe harbor contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Plan earnings are allocated based on participants' account balances. Any discretionary profit sharing contribution is allocated to participants based on the Plan document. For participants for whom the Plan sponsor is required to make a prevailing wage contribution, the participant's individual account is credited for the required amount as defined by the contract. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their own contributions, prevailing wage contributions and employer safe harbor matching contributions plus earnings credited thereon. For discretionary employer contributions, profit sharing contributions and earnings thereon, employees follow this vesting schedule:

#### Notes receivables from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, and a participant may have up to two loans outstanding at any time. The loans are secured by the balance in the participant's account. The loan interest rate is based upon the prime rate plus one percent, as determined on the 14th of each month. Principal and interest are paid ratably through regular payroll deductions, or other arrangements if necessary.

#### Payment of benefits

On termination of service, participants with a vested account balance greater than \$7,000 may elect to receive a lump-sum amount equal to the value of their account. For participants with a vested account balance that does not exceed \$7,000, the Plan will roll over the distribution to an Individual Retirement Account if the participant does not make an affirmative election to either receive or roll over the distribution. Distributions are subject to the applicable provisions of the Plan agreement.

#### Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$50,773 and \$34,992, respectively. Forfeitures generated are available to offset Company cash contributions, reallocated to participants' accounts or pay Plan expenses in accordance with the Plan agreement. For the year ended December 31, 2024, Plan expenses were offset by \$78,424 from forfeitures and employer contributions were reduced by \$0 from forfeited nonvested accounts.

#### **Note 2 - Summary of accounting policies**

##### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make significant estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment valuation and income recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### **Contributions**

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Matching contributions from the Company are recorded in the year in which the matching contributions is earned.

##### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### **Administrative expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

##### **Payment of benefits**

Benefits are recorded when paid.

##### **Subsequent events**

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

#### Note 3 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

#### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust fund:* Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### **Note 5 - Related party transactions and party-in-interest transactions**

Certain Plan assets include investments in funds managed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. The Plan sponsor pays directly any other fees related to the Plan's operations with the exception of loan administration fees and Plan audit fees.

#### **Note 6 - Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

#### **Note 7 - Tax status**

The prototype plan document, which the Plan has adopted in a nonstandardized adoption agreement, obtained its latest opinion on October 6, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has not yet filed for an individual determination letter. The Plan's adoption agreement has been amended since receiving the opinion letter on the prototype plan; however, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
