#### **Note 1 - Description of the Plan**

The following brief description of the Dennis K. Burke, Inc. Profit Sharing and 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Effective January 1, 2025, the name of the Plan was changed to Dennis K. Burke, Inc. 401(k) Retirement Savings Plan.

**General** - The Plan was established on May 1, 1979 to provide the employees of Dennis K. Burke, Inc. (the Company) a tax effective opportunity to save for their retirement. The Plan is a defined contribution plan covering all employees of the Company who have completed 500 hours of service within a ninety (90) day period, and are age twenty (20) or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan includes a savings plan established under the provisions of the Internal Revenue Code Section 401(k). Under the Plan, a certain amount of employee wages, as defined in the Plan, can be deferred as an employee contribution to the Plan. The Plan document was restated on April 30, 2016. As a result of the restatement, effective May 1, 2016, certain bonus payments, fringe benefits and reimbursements are excluded from eligible compensation for employee deferrals and employer contributions. The Plan document was restated on January 1, 2021. As a result of the restatement, the Plan year changed to a calendar year end.

**Contributions** - Participant contributions are made on a pretax basis through salary deferral agreements with the Company. Participants may contribute up to the maximum percentage, as allowed by law, of annual compensation, as defined in the Plan. Effective May 1, 2016, the definition of eligible compensation was amended to exclude certain bonuses, fringe benefits and reimbursements. Participants may also make after-tax contributions (Roth) into the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions representing distributions from other qualified plans.

The employer contributes a safe harbor matching contribution for all eligible participants. The safe harbor matching contribution is equal to 100% of employee contributions that are not in excess of 3% of eligible compensation plus 50% of the amount of employee contributions that exceed 3% of eligible compensation but that do not exceed 5% of eligible compensation. For the year ended December 31, 2024, the Company made total safe harbor matching contributions amounting to \$528,484.

The Company may also make further matching contributions and profit sharing contributions, both of which are subject to a six-year vesting schedule. To be eligible for the further matching contributions and profit sharing contributions, the participant must have 1,000 hours of service in the plan year and be employed by the Company on the last day of the plan year. Forfeited employer matching and profit sharing contributions may be used to reduce employer contributions or for the payment of plan administrative expenses. There were no further matching or profit sharing contributions made to the Plan for the year ended December 31, 2024.

**Participant Accounts** - Each participant's account is credited with their voluntary salary deferral contributions, employer safe harbor matching contributions, further employer matching contributions, if any, employer profit sharing contributions, if any, earnings, and expenses. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account.

### **Note 1 - Description of the Plan (Continued)**

**Vesting** - Participants are immediately vested in their salary deferral contributions and employer safe harbor matching contributions, plus actual earnings thereon. Further employer matching contributions and profit sharing contributions are subject to a six-year vesting schedule.

**Investment Options** - Upon enrollment in the Plan, and at any time during the plan year, a participant may direct employee contributions, employer safe harbor matching contributions, further employer matching contributions and profit sharing contributions among pooled separate accounts, a stable value fund and mutual funds. Participants may reallocate their investments or redirect new contributions at any time.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the participant's vested interest in the Plan. Principal and interest are paid ratably through payroll deductions. Generally, notes are repaid within five years except for notes relating to the purchase of a primary residence which may exceed five years. The notes bear interest at 1% over the Prime Rate. Participants may have only one note outstanding at a time under the Plan provisions.

**Benefits and Withdrawals** - Upon termination of service, retirement, disability or death, participants or beneficiaries are entitled to a distribution equal to the total value of the participant's vested account. Upon termination of service, a participant may elect to receive the value of the vested account in a lump-sum cash payment, a rollover distribution to an eligible retirement account, or if the balance is greater than \$1,000, elect to defer payment of benefits until a minimum distribution is required to be made. Vested account balances of \$1,000 or less are automatically distributed to the participant in the form of a lump sum payment unless an alternative distribution election is made by the participant. In service withdrawals are allowed upon attainment of age 59 1/2. Withdrawals due to serious financial hardship are allowed to the extent permitted by federal regulations.

**Forfeited Accounts** - Participants who leave the employment of the Company forfeit the non-vested portion of their employer accounts. Forfeitures are retained in the Plan and can be used to reduce future employer contributions or for the payment of Plan administrative expenses. There was no balance in the forfeiture account at December 31, 2024 and 2023. No forfeitures were used to fund the employer matching or profit sharing contributions during 2024.

**Administrative Expenses** - Participants are charged for processing fees on participant notes and distributions. Certain advisory and administrative expenses are paid by the Plan from participant accounts. All other administrative expenses are generally borne by the Company.

**Plan Termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and the assets would be distributed to participants in accordance with the terms set forth in the Plan.

#### **Note 2 - Summary of Significant Accounting Policies**

**Basis of Accounting** - The financial statements have been prepared under the accrual method of accounting in conformity with U.S. generally accepted accounting principles. Benefit payments are accounted for at the time of payment.

**Estimates** - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefit during the reporting period, and disclosure of contingent assets and liabilities, if applicable, at the date of the financial statements. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - All investments are recorded at fair value in these financial statements. Fair value is measured in accordance with U.S. generally accepted accounting principles as more fully described in Note 4. Purchases and sales of securities are recorded on a trade-date basis or if not materially different, the settlement date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Unit Values** - Individual participant accounts for the common investment trust and pooled separate accounts are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the accounts, but do have an interest therein represented by units which are valued daily. The account earns interest which is automatically reinvested in additional units. Generally contributions to and withdrawals from the pooled separate account are converted to units by dividing the amount of such transactions by the unit values as last determined and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Subsequent Events** - The date to which events occurring after December 31, 2024 have been evaluated for possible adjustment to the financial statements or disclosure is the date of the Independent Auditor's Report which is the date the financial statements were available to be issued.

#### **Note 3 - Information Certified**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, at fair value held at December 31, 2024 and 2023, and interest and dividends and realized and unrealized gains, net for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the custodian of the Plan) and Principal Life Insurance Company, on behalf of Principal Global Investors Trust Company.

#### **Note 4 - Fair Value Measurements**

Fair value is defined under U.S. generally accepted accounting principles as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. Valuation techniques used to measure fair value under U.S. generally accepted accounting principles must maximize the use of observable inputs and minimize the use of unobservable inputs. Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Plan's market assumptions. The fair value hierarchy is based on three levels of inputs as follows:

Level 1 - Quoted prices in active markets for identical assets or liabilities.

Level 2 - Observable inputs other than those included in Level 1. For example, quoted prices for similar assets in active markets or quoted prices for identical assets in inactive markets.

Level 3 - Unobservable inputs reflecting management's own assumptions about the inputs used in estimating the value of the assets.

Following is a description of the Plan's valuation methodologies for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### *Mutual Funds*

These investments are public investment vehicles valued using the Net Asset Value ("NAV") provided by the administrator of the fund and calculated at the close of business on the NYSE. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. Investments in mutual funds are classified within Level 1 of the valuation hierarchy.

#### *Pooled Separate Accounts*

These investments are valued on a per unit market value basis as determined by the custodian, which reflects the fair value of the investments comprising the separate pooled fund. As of December 31, 2024 there were no unfunded commitments. Investments can be redeemed daily but limited to one redemption every 30 days. The funds' investment strategies are in accordance with each portfolio's investment objective. The practical expedient has been utilized to estimate fair value of these investments by using the reported net asset value and have not been classified in the fair value hierarchy.

#### *Collective Investment Trust*

The Plan's investments in the collective investment trust are public investment securities valued using the net asset value (NAV) provided by Morley Capital Management. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure the securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments. These investments measured at net asset value per share have not been classified in the fair value hierarchy.

#### **Note 6 - Related Party Transactions**

Certain plan investments including a common investment trust and pooled separate accounts are managed by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the custodian of the Plan. Accordingly, these transactions qualify as party in interest transactions. For the year ended December 31, 2024, maintenance fees and other administrative expenses totaling \$78,822 were charged to participant accounts and paid to the Plan's custodian. The Plan Sponsor elects to pay certain other administrative expenses of the Plan. Notes receivable from participants also qualify as party-in-interest transactions.

#### **Note 7 - Income Tax Status**

The Plan operates under a non-standardized pre-approved profit sharing plan document of CCH Incorporated. This plan document received its latest determination letter on June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

In determining the recognition of uncertain tax positions, the Plan applies a more-likely-than-not recognition threshold and determines the measurement of uncertain tax positions considering the amounts and probabilities of the outcomes that could be realized upon ultimate settlement with taxing authorities. As of December 31, 2024, the Plan has no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan is generally subject to potential examination by taxing jurisdictions for the prior three years. Currently, no audits for any tax periods are in progress.

#### **Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic related issues or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Note 9 - Operational Failure - Participant Loans**

Subsequent to year end, it was discovered that Principal Trust Company (“Principal”), the custodian of the Plan, had configuration errors in its online loan refinancing feature resulting in several participants receiving additional loan funds in excess of the maximum dollar amount allowed. These errors occurred due to omission of the required additional calculations to properly determine the new loan amounts and terms for a refinanced loan. The Plan Sponsor is currently in the process of working with Principal, the Plan’s third-party administrator, and ERISA counsel to determine the proper procedures for corrections to the impacted participants. The Plan Sponsor, under the guidance of the ERISA counsel, believes that these loan failures meet the conditions established to be eligible for the self-correction through the expanded Employee Plans Compliance Resolution System (“EPCRS”) allowed in the SECURE 2.0 Act.
