## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Ascent, LLC 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ascent, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

### Basis for Opinion

**NOTE 1 — DESCRIPTION OF PLAN**

The following description of the Ascent, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Ascent, LLC (the Company) and related adopting employers, who have six months of service and are 21 or older. Effective July 1, 2024, the Plan document was amended to recognize an employee's service with SS&C Technologies, Inc. when determining eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Empower Retirement provides recordkeeping services to the Plan. Empower Trust Company, LLC (ETC) is the custodian of the Plan's pooled separate accounts. Massachusetts Mutual Life Insurance Company (MassMutual) is the issuer of the guaranteed investment contract. The Company is the plan administrator and has overall responsibility for the operation and administration of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance. A member of management serves as the Plan's trustee.

Effective October 31, 2024, the Company was purchased by Wesco International, Inc. It is the intention of Wesco International, Inc. to merge the Plan into the Wesco International, Inc. Section 401(k) Profit Sharing Plan & Trust by December 31, 2025.

**Contributions**

Participants may contribute up to 85% of annual eligible compensation, as defined in the Plan, and designate those contributions as either pre-tax or Roth. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan provides a safe harbor matching contribution which is determined as a percentage of participant elected deferrals. The Company contributes 100% of the first 3% and 50% of the next 2% of compensation that a participant contributed to the Plan. Participant contributions in excess of 5% of compensation are not matched.

Discretionary profit-sharing contributions are determined annually and allocated to participants who have at least one year of service and who are employed on the last day of the year. Profit sharing contributions are allocated to each participant based upon the ratio of the participant's eligible compensation to the total compensation for all eligible participants. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

Contributions are subject to certain limitations. Participants may also transfer funds to the Plan from other qualified retirement plans.

**Investment Options**

Participants of the Plan elect investment accounts in which their contributions, as well as Company contributions, are invested. The investment account options comprise various degrees of risk and return.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, Company matching contributions, an allocation of the Company's profit-sharing contribution, and investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Participants are vested immediately in their contributions, rollovers, and safe harbor matching contributions plus earnings thereon. Vesting in the Company's profit-sharing contributions is based on years of service, as follows:

Less than 1	0%
1	10%
2	20%
3	40%
4	60%
5 and more	100%

Notwithstanding the foregoing, participants become 100% vested in their entire account upon attainment of normal retirement age while an employee, or from death to disability during employment.

**Participant Loans**

Participants may not borrow from their accounts.

**Payment of Benefits**

On termination of service, death, disability or retirement, participants may elect to receive an amount equal to the value of the vested interest in their accounts in either a lump sum amount or in installments, depending on the size of the participant's account balance at the time of termination. Participants with a vested account balance of less than \$7,000 must take a lump-sum distribution. The account of a participant with a vested account balance between \$1,000 and \$7,000 who does not request a distribution will be rolled to an individual retirement account in the participant's name.

**Payment of Benefits (Continued)**

The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals are allowed from all vested accounts and are subject to specific statutory and regulatory requirements.

In-service distributions are permitted from all vested accounts when a participant has attained age 59½.

**Forfeited Accounts**

Forfeited balances of terminated participants' nonvested accounts may be used to pay plan expenses or to reduce Company contributions. There were \$2,856 and \$2,779 unallocated amounts at December 31, 2024 and 2023, respectively.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for its benefit-responsive investment contract, which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Revenue sharing income is presented as other income in the statement of changes in net assets available for benefits. These payments may be used to pay expenses.

**Subsequent Events**

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Pooled separate accounts:* Valued at the NAV of units of the fund, which is based on the readily determined fair value of the underlying investments.

**NOTE 4 — INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Massachusetts Mutual Life Insurance Company (MassMutual), the issuer. On December 31, 2020, Empower Retirement acquired the retirement business of MassMutual. EAIC is the certifying entity of the guaranteed investment contract on behalf of MassMutual under a power of attorney granted to EAIC.

The issuer maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by the issuer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$486,741 and \$537,642, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but not less than 0%. Such interest rates are reviewed on a monthly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participant are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 5 — INFORMATION CERTIFIED BY CUSTODIAN AND INSURANCE COMPANY**

Information related to investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended December 31, 2024, disclosed in the accompanying financial statements and supplemental schedules, was obtained or derived from data provided to the plan administrator and certified to as complete and accurate by ETC and MassMutual under the power of attorney granted to Empower Annuity Insurance Company of America (EAIC).

**NOTE 6 — PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

**NOTE 7 — TAX STATUS**

As this Plan is a prototype defined contribution plan, the IRS issued an opinion letter dated June 30, 2020, stating that while they do not issue a determination as to whether a specific employer's plan is qualified, any employer who adopts this plan document will be considered to have a plan qualified under code Section 401(a) of the Internal Revenue Code (IRC) provided all the terms are not more favorable for officers, owners, or highly compensated employees than for other employees. Management believes that the Plan is operating in compliance with all the terms provided in the nonstandardized plan agreement. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan is subject to examination by the IRS for the statutory period.

**NOTE 8 — RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 — PARTY-IN-INTEREST TRANSACTIONS**

Certain investments are managed by MassMutual and EAIC. These transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as these are not direct payments by the Plan.

**NOTE 10 — DELINQUENT CONTRIBUTIONS**

During the years ended December 31, 2024 and 2023, the Company failed to remit to the Plan's custodian certain employee contributions totaling \$111,025 and \$93,791, respectively, within the amount of time prescribed by the Department of Labor. The Company fully corrected the 2023 delinquent contributions in October 2024 and intends to fully correct the 2024 delinquent contributions in October 2025.
