Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Akshaya Inc. 401K Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1) DESCRIPTION OF THE PLAN

The following description of the Akshaya Inc. 401K Plan (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description and the Plan Document for a complete description of the Plan's provisions.

General

The Plan was established on January 1, 2014 as a defined contribution profit sharing plan. The Plan covers all employees of Akshaya Inc. (the Company). Employees are entered into the Plan on the first day of the month. The plan offers two kinds of elective deferrals: Pre-Tax Elective deferrals and Roth Elective Deferrals. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants, through an election to defer compensation, may contribute to their individual accounts from 1% to 90% of eligible earnings not to exceed the limits established by Internal Revenue Code, subject to certain limitations as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover amounts representing distributions from other qualified benefit plans. The Company may elect to make a matching contribution to the Plan although the Company is not required to make this contribution. Participants must make elective deferrals to the Plan to receive the matching contribution. In addition, the Company may elect to make non elective contribution. However, the Company did not make any matching or non-elective contributions during the year 2024 and 2023.

Vesting

Participants are always fully vested in their elective deferral and rollovers, if any. For the purpose of matching contributions and non-elective contributions account, the following vesting schedule is used:

Participants may elect to invest in any combination of the funds offered by the Plan and may change their elective deferral percentage any time. Each participant's account is credited with the participant's contributions, Company matching contributions (if any) with the Company's non-elective contributions (if any) and accumulated earnings thereon and will be tax-deferred until participants receive the distribution. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the participant's earnings, account balances, or specific participant transactions, as defined.

Distributions

The Plan generally provides that upon reaching the normal retirement age of 65, death, disability or termination, participants are entitled to receive the value of their account in one lump sum payment of cash if the individual account is less than \$1,000. If the value of the individual account exceeds this amount the participants may elect to keep it in the Plan, however the benefit must begin to be distributed no later than April 1st of the calendar year following the later of the participant attaining the age of 73 or the calendar year in which the participant retires. The participant may rollover their entire vested balance to individual retirement account or to another employer's tax qualified plan. In the event of financial hardship, participants may withdraw from their account.

Notes Receivables from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years and longer repayment terms are permitted for the purchase of a principal residence. The loans are secured by the balance in the participant's account. The interest rate for a loan will be the rate in effect in the month the loan is effective. The interest rate is the prime rate as published in the Wall Street Journal on the 14th of each month plus two percentage points. Principal and interest is paid ratably through payroll deductions.

Forfeitures

At December 31, 2024 and 2023, there were no forfeited non-vested account balances.

The financial statements of the Plan are prepared using the accrual basis of accounting.

2) SIGNIFICANT ACCOUNTING POLICIES (Continued)Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. Notes Receivable from Participants as of December 31, 2024, and December 31, 2023, are \$119,222 and \$80,220 respectively.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, trustees and insurance company. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

2) SIGNIFICANT ACCOUNTING POLICIES (Continued)Excess Contribution Payable

Amounts payable to participants or contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding corrective distribution expense. The Plan had no excess contribution payable as of December 31, 2024, and 2023.

3) CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution, (the trustee of the Plan).

4) FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the assets or liabilities.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is the description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds (Registered Investment Companies) – Valued at daily closing prices as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust – Valued at the NAV of units held by the Plan at year end, which is considered by Plan management to be the best approximation of fair value.

Self-Directed Brokerage Account – Hold common stocks, an exchange traded fund, and cash funds are valued at the closing price from the active market.

5) INCOME TAX STATUS

The Plan is a prototype plan. The prototype plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the prototype plan, as designed, is qualified for federal income-tax exempt status. The Plan has not individually sought its own determination letter.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or assets) if the Plan has taken any uncertain positions that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

6) RELATED PARTY TRANSACTIONS AND PARTIES-IN-INTEREST TRANSACTIONS

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Fees paid by the Plan for trustee services were \$2,485 and \$1,225 for 2024 and 2023, respectively.

7) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

8) ERISA BOND REQUIREMENTS

The Employee Retirement Income Security Act of 1974 (ERISA) requires that every person who handles funds or other property of the Plan be bonded. The bond coverage is to be determined by the balance of the total plan assets and is required to be at least equal to the lesser of 10% of the plan's assets at the beginning of the plan year or \$500,000. At December 31, 2024 and 2023, the Plan's sponsor maintained the required bond coverage.
