### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Chase Industries, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). #### Note 1. Description of the Plan

The following brief description of the Chase Industries, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan sponsored by Chase Industries, Inc. (the Company) for the benefit of its employees who have at least three months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Under terms of the Plan, eligible associates (other than nonresident aliens and residents of Puerto Rico) with at least three months of service may participate in the Plan. Participants are automatically enrolled in the Plan with an elective pre-tax deferral rate of 4% of compensation, increasing each January 1 thereafter by 1% until such elective deferral rate is 10% of compensation, unless the participant affirmatively elects out of the automatic deferral feature, elects a different deferral rate or elects not to participate in the Plan. Effective October 1, 2024, the automatic enrollment was increased to 6%. Each year, participants may contribute up to 90% of pre-tax annual compensation, as defined in the Plan. The amount of participant's contributions for any Plan year may not exceed certain limits set by the Plan document and the Internal Revenue Code (IRC). Contributions may be pre-tax, after-tax or a combination of both, subject to Internal Revenue Service (IRS) 401(k) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and a guaranteed investment contract as investment options for participants. The Company may make discretionary matching contributions as determined by the Board of Directors. The Company's matching contribution for non-union employees is 50% of employee's salary deferral amounts up to 6% of employee's eligible compensation. The Company's matching contribution for union employees is 50% up to 3% of employee contributions. The Company may also make a discretionary profit-sharing contribution to the Plan, which was \$0 for the year ended December 31, 2024.

**Participant accounts:** Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's matching contribution, (b) the Company's profit-sharing contribution and (c) Plan earnings and losses, including an allocation of administrative expenses. Allocations are based on participant compensation or account balances, in accordance with the method described in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions and earnings thereon. Vesting in employer contributions along with the earnings thereon is based on years of continuous service, where a year is defined as one in which an employee works 1,000 or more hours.

#### Note 1. Description of the Plan (Continued)

**Notes receivable from participants:** The Plan includes a provision allowing participants to borrow funds from the Plan. Under the terms of this provision, borrowings are subject to certain limitations, including a minimum borrowing of \$500 and a maximum borrowing not to exceed the lesser of \$50,000 or 50% of the participant's vested account balance. The notes receivable are secured by the balance in the participant's account. The maximum loan term is five years unless the loan is taken for the purchase of a primary residence where the loan term shall not exceed ten years. The interest rate charged on the outstanding notes receivable balances are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

**Payment of benefits:** A participant may receive the value of his or her vested account upon retirement, disability or termination in a lump-sum distribution. Upon death of a participant, the beneficiary shall be entitled to the full value of the account. Hardship withdrawals, as defined in the Plan, are also available to participants.

**Forfeitures:** Forfeited non-vested accounts are used to pay Plan expenses or reduce future employer contributions. Forfeited non-vested accounts totaled approximately \$50,000 and \$39,000 at December 31, 2024 and 2023, respectively. Employer contributions were reduced by approximately \$42,000 from forfeited non-vested accounts during the year ended December 31, 2024.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

**Contributions:** Participant contributions and employer matching contributions are recorded in the year in which the participant compensation is earned. The Company calculates and funds the matching contribution on an annual basis and remits the employer matching contributions after the plan year end. In addition, the Plan requires participants to be employed at plan year end to share in the employer match. Discretionary employer contributions are recognized when declared by the employer.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** Administrative expenses may be paid by the employer or the Plan, at the Company's discretion.

**Risks and uncertainties:** The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Standard also certified to the completeness and accuracy of \$4,122,237 of net appreciation in the fair value of investments and \$41,036 of interest and dividends related to the aforementioned assets for the year ended December 31, 2024.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted process for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Pooled separate accounts:** Valued at the net asset value per share based on quoted market prices of the underlying investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5. Guaranteed Investment Contract with Insurance Company

The Plan has a traditional investment contract with Standard. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the traditional investment contract at December 31, 2024 and 2023, was \$1,626,612 and \$1,375,093, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting. The contract does permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC
2. The Plan's total investment in the contract falls below an amount specified in the contract
3. Premature termination of the contract
4. Plan termination or merger
5. Changes to the Plan's prohibition on competing investment or other Plan provisions that have an adverse effect on the investment
6. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. Contract value approximates fair value at December 31, 2024 and 2023.

#### **Note 6. Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

#### **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

#### **Note 8. Party-in-Interest Transactions**

Certain Plan investments held during the year are shares of the guaranteed investment contract managed by Standard. Standard is the custodian, as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. During 2024, the Plan paid administrative fees that totaled approximately \$115,597 to Standard and other parties.
