### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the GONNELLA RETIREMENT SAVINGS PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the GONNELLA RETIREMENT SAVINGS PLAN's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Empower Trust Company, LLC, a qualified institution, as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the GONNELLA RETIREMENT SAVINGS PLAN and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the GONNELLA RETIREMENT SAVINGS PLAN's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

**NOTE 1—DESCRIPTION OF PLAN**

The following description of the Gonnella Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**GENERAL**

The Plan is a defined contribution plan covering all eligible employees of Gonnella Baking Company (the "Company" or "Employer") whose employment is not governed by collective bargaining agreements, who are not leased employees, who are eligible employees at Gabby's Bagels Inc. and others who are not considered to be actual employees. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA). Employees must meet minimum service requirements.

**CONTRIBUTIONS**

**Salary Deferral Contributions** – Employees who have completed six months of service can participate in the Plan and make elective pre-tax or ROTH salary deferral contributions subject to annual IRS limits. The Company automatically begins a 3% deferral of gross pay for newly eligible employees. Deferral rate increases by 1% each Plan Year until it reaches 10% of employee's compensation. Participants age 50 or older before year end are permitted to make catch-up contributions to the Plan. The additional contribution is permitted once the participant's maximum contribution has been reached.

**Employer Safe Harbor Non-elective Contributions** - In order to simplify the administration of the Plan by ensuring that nondiscrimination regulations are met, the Company will make contributions equal to 3% of eligible employees' compensation. This contribution is 100% vested immediately. The Safe Harbor contribution amounted to \$873,363 and \$795,968 for the years ended December 31, 2024 and 2023, respectively.

**Profit Sharing and Matching Contributions** - The Company reserves the right to make profit sharing or matching contributions each year and allocate it to participants' accounts based on a formula defined in the Plan Document. This contribution is 100% vested after 3 years of service. The Company elected to make a discretionary Profit Sharing contribution of \$980,723 and \$710,201 for the years ended December 31, 2024 and 2023, respectively.

**Rollover Contributions** - A new employee may elect to directly roll over funds from a prior employer's qualified plan as described in Code section 401(a) or 403(a). However, if the rollover is a cash distribution, the trustee must receive the distribution within 60 days of the disbursement. All rollovers are subject to the consent of the Plan administrator and the terms stipulated by the Plan. Nonetheless, the employee must still meet the Plan's eligibility requirements and will be unable to make an employee contribution until qualified. Rollover contributions received were \$1,794,634 and \$351,502 for the years ended December 31, 2024 and 2023, respectively.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contributions, the Company's Safe Harbor contribution, an allocation of the Company's elective profit-sharing contribution, and plan earnings. Earnings are allocated based on account balances.

## NOTES TO FINANCIAL STATEMENTS

**NOTE 1—DESCRIPTION OF PLAN (Continued)**

## INVESTMENT OPTIONS

Participants direct the investment of their account balance and future contributions into various investment options offered by the Plan. Upon enrollment in the plan, a participant may select any combination of investment options consisting of registered investment companies (mutual funds). If no selection is made, the contribution is invested in the age-appropriate Vanguard Target Retirement fund. Participants may change their investment options at any time.

## LOANS TO PARTICIPANTS

Loans are not permitted from the Plan.

## PAYMENTS OF BENEFITS

Upon termination of employment, participants with vested balances below \$5,000, a lump-sum distribution will be made in accordance with the plan document. Participants with vested balances above \$5,000 may elect to receive a lump-sum distribution of his/her entire vested account balance, a partial lump-sum, or an installment distribution in accordance with the Plan Document. Participants who are still employed by the Company have an option to request a hardship distribution.

## FORFEITURES

Forfeitures are used to pay Plan expenses, and to reduce employer discretionary contributions. Additionally, forfeitures could be used to restore the non-vested portion of the account balance for Participants who resume employment with the Company within certain time limits. Forfeitures totaled \$23,245 for 2024 and \$11,412 for 2023. Forfeitures were used to pay plan expenses were \$15,940 for 2024 and \$2,048 for 2023. No forfeiture was used to reduce the Employer's discretionary contribution for 2024 or 2023. Forfeitures available for future use are \$19,939 as of December 31, 2024 and \$11,946 as of December 31, 2023.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

## BASIS OF ACCOUNTING

The financial statements of the Plan are prepared under the accrual method in accordance with accounting principles generally accepted in the United States of America.

## USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

## NOTES TO FINANCIAL STATEMENTS

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

## RISKS AND UNCERTAINTIES

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the financial statements.

## INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are stated at fair value as established under ASC 820, Fair Value Measurements and Disclosures. The fair values of these assets are determined by reference to the funds' Net Asset Value (NAV). Portfolio valuation procedures for these accounts are determined by the mutual fund company. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

## PAYMENT OF BENEFITS

Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who had elected to withdraw from the Plan, but have not been paid at December 31, 2024 and 2023.

## ADMINISTRATIVE FEES AND EXPENSES

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

**NOTE 3—FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

## NOTES TO FINANCIAL STATEMENTS

**NOTE 3—FAIR VALUE MEASUREMENTS (Continued)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Level 1 Fair Value Measurements*

Mutual funds are valued at quoted net asset values of the shares held by the Plan at year-end.

*Level 2 and Level 3 Fair Value Measurements*

Level 2 and Level 3 Fair Value Measurements are not applicable to the Plan for 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

Money market funds are valued at the net asset value ("NAV") of shares held by the Plan at year-end. NAV is determined by each fund's trustee based on the fair value of the underlying securities held less liabilities held by the fund. This practical expedient is not used when it is determined to be provable that the fund will sell the investment for an amount different than the reported NAV. Plan transactions (issuance and redemptions) may occur daily. There are no restrictions on a participant's ability to redeem investments. However, withdrawals prompted by certain events (e.g., termination of the managed income portfolio, changes in laws and regulations) may restrict a participant's ability to redeem the investment at its NAV.

**NOTE 4—INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, a trustee of the Plan, has certified that the following data included in the accompanying financial statements and schedule is complete and accurate.

- a. Investments, as shown in the accompanying statements of assets available for benefits as of December 31, 2024 and 2023.
- b. Investment income, as shown in the accompanying statements of changes in assets available for benefits for the years ended December 31, 2024 and 2023.
- c. The schedule of assets (held at end of year) as of December 31, 2024, as shown on Schedule H - Line 4(i).

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to related information included in the financial statements and supplemental schedule.

**NOTE 5—PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of a plan termination, participants will become 100 percent vested in their accounts.

**NOTE 6—PARTY-IN-INTEREST TRANSACTIONS AND RELATED PARTY**

The Company provides to the Plan certain accounting and administrative services for which no fees are charged. In addition, some expenses of the Plan are paid by the Company.

Plan investments are managed by the trustee of the Plan. The Plan's third-party administrator is Empower Trust Company, LLC, which is considered a party-in-interest.

**NOTE 8—PLAN QUALIFICATION**

The Plan has adopted the Empower Retirement, LLC Prototype Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA. The Empower plan has obtained an opinion letter from the Internal Revenue Service dated September 16, 2022, stating that the prototype plan is acceptable for use by employers for the benefit of their employees under Internal Revenue Code (IRC) Section 401. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan presently meets the requirements of Section 401(a) of the Internal Revenue Code and, accordingly, its income is exempt from federal income taxes under Section 501(a). A similar status exists for Illinois income taxes.

**NOTE 9—TRANSFER OF ASSETS FROM OTHER INSTITUTE AND UNALLOCATED PLAN ASSETS**

The Company also sponsored a defined benefit plan, the Gonnella Pension Plan (the defined benefit plan). Effective November 30, 2023, the Board approved the termination of the defined benefit plan. All participants of the defined benefit plan were notified of their distribution options, and all participant balances were fully distributed by May 1, 2024.

On November 7, 2024, the remaining \$5,271,782 balance of the defined benefit plan was transferred to the Gonnella Retirement Savings Plan. The Company intends to retain these funds within the Plan, separate from Participant Plan Assets, and utilize the balance to fund the Safe Harbor and Profit Sharing contributions.

The Company applied \$1,854,086 of these transferred funds towards the 2024 Safe Harbor and Profit Sharing contributions. As of December 31, 2024, the remaining balance of funds transferred from the defined benefit plan is \$3,417,676.
