Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of

NATIONAL BOILER SERVICE, LLC 401(k) PLAN

an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it permissible in the circumstances, has elected to have the audit of National Boiler Service, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

Year Ended December 31, 2024

(1) Description of the Plan

The following description of the National Boiler Service, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all eligible employees of National Boiler Service, LLC and Alloy Cladding Company, LLC (collectively the "Company" or "Plan Sponsor") who have completed one year of eligibility service, at least 1,000 hours of service, and attained the age of 21 for the Elective Deferral Contributions, Employer Matching Contributions, and the Non-Elective Contributions. The Plan was established with an effective date of January 1, 2024, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Employees of Alloy Cladding Company, LLC who were employed on April 15, 2024 and had satisfied the Plan's age and service requirements were immediately eligible to participate in the plan. The Plan was amended and restated effective April 11, 2024.

Contributions - Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan agreement, subject to limitation as to amount under the provisions of the Internal Revenue Code ("IRC"). Elective deferrals can be made in whole percentages of compensation or in specific dollar amounts, not to exceed \$23,000 for 2024. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions not to exceed \$7,500 for 2024. Participants may also contribute amounts representing distributions ("rollover assets") from other qualified plans. The Company can make discretionary matching contributions in an amount determined by the Plan Sponsor. The Company may make a nonelective contribution to the Plan at the discretion of the Company's management. The Plan Sponsor recorded matching contributions totaling \$147,952 in 2024. The Company did not make any additional nonelective discretionary contributions in 2024.

Participant accounts - Each participant's account is credited with the participant's pre-tax 401(k) contributions, and an allocation of (a) the Company's matching contribution, (b) Plan earnings (losses), including unrealized appreciation (depreciation), and (c) forfeited balances of terminated participants' non-vested accounts, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their elective deferral, rollover contribution, and qualified non-elective contribution amounts plus actual earnings. For employer matching contributions, non-elective contribution accounts and earnings, an employee is 100% vested after six years of credited services.

Forfeited accounts - Forfeitures of terminated participants' may be allocated in any manner at the discretion of the Plan administrator. Forfeited non-vested accounts totaled \$-0- as of December 31, 2024.

(1) Description of the Plan (continued)

Notes receivable from participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loans fund. A participant may have no more than two loan outstanding from the Plan. Loan terms range from 1 to 5 years with certain exceptions for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate during the month the loan is effective plus 2%, which ranged between 10.00% and 10.50% for the year ended December 31, 2024.

Investment options - The Plan offers several investment options and participants may instruct the trustee in how they want to invest their funds without regard to their vested interest. Participants may change their investment options and move money from one fund to another in accordance with rules established by the Plan Administrator.

Payment of benefits - Upon termination of service due to death, disability, retirement, or other reasons, a participant or beneficiary will receive an amount equal to the vested interest in the participant's account. This payment will be in the form of a lump-sum distribution of their total account balance. Participants may defer receipt of their distribution until a later date. However, it cannot be postponed if their vested account balance is \$5,000 or less in which case the Plan Administrator will direct the Trustee that any account exceeding \$1,000 be distributed to an Individual Retirement Account or Annuity ("IRA") for the participant's benefit. If their vested account balance is \$1,000 or less, the Plan Administrator will direct the Trustee to distribute it as a lump sum distribution without participant consent. Prior to such distribution, participants have the right to request that the amount be distributed directly as a lump sum payment or to request that it be rolled-over to a different IRA provider or another retirement plan eligible to receive rollover contributions. Distributions from the Plan will normally be subject to income taxes and in certain circumstances may also be subject to IRS penalties unless the distribution is transferred to another qualified plan or IRA.

Administration - The Plan Sponsor serves as the Plan Administrator. The Plan Administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan, and making determinations regarding questions, which may affect eligibility for benefits. For the year ended December 31, 2024, the Plan Sponsor engaged The Retirement Advantage, Inc. ("TRA") as a third-party administrator to assist in the administration of the Plan. The Plan Sponsor has assigned John Hancock Life Insurance Company ("John Hancock") as the trustee of the Plan. John Hancock receives all contributions made under the Plan, holds plan assets, pays benefits to participants, and assists in the administration of the Plan.

Plan expenses - Substantially all Plan administrative expenses are paid by the Company.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Investment valuation and income recognition - The Plan’s investments are stated at fair value in accordance with Financial Accounting Standards Board (“FASB”), Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement and Disclosures*, as more fully described in Note (3).

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The market value of pooled separate accounts is determined by the quoted market prices of the underlying funds.

Purchases and sales of securities are recorded on the trade date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investment income - Investment income consists of interest, dividends, gains on sales of securities and the unrealized appreciation (depreciation) in fair market values of investments. Net appreciation in the fair value of investments includes the Plan’s gains (losses) on investments bought and sold, as well as held, during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Risk and uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Payment of benefits - Benefits are recorded when paid.

Estimates - The preparation of the financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative expenses - Administrative expenses of the Plan are paid out of the assets of the Plan unless paid by the Plan Sponsor, as defined in the Plan document. These expenses include, but are not limited to, legal and accounting fees. However, individual transaction fees for withdrawals or notes receivable from participants are paid from the participant’s account. A proportionate share of fees and expenses paid by the Plan is charged to each participant’s account.

(3) Fair value measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of inputs used to measure fair value under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Interest bearing cash and pooled separate accounts: These investments consist of various publicly traded money market funds and pooled assets. The fair values are based on quoted market prices in active markets and therefore are classified as Level 1 investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Plan termination

The Company intends to continue the Plan indefinitely for the benefit of its employees, but reserves the right to amend, modify, or terminate the Plan at any time or for any reason subject to the terms of ERISA. In the event the Plan terminates, the participants will be entitled to the full amounts in their account as of the date of termination, regardless of their percent vested at the time of the Plan's termination.

(6) Tax status

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the IRC and accordingly, the trust's net investment income is exempt from income taxes. The Plan received a favorable tax determination letter from the Internal Revenue Service ("IRS") on June 30, 2020. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Excess contributions

Corrective distributions of \$10,629 for the year ended December 31, 2024, were made to certain active participants to return to them excess deferral contributions and forfeitures on distributed balances. The amounts payable for contributions in excess of amounts allowed by the IRS are recorded as corrective distributions due to participants in the statement of net assets available for benefits. The Plan distributed the 2024 excess contributions in the 2025 plan year.

(8) Fidelity bond coverage

ERISA Code Section 412 requires the Plan to maintain fidelity bond coverage in an amount equal to the lesser of 10% of the total funds in the Plan as of the preceding plan year or \$500,000. The Plan has sufficient bond coverage as of December 31, 2024.

(9) Party-in-interest transactions

Certain Plan investments are shares of pooled funds managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the trustee as defined by the Plan agreement and, therefore, those transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services totaled \$23,724 for the year ended December 31, 2024.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(10) Prohibited transactions

The Plan Sponsor deducted, via payroll withholdings, \$6,777 during the year ended December 31, 2024, from participants gross wages that were not remitted in a timely manner to the plan in accordance with DOL regulations. The correction of the amounts and the related lost earnings for the participants are pending with the Plan Sponsor.

(11) Subsequent events
