INDEPENDENT AUDITOR'S REPORT

To the Trustees of
Kornit Digital North America Inc. 401k Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kornit Digital North America Inc. 401k Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kornit Digital North America Inc. 401k Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Kornit Digital North America Inc. 401k Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE 1: PLAN DESCRIPTION

The following brief description of the Kornit Digital North America, Inc. (the "Company") 401k Profit Sharing Plan (the "Plan") is for general information only. Participant should refer to the plan document for a complete description of the Plan's provisions.

The Plan is a qualified profit sharing plan established on July 1, 2008, which has been amended and restated effective May 1, 2022. The Plan covers eligible employees of the Company and is subject to the provision of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility:

Employees are eligible to participate in the Plan and receive employer matching contributions upon the first day of the following month upon hiring date and upon the attainment of 21 years of age.

Contributions:

The Plan provides each participant with an opportunity to make elective pre-tax contributions and/or Roth elective deferrals to the Plan, up to 90% of compensation, and subject to the limitations of the Internal Revenue Code ("IRC"). Eligible employees are automatically enrolled at a rate of 4% after 45 days from their hire date unless they opt out within the 45-day period. The Company is required to make safe harbor matching contributions equal to 4% of their eligible contributions. The Company may also make a discretionary matching contribution and or profit sharing contribution in accordance with the provisions contained in the plan document. No employer discretionary match contributions and profit sharing contributions were made for the year ended December 31, 2024.

Vesting:

Participants are fully vested in their own contributions and safe harbor matching contributions, plus earnings thereon. Vesting in the Company's discretionary profit sharing or employer matching contribution is based on years of service as follows:

Forfeitures:

Forfeitures, plus earnings thereon, can be used to reduce plan administrative expenses or future employer contributions. Total forfeitures were \$1 for the year ended December 31, 2024. As of December 31, 2024, and 2023, the forfeitures balance was \$11 and \$10, respectively.

Participants Accounts:

Each participant's account is credited with their contributions, employer contributions, and the earnings thereon. Contributions to the Plan are invested by the custodian as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the plan document.

Notes Receivable from Participants:

Participants are permitted to borrow from their accounts a minimum of \$1,000 and up to the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the balance of the participant's account and bear interest at rates similar to those charged by commercial lenders under similar terms. The maximum term of the loan is five years unless the loan is used to purchase a principal residence. Loans are repaid through payroll deductions according to due dates specified in the individual promissory note. Loans are measured at their unpaid principal balance plus any accrued, but unpaid interest. As of December 31, 2024, the interest rates on the outstanding notes receivable from participants ranged from 5.25% to 10.50%.

Benefits:

In the event of death, disability, retirement or termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or an annuity as specified by the Plan. Vested account balances less than \$5,000 upon termination may be distributed without the participant's consent in a lump-sum.

Rollover:

An employee may rollover distributions from a former employer's qualified plan to the Plan, regardless of eligibility if it has been determined by the plan administrator to be an "eligible rollover distribution" as defined by the Internal Revenue Code ("IRC").

Administrative Expenses:

All transaction fees are paid from participants' accounts. Substantially all other administrative expenses of the Plan are paid by the Company.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period, and when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments Valuation and Income Recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Payment of Benefits:

Benefits are recorded when paid.

Subsequent Events:

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023,
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024,
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

NOTE 4: FAIR VALUE MEASUREMENTS

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Valuation techniques used to measure fair value are defined as follows:

- Level 1 - Unadjusted quoted prices in active markets for identical investments.
- Level 2 - Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Significant unobservable inputs, including the Plan's own assumptions in determining the fair value of investments.

The asset and liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

- Mutual funds: Valued at fair value based on quoted prices in an active market for each share held by the Plan.
- Money market funds: Valued at fair value based on current market values of the underlying assets of the fund.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodology used at December 31, 2024 and 2023.

NOTE 5: PARTIES-IN-INTEREST TRANSACTIONS

During the year ended December 31, 2024, Reliance Trust Company was the trustee as defined by the Plan. Administrative expenses paid by the Plan to the custodian qualify as a party-in-interest transaction. Additionally, fees paid during the year to Stifel Nicolaus & Co, the investment advisor of the Plan, and to Automatic Data Processing, Inc (“ADP”), the record-keeper of the Plan, also qualify as parties-in-interest transactions. Total administrative expenses paid by the Plan to parties-in-interest amounted to approximately \$71,200 for the year ended December 31, 2024.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan in whole or in part at any time subject to the provisions set forth in the Employer Retirement Income Security Act of 1974 (“ERISA”). Upon termination, partial termination or complete discontinuance of contributions under the Plan, all participants become fully vested in their individual accounts.

NOTE 7: TAX STATUS

Although the Plan has not requested a determination from the Internal Revenue Service (“IRS”) as to the Plan’s tax-exempt status, the master prototype plan from which the Plan was drafted has received a favorable opinion letter from the IRS dated October 6, 2020. The Plan administrator believes that the Sponsor has operated the Plan in a manner that did not jeopardize this tax status.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of both December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8: RISK AND UNCERTAINTIES

The Plan's investments are concentrated in funds that invest in marketable securities. Such securities are subject to various risks that determine the value of the funds. Due to the level of risk associated with certain securities and level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

NOTE 9: RECONCILIATION OF THE FINANCIAL STATEMENTS TO FORM 5500

For the Plan year ended December 31, 2024 and 2023, the Form 5500 was prepared on the cash basis and the financial statements were prepared on an accrual basis.
