### **Basis for Opinion**

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

1. Description of plan

The following description of the O'Reilly Hospitality Management, LLC 401(k) Plan ("Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

a. General

The Plan, established January 1, 2013, is a defined contribution plan covering all eligible employees of O'Reilly Hospitality Management, LLC ("Company"). The Company manages hotels and restaurants in multiple states across the country. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Eligibility

Effective January 1, 2018, employees are eligible to join the Plan after 6 months of service. The Plan entry date is the first day of the month following the eligibility date.

c. Contributions

Each year, participants may contribute a percentage of pretax or after tax annual compensation to their account. Effective January 1, 2019, the Company is required to make a safe harbor match of 100% of the first 3% of employee contributions plus 50% of contributions that exceed 3% of compensation, but not to exceed 5% of the employee compensation. The Company may also make a discretionary match, not to exceed 4% of the plan year compensation.

The Plan allows rollover contributions from other qualified plans in accordance with applicable laws and regulations. The total amount of participant and employer contributions that can be made during a year is subject to certain Internal Revenue Code (IRC) limitations.

d. Qualified Automatic Contribution Arrangement

Effective January 1, 2019, the Plan entered into a qualified automatic contribution arrangement.

The Qualified Automatic Contribution Arrangement (QACA) is set at 6% of compensation deducted as pre-tax deferrals with no scheduled increases. Permissible withdrawals are not allowed.

1. Description of plan (continued)

e. Participants' accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan. Participant's accounts are charged for specific services used. Investment advisory fees are allocated to participant accounts, and are based on the value of each participant's account balance.

f. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon.

Vesting in the Company's required safe harbor matching portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after two years of credited service.

The vesting schedule is as follows:

Vesting in the Company's discretionary matching portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after six years of credit service.

The vesting schedule is as follows:

6	100%

To be credited a year of service, participants must have worked at least 1,000 hours during the year.

g. Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a joint or survivor annuity. If terminated for any reason other than death, disability or retirement, a participant may receive the value of vested interest in his or her account as a lump-sum distribution. In-service distributions are required minimum distributions and hardships withdrawals. All non-vested contributions will be forfeited.

1. Description of plan (continued)

h. Forfeited accounts

Forfeited balances remaining from non-vested accounts remain in the Plan and may be used to pay plan expenses and reduce employer contributions. For the years ended December 31, 2024 and 2023, forfeitures available to be used are \$217,523 and \$204,694, respectively.

During the year ending December 31, 2024, \$62,063 of forfeitures were available to be used to pay for Plan expenses or to reduce employer contributions.

i. In-service withdrawals

Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to the participant's elective deferrals.

Participants who have obtained the age of 59½ are allowed to receive a distribution of all or any portion of their vested account balances in a single sum payment.

j. Parties-in-interest

Capital Bank and Trust Company is the trustee/custodian of the Plan's investments and executes transactions therein. Empower Trust Company, LLC is the Third Party Administrator, responsible for administrating and processing aspects of the Plan. Benefit Plans Plus LLC is the Third Party Administrator. ADP is the payroll provider. The Plan sponsor is O'Reilly Hospitality Management, LLC (the Company). The Company's owner, Tim O'Reilly, is the Plan administrator. Roberts, McKenzie, Mangan and Cummings, PC is the independent auditor. Each of these entities/individuals are classified as parties-in-interest with respect to the Plan.

2. Summary of significant accounting policies

The following are the significant accounting policies followed by the Plan:

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

2. Summary of significant accounting policies (continued)

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

3. Information prepared and certified by qualified institution

The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for December 31, 2024, and the accompanying notes to the financial statements were prepared in part from information certified by the Trustee in accordance with 29 CRF 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes investments in mutual funds of \$11,165,102 and \$8,755,694 at December 31, 2024 and 2023, respectively, and related investment income of \$1,285,689, for the year ended December 31, 2024.

4. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

5. Administrative costs

During the year ended December 31, 2024, the Plan paid administrative costs of the plan of \$138,273. These administrative costs include recordkeeping and investment advisory fees. All other costs are paid by the Plan sponsor.

6. Tax status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax exempt.

6. Tax status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Fair value measurements

FASB ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds):* Valued at the net asset value (NAV) of shares held by the Plan at year end.

7. Fair value measurements (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Separated participants

At December 31, 2024, \$248,351 of the net assets available for benefits are for those participants who have separated from active service with the Plan sponsor.

10. Subsequent event

The Plan has evaluated subsequent events through October 11, 2025, the date which the financial statements were available to be issued. There were no significant events noted that did not exist at the date of the statements of net assets available for benefits but arose subsequent to that date.
