INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants
of the Flexton, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Flexton, Inc. 401(k) Plan, (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Flexton, Inc. 401(k) Plan's financial statements, performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section—

Basis for Opinion

1. Description of the Plan

The following description of the Flexton, Inc. 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that was established on January 1, 2016 by Flexton, Inc. (“the Company”) for the benefit of all eligible employees of the Company and any participating affiliates, if applicable. Certain classes of employees, as defined in the Plan agreement, may be excluded from participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”)

Plan Administration

The Plan Administrator manages the operation and administration of the Plan, including the appropriateness of the Plan’s investment offerings and investment performance. The Company has contracted with Reliance Trust Company to act as trustee and/or custodian.

Eligibility

Employees become eligible to participate once they have attained the age of twenty-one and completed 1 month of service. Employees may enroll in the Plan on the first day of the month following the completion of the eligibility requirements.

Employees excluded from the plan are as follows:

- Non resident aliens
- Residents of Puerto Rico

Contributions

Each year, participants may contribute an amount of eligible pre-tax annual compensation, as defined in the Plan agreement, not to exceed the maximum statutory amount established by the Internal Revenue Service (“IRS”). The Plan also allows for Roth 401(k) deferral contributions. Participants who are aged 50 or older before the end of the Plan year may elect to make catch-up contributions, not to exceed the maximum statutory amount. The annual elective deferral limit is \$23,000 for 2024 and the catch-up dollar limit for 2024 is \$7,500. Participants may also contribute amounts representing distributions from other qualified plans as permitted under the Plan agreement.

The Plan allows for an employer discretionary matching contribution subject to certain eligibility requirements as outlined in the Plan agreement. The Company’s discretionary matching contribution for the year ended December 31, 2024 was nil and for the year ended December 31, 2023 was \$ 91,142 of which \$ 7,784 was funded through the forfeiture account in 2024. The total employer match receivable as of December 31, 2024, was nil, and as of December 31, 2023, was \$91,142.

Rollovers

Employees may roll over eligible amounts from other eligible retirement plans or certain Individual Retirement Account (IRA) to the plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's discretionary matching contributions, Plan earnings and losses, and Plan expenses as applicable. Allocations of plan earnings and losses are based on individual participant investment choices. All contributions/investments are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their contributions and rollover amounts plus actual earnings thereon. Vesting in the Company's discretionary matching and earnings is based on years of credited service at rate of 20% after two years of service and an additional 20% each year thereafter and is 100% vested after six years of credited service. Participants become fully vested in all contributions in the event of death, disability, attainment of retirement age, or plan termination.

Payments of Benefits

Upon the satisfaction of certain distributable events, including retirement, death, disability, or termination of employment, participants or their beneficiaries may elect to receive their vested account balance. Distributions are made in accordance with the provisions of the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance, as defined by the Plan document. The notes are secured by the balance in the participant's account and bear interest at rates commensurate with prevailing market rates at the time the loan is originated, as determined by the Plan Administrator.

A participant may have up to three active notes outstanding at any one time, only one of which may be designated as a primary residence loan. The notes must be repaid within a five-year period; unless it is used for the purchase of a principal residence in which case the maximum repayment period may extend beyond five years.

Outstanding notes receivable from participants as of December 31, 2024 and 2023 carry interest rates ranging from 6.00% to 10.25% and from 5.25% to 10.25% respectively.

Principal and interest are repaid ratably through payroll deductions in accordance with the terms of the note and the provisions of the Plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Forfeited Accounts

Forfeited accounts may be used to pay Plan administrative expenses or to reduce future employer contributions, as provided under the terms of the Plan.

As of December 31, 2024 and 2023, the balance in forfeited nonvested accounts, if any, was applied in accordance with Plan provisions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Committee determines the Plan’s valuation policies utilizing information provided by Reliance Trust Company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as those held during the year.

Contributions:

Contributions from Plan participants and employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related loan processing fees are recorded as administrative expenses and are expensed when incurred.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

In 2024, certain administrative fees related to the operation of the Plan were paid by the Company, and these amounts are excluded from the Plan's financial statements. Investment and fund-related fees, participant transaction fees, investment advisory fees, and recordkeeping fees are paid through the Plan and charged to participant accounts, as applicable.

3. Risk and Uncertainties

The Plan invests in various investment securities that are exposed to risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the fair value of these securities could occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, interest, dividends, net appreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

5. Fair Value Measurements

The framework for measuring fair value establishes a fair value hierarchy that prioritizes the inputs used in valuation techniques to measure fair value. The hierarchy gives the

highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs other than quoted prices include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

Registered Investment Company/Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust Funds: The collective trust funds are primarily composed of fully benefit-responsive investment contracts and are valued at the net asset value (NAV) of the units, similar to a bank collective trust. The NAV is determined based on a compilation of primarily observable market information and is provided by the trustee. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not applied when it is determined that it is probable the fund will sell the investment for an amount different from the reported NAV. These funds have no unfunded commitments, and the units are redeemable on a daily basis by participants. Either party may terminate the contract in accordance with the terms of the agreement.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Income Tax Status

The Plan adopted a non-standardized pre-approved plan, which received an opinion letter dated October 6, 2020, from the Internal Revenue Service (IRS) stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and, therefore, the related trust is tax-exempt. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan remains qualified and the related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America (U.S. GAAP) require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that is more likely than not to be

sustained upon examination by the relevant taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits currently in progress for any tax periods.

7. Party-In-Interest and Related Party Transactions

The Plan's investments are held by Reliance Trust Company. Any purchases and sales of these investments are performed in the open market at fair value or contract value. Plan-related fees are paid to Reliance Trust Company and ADP Inc. The plan has other service providers. All these transactions while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA

8. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as liability with a corresponding reduction to contributions. The Plan is required to return the contributions to participants in the event certain non-discrimination tests defined under the IRC are not satisfied. As of December 31, 2024 and December 31, 2023 there is \$22,665 and nil respectively recorded as excess contributions payable.

9. Other Liability

Amounts payable for over contributions are recorded as a liability with a corresponding reduction to contributions. Other liability recorded as of December 31, 2024 was nil and December 31, 2023 was \$500.

10. Other Deductions

During 2024, the Plan utilized forfeitures totaling \$7,784 to fund employer matching contributions applicable to the plan year ended December 31, 2023. These forfeitures are included in "Other deductions".
