Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Reece Construction Company 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institutions").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Note 1 - DESCRIPTION OF PLAN

The following description of the Reece Construction Company 401(k) Plan (the "plan") provides only general information. Participants should refer to the plan document or Summary Plan Description for a more complete description of the plan's provisions, which are available from the plan administrator.

GENERAL

The plan is a defined contribution plan sponsored by Reece Construction Company, (the "company") for the benefit of its full-time employees who have three months of service, are age 18 or older, and are not a part of a collective bargaining agreement. Participants who perform services subject to the Davis-Bacon Act, The Service Contract Act, or any similar federal, state, or municipal prevailing wage statutes are immediately eligible to receive employer contributions. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

CONTRIBUTIONS

Each year, participants may contribute up to a certain percentage of annual compensation as pre-tax or Roth contributions not to exceed the annual dollar limitation defined by the Internal Revenue Code, as defined in the plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the plan, are allowed to make catch-up contributions as defined in the plan. Participants direct the investment of all contributions into various investment options offered by the plan.

The company makes employer matching contributions specified by any federal, state, county or publicly funded contract entered into, including prevailing wage contributions on behalf of participants who perform services subject to the Davis-Bacon Act, the Service Contract Act, or any similar federal, state, or municipal prevailing wage statutes. The company made prevailing wage contributions of \$116,247 and \$120,344 for the years ended December 31, 2024 and 2023, respectively. Effective October 2, 2024, the plan was amended to exclude certain employer contributions subject to the Davis-Bacon Act, The Service Contract Act, or any similar federal, state, or municipal prevailing wage statutes. Contributions specific to these statutes are subsequently the responsibility of the plan sponsor and will be allocated to other uses allowed under the applicable fringe benefit mandates accordingly.

The employer may make discretionary matching contributions during the plan year for eligible employees. Effective October 2, 2024, the company increased the discretionary matching contribution of 3% to 4% of the participants' eligible compensation. Prior to the change in discretionary matching the company made discretionary matching contributions of 3% during 2024 and 2023. The company made discretionary matching contributions of \$199,364 and \$153,070 for the years ended December 31, 2024 and 2023, respectively. Additionally, the plan was amended to include a safe harbor matching provision effective January 1, 2025.

Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

PARTICIPANT INVESTMENT ACCOUNT OPTIONS

The plan currently offers various mutual funds as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus

of the respective fund. Participants may change their investment options at any time. There are no nonparticipant directed investments.

Contributions may be held as cash balances prior to the execution of the investment according to the participant's direction.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the company's discretionary matching contributions and prevailing wage contributions, and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are immediately vested in their voluntary contributions and prevailing wage contributions plus actual earnings thereon. Employer discretionary and matching contributions are subject to the following vesting schedule:

PAYMENT OF BENEFITS

On termination of service due to death, disability, or retirement, a participant may elect to receive either a single lump-sum amount or a direct rollover distribution equal to the value of the participant's vested interest in his or her account. For termination of employment due to other reasons, a participant with a balance in excess of \$5,000 may elect whether to receive a lump-sum distribution or roll over the vested interest in his or her account into another qualified plan. Participants with a vested balance under \$5,000 must receive the distribution in a lump sum upon termination.

HARDSHIP WITHDRAWALS AND IN-SERVICE DISTRIBUTIONS

Participants are permitted to withdraw, in a single sum, the vested portion of their account balance under certain conditions. These conditions include unreimbursed medical expenses, funeral expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition, or to prevent eviction or foreclosure from the participant's principal residence.

Upon attaining age 59 ½, a participant employed by the company may elect certain in-service withdrawals from their vested account balance.

FORFEITED ACCOUNTS

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$7,515 and \$9,148, respectively. These accounts will be used to pay plan expenses and then to reduce future employer

contributions. For the years ended December 31, 2024 and 2023, forfeitures in the amount of \$19,699 and \$23,807, respectively, were used from forfeited nonvested accounts to pay plan expenses.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the plan are prepared on the accrual method of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's trustees determine the plan's valuation policies utilizing information provided by the investment custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold, as well as held during the year.

CONTRIBUTIONS

Contributions from plan participants and company matching contributions are recorded in the year which the contributions are withheld from compensation.

EXCESS CONTRIBUTIONS PAYABLE

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Code are recorded as a liability with a corresponding increase to corrective distributions. The plan distributed the excess contributions to the applicable participants prior to March 15 of the following year.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

The plan assets are held by the custodian of the plan. Certain other administrative expenses are paid by the plan and therefore qualify as party-in-interest transactions. The accompanying financial statements include \$36,830 and \$34,679 of administrative expenses for the years ended December 31, 2024 and 2023, respectively.

SUBSEQUENT EVENTS

The plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

Note 3 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A.) held the plan's investment assets and executed investment transactions from January 1, 2023 through November 11, 2024 and Matrix Trust Company held the plan's investment assets and executed investment transactions from November 12, 2024 to December 31, 2024. The custodians of the plan have certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Net appreciation (depreciation) in fair value of investments
- Interest and dividend income
- Investments, as reflected in Schedule H, Line 4(i) - Schedule of assets (Held at End of Year)

The plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Note 5 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are held in accounts managed by JPMorgan Invest Holdings LLC, the recordkeeper, and were held in accounts managed by John Hancock Life Insurance Company (U.S.A.) through November 11, 2024, and other related third-party plan administrators. Fees paid by the plan for the investment management services and third-party plan administration are included within administrative expenses. At December 31, 2024 and 2023, there was \$0 and \$2,541, respectively, due to highly compensated employees who made excess contributions to the plan. Transactions with these parties qualify as party-in-interest transactions.

Note 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7 - TAX STATUS

The Internal Revenue Service ("IRS") has determined that the prototype 401(k) plan is designed in accordance with the applicable sections of the IRC and informed the trustee of such in a letter dated June 30, 2020. The plan administrator has adopted the plan and believes that the plan and related trust are currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - OTHER MATTERS

During the plan year ended December 31 2023, plan administrators discovered certain plan participants were not remitting salary deferrals due to incorrect definitions of eligible compensation. As a result, a voluntary correction of employee and related employer matching contributions were required to be made. From the 2021 plan year through the date of discovery, the required sponsor-funded correction was made using the available correction program. During 2024, the company remitted \$32,300 in contributions and earnings to participant accounts under ERISA guidelines.

Note 9 - RISKS, UNCERTAINTIES AND CONCENTRATIONS

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as tariff impositions or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could

materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 approximately 58% of the plan's investments were invested in the JPMorgan Smart Retirement 2040 Fund, JPMorgan Smart Retirement 2045 Fund, and JPMorgan Smart Retirement 2050 Fund. At December 31, 2023, 37% of the plan's investments were invested in the T. Rowe Price Retirement 2045 Fund and T. Rowe Price Retirement 2060 Fund.
